The software is used by NIST for computation, visualization, and programming in support of NIST's mission. Waterloo Maple, Inc. (doing business as Maplesoft Inc.) will provide the software licenses, and maintenance and technical support for the existing Maplesoft software utilized by NIST. The estimated value of this requirement

While the Maplesoft software is commercially available, Waterloo Maple, Inc. is the manufacturer and sole distributor of the software within the North American continent.

A notice of intent to sole source to Waterloo Maple, Inc. was posted to the NIST solicitation website on 11/28/2018, with a response date of 12/5/2018.

7) <u>DETERMINATION BY THE CONTRACTING OFFICER THAT THE ANTICIPATED COST TO THE</u> GOVERNMENT WILL BE FAIR AND REASONABLE:

Price analysis will be performed and documented to ensure the price is fair and reasonable. Prices will be compared to historical pricing for the same services.

8) DESCRIPTION OF MARKET RESEARCH CONDUCTED

The market research provided by the program office included the incumbent (Waterloo Maple, Inc., contract # SB134118AE0001), and one (1) additional vendor. The contract specialist reviewed the potential suppliers on NASA SEWP and found one (1) foreign vendor available. Additionally, market research was conducted on GSA with no resources found that provided Maplesoft software. Additionally, the contract specialist contacted Waterloo Maple, Inc. to request a list of their authorized resellers/distributors of their software product and services. The sole source letter from Waterloo Maple, Inc. confirmed that they are the sole provider of their products and services in North America.
