# A Model of Joint Congestion Control and Routing Through Random Assignment of Paths

#### Abstract

We investigate the trade-off between utility and path diversity in a model of congestion control where there can be multiple routes between two locations in a network. The model contains a random route allocation scheme for each source $s$ where the degree of randomness and therefore path diversity is controlled by $h_{s}$, the entropy of the route distribution. After deriving the model from a network utility maximization problem we analyze it in detail for two sample topologies. We conclude that, starting from an allocation with maximum robustness and path diversity, one can always increase the utility by decreasing $h_{s}$. However it can only decrease until a critical value of the entropy is reached. The value depends on the topology and link capacities of the network and can be explicity computed for our examples.

## 1 INTRODUCTION

In recent years, network protocols have been interpreted as algorithms that solve a convex optimization problem. In this set-up overall congestion control is formulated as a network utility maximization problem (NUM) that is solved in a distributed fashion by the various network layers. The network topology and the capacity of its links introduces constraints on the optimal solution. Then algorithms solve the problem by computing and modifying the primal and dual variables based on efficient communication between users, link and router layers of the network. Since the work of Kelly et al [7] congestion control protocols have been seen as regulating user network transmission rates so that the objective function i.e., the aggregate utility, is maximized subject to capacity constraints ([8], [3]). The utility function incorporates efficient utilization and fair allocation of resources among users. Significantly, such functions have been identified for existing protocols such as TCP and BGP (Border Gateway Protocols) through a process of "reverse engineering", thus opening up opportunities for analysis and improvement of existing protocols as well as the development of new ones.

The paradigm just described has been extended to the problem of characterizing protocols that jointly control congestion and routing ([12],[3], [4], [5],[6]). Aside from the obvious improvement in the utilization of network resources that could be gained by such an approach, there are obvious benefits in this time of cybersecurity concerns about adequate network robustness against route disruptions. However implicit in such a protocol is a tradeoff between robustness through path diversity on the one hand and network performance or utility on the other. Single
path routing based on e.g. the OSPF (Open Shortest Path First) protocol can lead to route flapping instability and reduced utility. However splitting traffic equally across all paths regardless of cost would also imply reduced utility. The best tradeoff if it exists would have to navigate between these extremes. Thus the design of stable, implementable algorithms that achieve maximum aggregate utility remains a challenge.

Our purpose is to propose a generalized NUM optimization problem for joint congestion control and routing where we can examine the behavior of the time averaged utility as a function of entropy, a model parameter that can be interpreted as a measure of path diversity. This paper is not presenting an algorithm to be implemented on a real network but is rather, a theoretical study of issues that must be addressed by any algorithm that is based on the NUM problem we discuss. Our model contains a routing scheme based on random allocation where the degree of randomness is controlled. The randomness of any route or path allocation for a class of network users $s$, can be measured in terms of the entropy $h_{s}$ of the probability distribution defined by the allocation.

Treating $h_{s}$ as a parameter, we find that as we increase $h_{s}$ from 0 , the model equations fail to converge to an equilibrium until the entropy reaches a critical value (see Section 5.1 for TwoLinks and Section 6.1 for Diamond). Stable equilibria exist for values of $h_{s}$ greater or equal to the critical value and we show that the corresponding equilibrium pair ( $x_{s}^{*}, \beta_{s}^{*}$ ) are solutions of the optimization problem.

We also calculate the time averaged aggregate utility for a range of values $h_{s}$ for each topology (see Figure 8 , Figure 9 . These graphs show how the utility decreases as the entropy increases and they illustrate the fact that one can always increase the utility for a route allocation that has entropy greater than the critical value by changing the allocation so that the entropy decreases. This automatically decreases the mean route cost. A protocol based on the model we presented does not allow one to decrease the entropy below the critical value. We conjecture that the behavior of the model for entropy values less than the critical value corresponds to the unstable behavior seen in the single path TCP/IP protocols as discussed in reference [12].

We now turn to a description of the organization of the paper. The NUM optimization problem is presented in the next section and is followed by a description of the model and the notation used in Section 3. The model is an algorithm for solving the NUM optimization problem and is derived following the work of [8], [12] in Section 4. Then the model is specialized to the TwoLinks topology (see 29p) in Section 5, and there follows a detailed description of the model behavior in 5.1-5.3. Readers who want to skip the details and see the results and conclusions can go to the beginning of sections 5 and 6 . The model equations for the Diamond topology (equations $(38)-(\sqrt{42})$ ) can be found in Section 6. A summary of the model behavior for this topology can be found at the beginning while details can be found in the subsections 6.1-6.3. A discussion of how the aggregate utility varies as a function of the parameter $h_{s}$ for these two topologies can be found in Section 7. The conclusion can be found in Section 8. Finally the last section, Section 9 is an appendix, containing proofs of some results needed in the detailed subsections of 5 and 6 .

## 2 OPTIMIZATION PROBLEM

Consider a planar network to be a graph with nodes representing physical nodes in the network and edges representing links. The link capacities are defined by the vector $\mathbf{c}=\left(c_{1}, c_{2}, \cdots, c_{L}\right)$. A user who requires bandwidth to transmit from one node to another in the network (or a single TCP session between those two nodes) is indexed by $s$, the index of the source-destination pair. For each $s$, the utility function is a twice differentiable strictly concave function $U_{s}:\left[m_{s}, M_{s}\right] \rightarrow \mathbb{R}$. Here $m_{s}$ and $M_{s}$ are lower and upper bounds respectively on the bandwidth rate $x_{s}$. $U_{s}\left(x_{s}\right)$ measures the degree of user satisfaction, network fairness and efficiency for the part of the network defined by $s$. Users in a source-destination class $s$ are assigned a path by edge routers using a probability distribution with a minimum degree of randomization as specified by $h_{s}$. The distribution is constrained so that the traffic on any link does not exceed the link capacity.

The optimization problem that our protocol seeks to solve is:

$\mathbf{x}=\left\{x_{s}: s=1,2, \cdots S\right\}$ is the vector of source rates with each $x_{s} \in\left[m_{s}, M_{s}\right]$ where $m_{s} \geq 0$. In this paper we will take $m_{s}=0$ for all $s$ and $U_{s}\left(x_{s}\right)=w_{s}\left(1-\alpha_{s}\right) x_{s}^{1-\alpha_{s}}$ with $\alpha_{s}=2$. The form for $U$ is commonly used in the literature [3]. The elements $\beta=\left\{\beta_{s r}\right\}$ comprise a matrix whose rows are the route probability distributions for source $s$. The
constraints $\sqrt{2}$ require that all routes $r$ in $R_{s}(l)$, the set of routes of source $s$ that use link $l$, be assigned bandwidth rates $\beta_{s r} x_{s}$ so that the total link load does not exceed the capacity $c_{l}$. Finally if $R_{s}$ is the set of all paths joining the source-destination pair $s$, then (3) is the usual requirement for probability distributions and (4) places an lower bound on the degree of randomness for the distribution $\left\{\beta_{s r}\right\}$ for source $s$. Small values of $h_{s}$ indicate that the problem is closer to the single path case and as $h_{s}$ increases we are closer to the equiprobable case- a version of the multipath problem. Following the approach of [8] we developed an algorithm based on a gradient projection iteration method for the dual optimization problem. We will discuss the convergence of this algorithm and its stability as a function of $h_{s}$ for two sample topologies. As in [8] and [12], the dual variables are link costs changing in response to congestion. The route allocation distributions follow dynamics that minimize the average route cost.

In [9] where the idea of random route allocation was first proposed, the authors introduced an adaptive algorithm involving non-constant values of $h_{s}$. Through simulations they demonstrated the trade-off between stability and utility. They found that the maximum utility occurs near the boundary between stability and instability.

## 3 DESCRIPTION OF MODEL

To describe the results of this paper, the model equations are presented next. They are based on a gradient projection algorithm for solving the dual form of a NUM problem and they are derived in Section 4. The utility funcion $U_{s}:\left[m_{s}, M_{s}\right] \rightarrow \mathbb{R}$ where $0<m_{s}<M_{s}$, is a strictly concave, twice continuously differentiable function.

We will as usual represent a computer network as a planar graph with nodes representing locations in the network. In the literature, the total amount of bandwidth to send information from one part of the network to another is controlled by an agent called a source. There are several routes a source can take to its destination and we assume each route is defined by a set of uni-directional links indexed by $l=1, \cdots L$. These links are represented in the graph as weighted edges, where an edge weight is the link capacity. Sources are indexed by $s$, and traffic is assigned to route $r \in R(s)$ with probability $\beta_{r s}$ where $R(s)$ is the set of all routes used by source $s$. If $p_{l}^{(k)}$ is the link cost at time $k$ and $c_{l}$ is the capacity of the $l$ th link then the equations of the model are

where $d_{r}(k)=\sum_{l \in r} p_{l}^{(k)}$ is the cost of route $r$ at time $k, h$ is a step size, $[a]^{+}=a$ if $a>0$ and is 0 otherwise. $Z_{s}(k)=\sum_{r \in R(s)} \exp \left(-\gamma_{s}^{(k)} d_{r}(k)\right)$ is the normalization factor for the route distribution and, the variable $\gamma_{s}^{(k)}$ is the solution of the implicit equation,

The model equations are completed by a relation between the bandwidth rate $x_{s}(k)$ and $D_{s}(k)$, the mean route cost at time $k$ for positive constants $w$ and $M$.

Equations $\sqrt{6}$ and $\sqrt{7}$ force the route distribution $\beta_{s r}^{(k)}$ to be the unique distribution of entropy $h_{s}$ with the smallest mean route cost at each time step $k$. Recall that for any probability distribution $\beta_{\mathbf{s}}=\left\{\beta_{s r}\right\}_{r \in R(s)}$ the entropy of the distribution is

Thus the condition on the route distributions is $\mathrm{H}\left(\beta_{\mathbf{s}}\right)=h_{s}$. This constant entropy requirement will constrain the set of values $\left\{p_{l} \mid l=1 \cdots L\right\}$ for which a bounded $\gamma_{s}^{(k)}$ exists. The precise set depends on the network topology and capacity of the links. In this paper we present a detailed discussion of two very simple sample networks where these regions can be determined.

## 4 DERIVATION OF THE MODEL

The problem (1)-4 is not convex in $(x, \beta)$ but through an invertible change a variables $(x, \beta) \mapsto(x, y)$ it can be transformed to one. The new problem is:

This is a convex program because the functions in 10 -13 are clearly concave. If we assume the conditions

hold for each $l$, where the summation is over all source-destination pairs $s^{\prime}$ that use link $l$, and note that a $\beta=\left\{\beta_{s r}\right.$ : $\left.r \in R_{s}, s=1 \cdots S\right\}$ can always be found so that $y_{s r}=x_{s} * \beta_{s r}$ and

then there is a Slater point([11]) and the Slater constraint qualification is satisfied. We note here that $x_{s} \in\left[m_{s}, M_{s}\right]$ can be chosen independently of $\beta$. Thus 10 - 13 is superconsistent and Lagrange multipliers exist. The Lagrangian for the problem is:

where $\left\{p_{l}, l=1 \cdots N L\right\}$ are the Lagrange multipliers for 11 and $\lambda=\left[\lambda_{s}^{1}, \lambda_{s}^{2}: s=1, \cdots S\right]$ are Lagrange multipliers for constraints (13) and (12). To obtain solutions $x, y$ we consider the problem;

where maximization is first performed in $y$ with $x$ and $p$ held fixed. The problem $\max _{y} \mathfrak{L}(x, y, \lambda, p)$ is equivalent to the constrained problem

Problem 15 has a Slater point so it too is superconsistent. A solution $y^{*}$ to 15 exists if and only if there is a $\lambda^{*}$ that satisfies the Karush-Kuhn-Tucker conditions ([11] p.182,183). Reintroducing $\beta_{s r}=\frac{y_{s r}}{x_{s}}$ where $\beta_{s r}$ is independent of $x_{s}$, we obtain the following form of the optimal solution of for each fixed $x_{s}$ and $p$.

Recognizing that $\sqrt{15}$ is equivalent to the problem of minimizing $\sum_{r \in R_{s}} y_{s r} d_{r}=x_{s} D_{s}$ subject to the constraints, we see that the optimal solution can be obtained by setting $\gamma$ equal to the unique positive root of (17). Indeed there are in general two roots of this equation when $h_{s}<\log \left|R_{s}\right|$ and the positive root provides the smallest value of $D_{s}$. Given $\gamma>0$, call any $\beta_{s r}$ subject to (16) and (17), $\beta_{s r}^{*}$. Then we have $y_{s r}^{*}=x_{s} \beta_{s r}^{*}$. The $\left\{y_{s r}^{*}: r=1, \cdots R_{s}\right\}$ are unique since for each $s, 17$ has a unique positive solution. Set

where $y^{*}(x, p)$ and $\lambda^{*}(x, p)$ are the optimal solution and Lagrange multipliers of 155 for fixed $x$ and $p$. Using the KKT conditions $L$ can be written as,

$L$ is strictly concave on the product interval $X=\prod_{s}\left[m_{s}, M_{s}\right]$ and therefore $\max _{x} L(x, p)$ exists for a unique $x$. Moreover $L$ is convex in $p$. To see this note that

and is the supremum over all vectors $\beta ; \beta: \sum_{r \in R_{s}} \beta_{r}=1,-\sum_{r \in R_{s}} \beta_{r} \log \beta_{r} \geq h_{s}$. Thus $L(x, p)$ is the supremum of set of convex functions over an infinite (convex) set (p. 81 Boyd and Vandenberghe). Applying the same reasoning to $L$ we can conclude that $\mathcal{Q}(p)=\max _{x} L(x, p)=\max _{x} \max _{y} \mathfrak{L}(x, y, \lambda, p)$ is convex in $p$. The remainder of this derivation follows the work of [8] and [12]. First the dual problem for $p$ is formulated as:

If $\left\{\beta_{s r}^{*}\right\}_{s, r}$ is differentiable in $p$ and $\lambda$, then Danskin's theorem [1] applied to $\mathfrak{L}$ implies the differentiability of $\mathcal{Q}$. Indeed the unique maximizing $\bar{x}$ and $y=x \hat{\beta}^{*}$ are differentiable in $p$ and $\lambda$. At $\bar{x}$, either $\overline{x_{s}}(p)=M_{s}$ or $\left.U_{s}^{\prime}\left(\overline{x_{s}}\right)(p)\right)=\Lambda_{s}(p)$. If $\overline{x_{s}}(p)<M_{s}$, then a condition introduced in [8], $U^{\prime \prime}\left(x_{s}\right) \geq \delta_{s}>0$ for all $x_{s} \in\left(0, M_{s}\right]$, together with the differentiability of $\Lambda_{s}$ with respect to $p$ and $\lambda$, imply that $\bar{x}_{s}$ is differentiable(see Appendix) and thus $\mathfrak{L}\left(\bar{x}, y^{*}, \lambda, p\right)$ is differentiable. We conjecture that $\Lambda_{s}$ is differentiable at $p$ if $p$ lies in a convex subset of $\mathcal{R}^{L}$. The exact nature of the subset depends on the existence of a finite positive root of 17. We have determined the region for sample problems discussed in this paper. In general however we do not expect $\mathcal{Q}$ to be everywhere differentiable. These considerations lead to the following subgradient algorithm for solving 20 .

If $x_{s}(p)<M_{s}$, for all $s$, where $g$ is a subgradient of $\mathcal{Q}$. When it is differentiable $g^{k}=\nabla \mathcal{Q}\left(p^{k}\right)$. Our interest lies in understanding the dynamics of the latter equation when this condition is satisfied at least initially and the boundary of $X$ can only be approached from the interior thus for the rest of our discussion we assume that for each $k$ :

ASSUMPTION For all $s, \overline{x_{s}}\left(p^{k}\right)<M_{s}$.

Under this assumption, 21) can be written as

Equations (22) is supplemented by the relations coming from the optimality conditions.

where $\gamma_{s}^{k}$ is the solution of 17) using $\beta_{s r}^{k}$, and $Z\left(\gamma_{s}^{k}\right)$ is defined analogously to $Z(s)$. Equation 17) effectively insures that at each time step $k$ the route distribution $\left\{\beta_{s r}^{(k)}: r \in R_{s}\right\}$ has entropy $h_{s}$ for every $s$.

## 5 TWO LINKS TOPOLOGY

A network consisting of a single source-destination pair of nodes connected by two links is depicted in Figure 1 . In this section we describe the dynamics of equations (22) particular to this case as seen in equation (29). We find the values of the entropy $h_{s}$ where the iterations converge and these can be used to express the solution of the original optimization problem. As $h_{s}$ is varied it will be convenient from a conceptual as well as mathematical point of view to express the variation in entropy in terms of the route allocation distribution.

In Section 5.1, we discuss the existence of stable equilibria for 29 at an intrinsic (critical) entropy value with route probabilities,

where $c_{1}$ and $c_{2}$ are the link capacities and without loss of generality we assume $c_{1}>c_{2}$. The corresponding critical value of the entropy is therefore

Each initial point in a region $\mathcal{H}$ in the $p_{1}, p_{2}$ plane, converges along a straight line orbit to a point on the line of constant mean cost $\overline{x^{*}}$ (see the line $L_{1}$ Figure 22. Although there are infinitely many such points in the plane there is a unique equilibrium bandwidth rate $x s^{*}=\left(\frac{w}{x^{*}}\right)^{1 / 2}$. These equilibria are neutrally stable.

There is a corresponding equilibrium route allocation as well. In the latter part of our discussion here and Theorem 9.1 in the Appendix we show that there are just two probability distributions with a given entropy $h_{s}<\log 2$. It is shown that within the quadrant sector $\left\{\mathrm{p}=\left(p_{1}, p_{2},\right): p_{1}<p_{2}\right\}$, the route probabilities $\beta_{1}^{(k)}>\beta_{2}^{(k)}$ are constant and equal to the values in for $k \geq 1$. Thus the optimal route probabilities are reached in a single step although of course the solution of the implicit equation varies and depends on $\mathbf{p}$. The reverse inequality holds in the other quadrant sector. The particular choice of solution depends on the sector the intiial values of $\mathbf{p}$ are in. The proof that the equilibrium values $\left(x s^{*}, \beta^{*}\right)$ are solutions of the optimization problem for $h$ small enough is omitted here but follows along the same lines as the proof of Theorem 1 in reference [8] and page 214 of [1], because orbits of (29) remain in a single sector so the route probabilities are constants. Therefore the equations take the same form as those discussed in [8]. We note that it is also at this point that the lower bound on $U^{\prime \prime}$ is needed.

If $h_{s} \neq h_{T}(c)$, then the route probabilities in analogy with equation (25) are:

\begin{equation*}
\beta_{1}^{(h s)}=\frac{c_{1}+\mu c_{2}}{(1+\mu) c_{2}+c_{1}} \beta_{2}^{(h s)}=\frac{c_{2}}{(1+\mu) c_{2}+c_{1}} \tag{28}
\end{equation*}
$$

where $\mu \neq 0$. If $\mu=0$ then $h_{s}=h_{T}(c)$, while $\mu<0$ implies that $h_{s}>h_{T}(c)$. The dynamics of the iterations for these values are discussed in Section 5.2. There it is proved, that if initial points start in $\mathcal{H}$, iterates converge to a asymptotically stable equilibrium point on the $p_{2}$ axis. Figure 3 shows some of these orbits. This equilibrium corresponds to a solution of the optimization problem but here the utility, i.e. $U\left(x_{s}^{*}\right)$ is smaller than the value obtained at $h_{T}(c)$. The discussion of TwoLinks ends in Section 5.3 where we treat the case $\mu>0$. Here $h_{s}<h_{T}(c)$. The algorithm does not converge but instead orbits approach the line $p_{1}=p_{2}$ and the solution of the implicit equation becomes unbounded.

We now introduce the equations for the TwoLink topology and establish some preliminary facts needed for their analysis in the later subsections. We are interested in identifying sufficient conditions for the existence of equilibria for our algorithm in the region where the dual function $\mathcal{Q}$ is differentiable. In this topology note that a finite solution of 17 fails to exist if $h_{s}<\log 2$ but $p_{1}=p_{2}$. Therefore we will restrict our investigation of 22 to the set $\left\{p=\left\langle p_{1}, p_{2}\right\rangle: p_{1}<p_{2}\right\}$. We will denote by $x s$ the bandwidth rate with the single source in this network. In this setting equations 22 become:

p_{2}^{k+1}=\left[p_{2}^{k}-h\left\{c_{2}-\beta_{2}^{k} x s(k)\right\}\right]^{+}
\end{gather*}

Here $\beta_{1}^{(k)}$ is the probability of being assigned to route 1 at the $k$ th step and $\beta_{2}^{(k)}=1-\beta_{1}^{(k)}$. Now the entropy of a two point distribution is defined as

\mathrm{H}(\beta)=-(\beta \log (\beta)+(1-\beta) \log (1-\beta))
$$

The equation $\mathrm{H}(\beta)=h_{s}$, for some fixed $h_{s}<\log 2$, is satisfied by exactly two distributions $\hat{\beta}=\left\{\beta^{(h s)}, 1-\beta^{(h s)}\right\}$ or $\left\{1-\beta^{(h s)}, \beta^{(h s)}\right\}$. Since the left hand side of 17 can be interpreted as $\mathrm{H}\left(\hat{\beta^{k}}\right)$, where $\hat{\beta}^{(k)}=\left\{\beta_{1}^{(k)}, \beta_{2}^{(k)}\right\}$, this means there are only two possible values of $\beta_{1}^{(k)}\left(\beta_{2}^{(k)}\right.$ respectively). The optimality conditions require that the positive root be selected, so we conclude that $\beta_{1}^{(k)} \equiv \beta^{(h s)}$ where $\beta^{(h s)}>\left(1-\beta^{(h s)}\right)$ if $p_{1}^{(0)}<p_{2}^{(0)}$ and the reverse inequality when $p_{1}^{(0)}>p_{2}^{(0)}$ (see Theorem 9.1 in the Appendix).

In what follows the sets $W_{i}=\left\{p_{i} \mid p_{i}-h\left\{c_{i}-\beta_{i} x s\right\}>0\right\}$ will be mentioned frequently.

### 5.1 Route Distribution defined by Link Capacities

Given capacities $c_{1}>c_{2}$ where $c_{1}$ and $c_{2}$ are the capacities of link 1 and link 2 respectively suppose,

Here $\beta_{1}^{\left(h_{s}\right)}$ and $\beta_{2}^{\left(h_{s}\right)}$, the proportion of traffic allocated to links 1 and 2 respectively define a probability distribution with entropy $h_{s}=h_{T}(c)$ given by 27 . The entropy and thus the possible path allocation probabilities are determined by the capacities of the links and are therefore intrinsic to the network. The ratio in (30) is greater than 1 so we make the choice of assigning the smaller initial price to link 1, i.e. $p_{1}^{(0)}<p_{2}^{(0)}$. We also make the realistic assumption that $M>\frac{c_{1}}{\beta_{1}^{(h s)}}$. There exists a family of steady states (equilibrium values) $\left(x s^{*}, p_{1}^{*}, p_{2}^{*}, \beta_{1}^{\left(h_{s}\right)}, \beta_{2}^{\left(h_{s}\right)}\right)$. Here $x s^{*}=\frac{c_{2}}{\beta_{2}}$ is the unique equilibrium source rate, where $p_{i}^{*}$ are the link costs for $i=1,2$ such that $\beta_{1}^{(h s)} p_{1}^{*}+\beta_{2}^{(h s)} p_{2}^{*}=\overline{x^{*}}$, where $x s^{*}=\left(\frac{w}{x^{*}}\right)^{1 / 2}$. The equilibrium values of $p_{i}$ are not unique as we will see. To simplify notation in what follows we write $\beta_{i}^{(h s)}=\beta_{i} \quad i=1,2$.

The dynamics of 29 are most conveniently described by dividing the ( $p_{1}, p_{2}$ ) plane into 3 regions. Let $\mathcal{L}_{0}$ be the line perpendicular to the line $\mathcal{L}_{1}: \bar{x}=\overline{x^{*}}$ at the point $\left(0, \tilde{p_{2}}\right)$. It is clear that $\tilde{p_{2}}=\frac{x^{*}}{\beta_{2}}$. Similarly let $\mathcal{L}_{2}$ be the line perpendicular to $\mathcal{L}_{1}$ at the point of intersection of the lines $\mathcal{L}_{1}$ and $\left\{p: p_{1}=p_{2}\right\}$. We will begin with the region bounded above by $\mathcal{L}_{0}$, and below by $\mathcal{L}_{2}$ and on the left by the $p_{2}$ axis. Denoting this region by $\mathcal{R}$ we assume that initial value $p^{0}=\left(p_{1}^{(0)}, p_{2}^{(0)}\right)$ is in $\mathcal{H}=\mathcal{R} \cap W_{1} \cap W_{2} \cap\left\{p: p_{2}>p_{1}\right\}$. As long as $p_{2}^{(k)}>p_{1}^{(k)}, \beta_{i}^{(k)}=\beta_{i} i=1,2$ (see the discussion at the end of the introductory part Section 5). Equations 29 and 30 imply that $p_{2}^{(k)}-p_{1}^{(k)}$ increases so this inequality holds while $p_{i}^{(k)} \in W_{i}$. The orbit of $p$ proceeds in a direction parallel to $\mathcal{L}_{0}$, i.e. perpendicular to $\mathcal{L}_{1}$. To see this let, $\Delta p$ equal the vector $<h\left(\beta_{1} x s(k)-c_{1}\right), h\left(\beta_{2} x s(k)-c_{2}\right)>$. Then the dot product with $<-\beta_{2}, \beta_{1}>$ is $\Delta p .<-\beta_{2}, \beta_{1}>=0$. If $p_{1}$ leaves $W_{1},\left(p_{2}\right.$ cannot leave $W_{2}$ because $\left.p_{2}>\beta_{2} \bar{x}^{*}\right)$, then the orbit will move to the $p_{2}$ axis and $p_{2}^{(k)} \rightarrow \tilde{p_{2}}$ as $k \rightarrow \infty$. If $p_{1}$ remains in $W_{1}$ we will show that $p^{(k)}$ will exponentially converge to a point on the line $\mathcal{L}_{1}$. From 29 we derive the following equation for the evolution of $\bar{x}$ for $p_{i}^{(k)} \in W_{i} \quad i=1,2 k \geq 1$.

\begin{equation*}
\bar{x}^{k+1}=T\left(\bar{x}^{(k)}\right)=\bar{x}^{k}+h \beta_{2}^{(h s)}\left(1+\lambda^{2}\right)\left(x s(k) \beta_{2}^{(h s)}-c_{2}\right) \tag{31}
\end{equation*}
$$

First suppose that $x s(0)<x s^{*},\left(\bar{x}^{0}>\bar{x}^{*}\right)$. Equation 31 shows that $\bar{x}$ decreases as long as $x s^{(k)} \leq x s^{*}$ and is fixed when $x s^{(k)}=x s^{*}\left(\bar{x}^{(k)}=\bar{x}^{*}\right)$. Moreover, an application of the the Mean Value theorem shows the the map $T$ is a
uniform contraction in within the interval, $\left[\bar{x}^{*}, \bar{x}^{(k)}\right]$ and the approach to $\bar{x}^{*}$ is exponential. In fact we have,

\begin{equation*}
\bar{x}^{(k+1)}-\bar{x}^{*}=\left(\bar{x}^{(k)}-\bar{x}^{*}\right)-\frac{h \beta_{2}^{2}}{2 w}\left(\frac{w}{\xi}\right)^{3 / 2}\left(\bar{x}^{(k)}-\bar{x}^{*}\right) \tag{32}
\end{equation*}
$$

where $\xi \in\left[\bar{x}^{*}, \bar{x}^{(k)}\right]$. Thus $p^{(k)}$ converges to a point $\hat{p}$ on $\mathcal{L}_{1}$ that is the intersection of $\mathcal{L}_{1}$, with the line perpendicular to it and passing through through $p^{(0)}$. It is clear then, that the equilibrium values are not unique. However the equilibrium value of the bandwidth $x s^{*}$ and therefore the equilibrium mean cost $\bar{x}^{*}$ is unique. If $x s(0)>x s^{*}$, then $\bar{x}$ increases and eventually reaches an interval where $T$ is a contraction i.e. 32 holds with $\xi \in\left[\bar{x}^{(k)}\right.$, $\left.\bar{x}^{*}\right]$. Since $p^{(0)} \in W_{1} \cap W_{2}$ the orbit remains in this set because $p_{1}^{(k)}$ and $p_{2}^{(k)}$ are both increasing while $c_{2}-\beta_{2} * x s^{(k)}$ decreases with $k$. As in the previous case, $p^{(k)}$ exponentially approaches a point on $\mathcal{L}_{1}$. It is not hard to show by local stability analysis that the limiting point is neutrally stable along the $\mathcal{L}_{1}$ direction (with eigenvalue 1 ) and is stable along the $\mathcal{L}_{0}$ direction, with eigenvalue less than 1 in absolute value.

Let us now consider the cases where $p^{(0)} \in W_{1} \cap W_{2}$ is located outside of $\mathcal{H}$. If the initial point is above (and to the left of) $\mathcal{L}_{0}$, then the orbit of $p$ lies along a straight line perpendicular to $\mathcal{L}_{1}$ and approaches a point on the $p_{2}$ axis. At some time $k, p_{1}^{(k)} \notin W_{1}$, then $p_{1}^{(k+1)}=0$. Since $x s^{(m)} \leq x s^{*}$, for $m \geq k$, then $p_{1}^{(m)}=0$ for $m \geq k+1$ and the orbit is confined to the $p_{2}$ axis. $p_{2}^{(m)} \rightarrow \tilde{p}_{2}$ as $m \rightarrow \infty$. If $p^{(0)}$ is located to the right of the line $\mathcal{L}_{2}$ but still satisfies, $p_{2}^{(0)}>p_{1}^{(0)}$, then the orbit moves in a direction perpendicular to $\mathcal{L}_{1}$. As in previous cases however, it will reach the $p_{1}=p_{2}$ before it reaches $\mathcal{L}_{1}$ so that the orbit fails to converge to an equilibrium.

### 5.2 Route Distribution with Less Weight on the Larger Link (increased $h_{s}$ )

We now consider the choice of parameters

$$
\frac{c_{1}}{c_{2}}=\lambda, \frac{\beta_{1}^{h s}}{\beta_{2}^{h s}}=\lambda+\mu
$$

The parameter $\mu$ expresses the degree to which the route allocation distribution's entropy differs from what we can call an intrinsic entropy defined in (27). In this instance $\lambda$ is fixed by the intrinsic capacities of the links but the controller can vary traffic allocation by varying $\mu$. The first case we consider, $\mu<0$, decreases the portion of traffic assigned to link 1. As $\beta_{1}$ decreases while maintaining the inequality $\beta_{1}>\beta_{2}$, we have $h_{s}>h_{T}(c)$ and the entropy increases. It approaches the distribution that assigns $1 / 2$ to each i.e. $h_{s}=\log 2$. We assume that $p_{i}^{(0)} \in W_{i}, i=1,2$. If $p_{i}^{(k)} \in W_{i} 1 \leq k \leq K \quad i=1,2$, where $K$, is an arbitrary but fixed positive integer, the right hand sides of of the two equations in 29 can be used to show the following:
Lemma 5.1 If $p_{1}^{(0)}<p_{2}^{(0)}$ and $x s^{(0)} \in\left[\frac{c_{2}}{\beta_{2}^{h s}}, \frac{c_{1}}{\beta_{1}^{h s}}\right]$, then $p_{1}^{(k)}<p_{2}^{(k)}$ and $x s^{(k)} \in\left[\frac{c_{2}}{\beta_{2}^{h s s}}, \frac{c_{1}}{\beta_{1}^{h s}}\right]$ for $1 \leq k \leq K$.

Proof: We use mathematical induction on $0 \leq l \leq K-1$. The induction hypothesis is that $p_{1}^{(l)}<p_{2}^{(l)}$ and $x s^{(l)} \in\left[\frac{c_{2}}{\beta_{2}^{h s}}, \frac{c_{1}}{\beta_{1}^{h s}}\right]$ with $\beta_{i}^{(l)}=\beta_{i}^{(h s)}, i=1,2$. Equation 29 then implies that $p_{1}^{(l+1)}<p_{2}^{(l+1)}$. Using the argument in the appendix, we then see that $\beta_{i}^{(l+1)}=\beta_{i}^{(h s)}, i=1,2$. To show that $x s^{(l+1)} \in\left[\frac{c_{2}}{\beta_{2}^{h s}}, \frac{c_{1}}{\beta_{1}^{h s}}\right]$ we rewrite 29 , simplifying the notation for $\beta_{i}$ by dropping the $h s$ superscript. Note that the right hand sides of 29) can be rewritten as $\left[p_{1}^{(l)}-h\left\{c_{1}-\beta_{1}^{(l)} x s^{*}+\beta_{1}^{(l)}\left(x s^{*}-x s^{(l)}\right)\right\}\right]^{+}$and $\left[p_{2}^{(l)}-h\left\{c_{2}-\beta_{2}^{(l)} x s^{*}+\beta_{2}^{(l)}\left(x s^{*}-x s^{(l)}\right)\right\}\right]^{+}$respectively. Here $x s^{*}=\theta \frac{c_{2}}{\beta_{2}}$ where $\theta=\frac{1+\lambda(\lambda+\mu)}{1+(\lambda+\mu)^{2}}$. Therefore after some algebra the equations for $p^{(l+1)}$ are:

$$
\begin{align*}
p_{1}^{(l+1)} & =p_{1}^{(l)}+\frac{h \mu c_{2}}{\left.1+(\lambda+\mu)^{2}\right)}+h \beta_{1}^{(l)}\left(x s^{(l)}-x s^{*}\right)  \tag{33}\\
p_{2}^{(l+1)} & =p_{2}^{(l)}-\frac{h \mu(\lambda+\mu) c_{2}}{1+(\lambda+\mu)^{2}}+h \beta_{2}^{(l)}\left(x s^{(l)}-x s^{*}\right)
\end{align*}
$$

The fact that $\beta_{i}=\beta_{i}^{(l)}=\beta_{i}^{(l+1)} i=1,2$ is then used to derive an equation for the mean value $\bar{x}^{(l+1)}$,

$$
\begin{equation*}
\bar{x}^{(l+1)}=\left[\bar{x}^{(l)}+h\left(\beta_{1}^{2}+\beta_{2}^{2}\right)\left(x s^{(l)}-x s^{*}\right)\right] \tag{34}
\end{equation*}
$$

If $x s^{(l)} \geq x s^{*}$, then 34 shows that $\bar{x}^{(l+1)} \geq \bar{x}^{(l)}$ and thus $x s^{(l+1)} \leq x s^{(l)}$. It is clear then that $x s^{(l+1)} \leq \frac{c_{1}}{\beta_{1}}$. To see that $x s^{(l+1)} \geq \frac{c_{2}}{\beta_{2}}$ for $h$ small enough, suppose the contrary, $x s^{(l+1)}<\frac{c_{2}}{\beta_{2}}$. We would then have

$$
x s^{(l)}-x s^{(l+1)}>x s^{(l)}-\frac{c_{2}}{\beta_{2}} \geq x s^{*}-\frac{c_{2}}{\beta_{2}} .
$$

We compute the last difference as $x s^{*}-\frac{c_{2}}{\beta_{2}}=\frac{-\mu(\lambda+\mu)}{1+(\lambda+\mu)^{2}} \frac{c_{2}}{\beta_{2}}$. However the differentiability and in particular the continuity of $U^{\prime}$ shows that $x s^{(l+1)}-x s^{(l)}$ can be made much smaller than this (it is $O(h)$ ) for $h$ small enough). Indeed we have

$$
\left|x s^{(l+1)}-x s^{(l)}\right| \leq \mathrm{C} \max _{x_{1}^{*} \leq x \leq x_{2}^{*}}\left(\frac{w}{4 x^{3}}\right)^{1 / 2} h
$$

where $\overline{x_{i}^{*}}=\left(\frac{\beta_{i} w}{c_{i}}\right)^{1 / 2}$ for $i=1,2$ and $\mathrm{C}=\max _{i=1,2}\left|\frac{c_{i}}{\beta_{i}}-x s^{*}\right|$. Thus the contradiction. A similar argument can be made when $x s^{l}<x s^{*}$.

If $p_{1}^{(k)}$ remains in $W_{1}$ for a sufficiently long interval then $x s^{(k)}$ will be close enough to $x s^{*}$ so the $\left(x s^{(k)}-x s^{*}\right)$ terms in the equations of 33 can be neglected. Note also that in this situation $p_{2}^{(k)}$ is always in $W_{2}$. We then have $p_{1}^{(k)}$ decreasing until it leaves $W_{1}$ and thereafter $p_{1}^{(k)}=0$. Meanwhile $p_{2}^{(k)}$ increases as the orbit moves along the $p_{2}$ axis until $p_{2} \rightarrow p_{2}^{*}$, where $\beta_{2} p_{2}^{*}=\overline{x_{2}^{*}}$. This conclusion still holds true if $p_{1}^{(k)}$ leaves $W_{1}$ at some time we can assume to be $k=K+1$. Using the fact that $p_{i}^{(l)} \in W_{i} \quad 0 \leq l \leq K$ we can show that $x s^{(k)} \in\left[\frac{c_{2}}{\beta_{2}}, \frac{c_{1}}{\beta_{1}}\right]$. This means that the orbit lands on the $p_{2}$ axis on the next step $k=K+2$ and $p_{2}^{(k)}$ continues to increase and approach $p_{2}^{*}$.

### 5.3 Distribution with More Weight on the Larger Link (decreased $h_{s}$ )

We now discuss the case $\mu>0$, where $h_{s}<h_{T}(c)$. First note that for any $\mu$ the equation for $p_{1}^{(k)}$ can be rewritten as,

$$
\begin{equation*}
p_{1}^{(k+1)}=\left[p_{1}^{(k)}-h\left((\lambda+\mu) \beta_{2}\left\{x_{1}^{*}-x s(k)\right\}\right]^{+}, \quad x_{1}^{*}=\frac{\lambda}{\lambda+\mu} c_{2} / \beta_{2}\right. \tag{35}
\end{equation*}
$$

We have $x_{1}^{*}<x s^{*}<c_{2} / \beta_{2}$ since $x s^{*}=\theta \frac{c_{2}}{\beta_{2}}$ and $\theta<1$. As before, we first assume that $p_{i}^{(0)} \in W_{i}$. If $x s(0) \in\left[x_{1}^{*}, \frac{c_{2}}{\beta_{2}}\right]$ then $p_{1}^{(k)}$ increases and since $p_{2}^{(k)}>p_{1}^{(k)}$, it follows that $p_{i}^{(k)} \in W_{i} i=1,2$ for all $k \geq 0$ and $x s$ will approach $x s^{*}$. Rewriting 29 to reveal the behaviour of $p^{(k)}$ near $x s^{*}$, we have,

$$
\begin{align*}
& p_{1}^{(k+1)}=p_{1}^{(k)}+h\left\{\frac{\mu}{(\lambda+\mu)^{2}+1}+\beta_{1}\left(x s(k)-x s^{*}\right)\right\}  \tag{36}\\
& p_{2}^{(k+1)}=p_{2}^{(k)}-h\left\{\frac{\mu(\lambda+\mu) c_{2}}{(\lambda+\mu)^{2}+1}+\beta_{2}\left(x s(k)-x s^{*}\right)\right\} . \tag{37}
\end{align*}
$$

Therefore it follows that $p_{1}^{(k)}$ increases and $p_{2}^{(k)}$ decreases in this situation so that $p_{2}^{(k)}-p_{1}^{(k)} \rightarrow 0$ as $k \rightarrow \infty$. This means that $\gamma(k) \rightarrow \infty$, where $\gamma(k)$ is the solution of 17 at the $k t h$ step and the iterations fail to converge.

If $x s(0)<x_{1}^{*}$, then $p_{1}^{(k)}$ and $p_{2}^{(k)}$ decrease. The dot product $\Delta p \cdot\left\langle-\beta_{2}, \beta_{1}\right\rangle=-h \mu \beta_{2} c_{2}$ shows that when $p_{i}^{(0)} \in W_{i}$ then $p_{i}^{(k)} \in W_{i}$ because in this region, the increment $\Delta p$ is pointing away from the $p_{2}\left(p_{1}=0\right)$ axis. At $x s(k)=x_{1}^{*}$, $p_{1}^{(k)}$ remains fixed but $p_{2}^{(k)}$ decreases, i.e. $\Delta p$ is pointing downward. $x s(k)$ increases until it enters the interval $\left[x_{1}^{*}, \frac{c_{2}}{\beta_{2}}\right]$, and approaches $x s^{*}$. Therefore $p_{2}$ decreases and $p_{1}$ increases. Consequently $p_{2}^{(k)}-p_{1}^{(k)} \rightarrow 0$ as in the previous case. If $x s^{(0)}>\frac{c_{2}}{\beta_{2}}$ then $p_{2}$ and $p_{1}$ both increase. Thus, $\bar{x}^{(k)}$ increases and $x s(k)$ decreases and eventually enters the interval $\left[\bar{x}_{1}^{*}, \frac{c_{2}}{\beta_{2}}\right]$. Suppose therefore that this is the case. If for some $k, p_{1}^{(k)}=0$ then , since $p_{2}^{(k)}$ decreases and $p_{1}^{(k)}$ increases, either $p_{2}^{(k)} \rightarrow p_{2}^{*}$ while $p_{1}^{(m)}$ remains 0 for $m \geq k$ or $p_{1}^{(m)}$ becomes positive and is therefore in $W_{1}$. In the latter case we can use the previous arguments for the case $p_{i}^{(k)} \in W_{i}$ that show that $p_{2}^{(k)}-p_{1}^{(k)} \rightarrow 0$.

Our final case for the parameter choice $\mu>0$ is to suppose that $x s(0)>\frac{c_{2}}{\beta_{2}}$. Clearly $x s$ will decrease until it enters the interval $\left[x_{1}^{*}, \frac{c_{2}}{\beta_{2}}\right]$. Previous arguments can then be used to determine the fate of $p_{i}^{(k)}, i=1,2$. We in fact see the divergence of $\gamma^{(k)}$ in our numerical computations. The cases discussed in this section correspond to the selection of a distribution that allocates a larger fraction of traffic to link 1 than the allocation defined by (30) and the corresponding critical entropy in equation(27). Thus $h_{T}(c)$ defines the outer limit of how far one can decrease entropy in order to increase utility.

## 6 DIAMOND TOPOLOGY

We turn our discussion now to another simple topology (see Figure 5) with 5 links attached to a single source destination pair. As seen in the figure there are 3 routes, using the links indicated in the figure.

Inspection of the figure leads to the system:

where, as in Section 5, the bandwidth rate $x s(k)=\min \left(\left(\frac{w}{\mathbb{E}\left[d^{(k)}\right]}\right)^{\frac{1}{2}}, M\right)$, with $\mathbb{E}\left[d^{(k)}\right]=\sum_{r=1,2,3} \beta_{r}^{k} d_{r}^{(k)}=$ $\sum_{r=1,2,3} \beta_{r}^{(k)}\left(\sum_{l^{\prime} \in r} p_{l^{\prime}}^{k}\right)$. The route probabilities are updated according to the following equations:

where $Z(k)=\sum_{i=1}^{3} \exp \left(-\gamma^{(k)} d_{i}^{(k)}\right)$ and

As was the case with the twolinks topology, we will examine the dynamics for a special choice of capacities. Here, led by the search for strictly interior equilibria of $\sqrt{38)}-(42)$, we take

The Subsections 6.1-6.3 contain discussions of the dynamics 38 - 42 for values of the route distribution entropy $h_{s}$ in relation to the critical entropy for this topology,

\end{equation*}

Equation (47) expresses the corresponding route distribution. In Section 6.1, (see Figure 6), we prove the existence of a set of equilibria in $\left(d_{1}, d_{2}, d_{3}\right)$ space that correspond to solutions of the optimization problem. Propositions 6.2 and 6.3 show that these values lie on the line $\overline{x^{*}}=\sum_{i=1}^{3} \beta_{i} d_{i}^{*}$, with $\beta_{i}$, the optimal route distribution given by (47). The equilibrium bandwidth rate is unique and can be expressed in terms of the equilibrium route costs by $x s^{*}=\frac{w}{x^{*}} 1 / 2$. These solutions are neutrally stable and do not persist when $h_{s}$ is perturbed. New unique and stable equilibria for (38)-42) arise when $h_{s}$ is increased. Note however that the value of the aggregate utility will be less than the value achieved at $h_{D}(c)$. In sections 6.2 we study the dynamics of the iterations when $h_{s}>h_{D}(c)$. Changes in $h_{s}$ are reflected in changes in the route allocation distribution as seen in equation (53), where $\nu<1$. In Section $6.3, h_{s}<h_{D}(c)$ and $\nu>1$. It is shown there that the iterations fail to converge and in fact the line $d_{1}=d_{3}$ is approached.

The proofs that the equilibrium values of subsections 6.1 and 6.2 are solutions of the original optimization problem again rely on the proof of Theorem 1 in reference [ 8 . The arguments below show that the route allocation distributions $\left(\beta_{1}^{(k)}, \beta_{2}^{(k)}, \beta_{3}^{(k)}\right)$, are constant for $k \geq 1$ when $h_{s} \geq h_{D}(c)$. Thus the proofs of our statements closely follow those in [8] and [1] therefore they are omitted.

We now choose initial conditions for $p_{i}^{(0)}, i=1 \cdots, 5$, that greatly simplify the dynamics as seen in the following result.

Lemma 6.1 Suppose the capacities in (38)-(42) satisfy 45). Further suppose the initial conditions

hold, with $p_{i}^{(0)} \in W_{i}, i=1, \ldots 5$. Then

and $\beta_{1}^{(k)}=\beta_{2}^{(k)}$ for $k \geq 1$.
Proof of Lemma: The proof is by induction. Suppose the conclusions of the lemma hold for some $k$. We then have $d_{1}^{(k)}=d_{2}^{(k)}$ by 44. Now at stage $k, \gamma^{(k)}$ must satisfy the implicit equation 17 with $d_{r}=d_{r}^{(k)} r=1,2$, 3. Since $\beta_{1}$ and $\beta_{2}$ satisfy 43), we must have $\beta_{1}^{(k+1)}=\beta_{2}^{(k+1)}$. The other conclusions follow from the right hand sides of (38)-42).

Remark: If $p_{i}^{(k)} \in W_{i}$ for $i=2,3,5$, then $p_{1}^{(k+1)}=p_{3}^{(k+1)}+p_{5}^{(k+1)}$ and $p_{4}^{(k+1)}=p_{2}^{(k+1)}+p_{5}^{(k+1)}$. When $p_{i}^{(k)} \notin W_{i}$ for some $i=2,3,5$ we cannot claim these equations are valid. Nevertheless it is always true that $p_{1}^{(k+1)}=p_{4}^{(k+1)}$.

As a corollary of Lemma 6.1 we can show that $\beta_{i}^{(k)} i=1,2,3$ is constant in $k$ and therefore the dynamics of $(38)-42$ are greatly simplified. To see this let us call the simplex of probability distributions on the three routes $S=\left\{\hat{\beta}=\left(\beta_{1}, \beta_{2}, \beta_{3}\right) \mid \quad \beta_{i} \geq 0 i=1,2,3, \beta_{1}+\beta_{2}+\beta_{3}=1\right\}$. For a fixed $h_{s} \geq \log (2)$, the subset defined by $C=\left\{\hat{\beta}=\left(\beta_{1}, \beta_{2}, \beta_{3}\right) \in \mathrm{S} \mid \mathrm{H}(\hat{\beta}) \geq h_{s}\right\}$ is a closed convex region enclosed by a smooth simple closed curve as boundary. It is the constraint region of the optimization problem (3)- (4). Its boundary is the level curve $\ell=$ $\left\{\hat{\beta} \in \mathrm{S} \mid \mathrm{H}(\hat{\beta})=h_{s}\right\}$. When $h_{s}<\log (2)$, the level curve breaks up into 3 pieces at the points where some $\beta_{i}=0$ (see Figure 10 ). When $0<h_{s}<\log 3$ there are precisely two points in $C$ with distribution $h_{s}$ that satisfy $\beta_{1}=\beta_{2}$. Each point corresponds to one of the conditions $\beta_{1}>\beta_{3}$ or $\beta_{1}<\beta_{3}$. It is not hard to show that in the region where $d_{3}^{(k)} \geq d_{1}^{(k)}=d_{2}^{(k)}$, we have $\beta_{1}^{(k)}=\beta_{2}^{(k)} \geq \beta_{3}^{(k)}$ so that over any time interval where this inequality is satisfied, $\beta_{j}^{(k)} j=1,2,3$ is constant. When $h_{s}<\log 2, \beta_{1}=\beta_{2}>\beta_{3}$ occurs when $\beta_{3}=0$. Therefore the corresponding value of $h_{s}$ must therefore be $\log 2$ which is infeasible.

Corollary 1 Assume the hypotheses of Lemma 6.1 hold and let $h_{s}$ be given with $h_{s}>\log (2)$. Further suppose that $d_{3}^{(l)}>d^{(1)}$ for $1 \leq l \leq k$. Then $\hat{\beta}^{(l)}=\hat{\beta}^{(h s)}$ where $\hat{\beta}^{(h s)}$ is the distribution with entropy $h_{s}$ satisfying $\beta_{1}^{\left(h_{s}\right)}=\beta_{2}^{\left(h_{s}\right)} \geq$ $\beta_{3}^{\left(h_{s}\right)}$. The latter inequality is strict when $h_{s}<\log (3)$.

Remark: The dual function $\mathcal{Q}$ in 20 is differentiable in the region $\left\{\mathbf{p} \mid d_{3}>d_{1}\right\}$.

### 6.1 Diamond Route Distribution Using Link Capacities

We assume a value of $h_{s}$ for which

\end{equation*}

As was true with the twolinks topology, the values of $x s$ for which $\Delta p_{i}^{(k)}=0$ when $p_{i}^{(k)} \in W_{i} i=1 \cdots 5$, will play an important role in defining the dynamical behaviour of the link and route costs. Here $W_{i}=\left\{p_{i} \geq 0 \mid p_{i}-h \Delta p_{i}>0\right\}$ where $\Delta_{i}$ is the part of the expression on the right hand side of 38 - 42 inside the curly brackets. Since the entropy in 47) is expressed in terms of link capacities that satisfy it is not hard to show that $x s_{i}^{(*)}=x s^{(*)}=c_{2}+c_{3}+c_{5}$ where $x s^{(*)}$ as in Section 5.1, is the equilibrium bandwidth rate. Equations for the route costs can be obtained from (38)-42 when $p_{i}^{(k)} \in W_{i}$.

$$
\begin{align*}
d_{1}^{(k+1)} & =d_{1}^{(k)}-h\left[C_{1}-x s(k) b_{1}\right]  \tag{48}\\
d_{3}^{(k+1)} & =d_{3}^{(k)}-h\left[C_{3}-x s(k) b_{3}\right] \tag{49}

where $C_{1}=c_{1}+c_{3}, b_{1}=\beta_{1}+\beta_{2}+\beta_{3}=1$, while $C_{3}=c_{1}+c_{4}+c_{5}$, and $b_{3}=\beta_{1}+\beta_{2}+3 \beta_{3}$ with $\beta_{i}=\beta_{i}^{\left(h_{s}\right)}$. Recall that Lemma 6.1 implies that $d_{1}^{(k)}=d_{2}^{(k)}$ so the equation for $d_{2}$ is unecessary. We assume that initial values of $p_{i}$ begin in $W_{i}$. When 48 - 49 are valid it can be seen that for $\Delta d_{i}^{(k)}=d_{i}^{(k+1)}-d_{i}^{(k)} i=1,2,3$, the dot product $<b_{3},-b_{1}>\cdot<\Delta d_{1}^{(k)}, \Delta d_{3}^{(k)}>$ is,

where in the present case $\nu=1$ (see equation 47) and 53). Let $\bar{x}^{*}$ be the mean route cost corresponding to $x s^{*}=\left(\frac{w}{\bar{x}^{(*)}}\right)^{1 / 2}$ and let $l_{d}$ be the line in the $d_{1}, d_{3}$ plane given by $l_{d}: \beta_{1} d_{1}+\beta_{2} d_{2}+\beta_{3} d_{3}=\bar{x}^{*}$ (see Figure 6 It intersects the $d_{3}$ axis at the point $\left(0, \frac{\bar{x}^{*}}{\beta_{3}}\right)$. Let $l_{0}$ be the line through this point, parallel to the vector $<-b_{3}, b_{1}>$ and given by the equation,

Finally, if $\mathcal{P}$ is the intersection of $l_{d}$ with the line $d_{1}=d_{3}$, let $l_{1}$ be the line passing through $\mathcal{P}$ and parallel to $l_{0}$. We call $\mathcal{A}$ the region in the $d_{1}, d_{3}$ plane bounded above by $l_{0}$ and below by $l_{1}$. Propositions 6.2 describes the dynamics of 48, 49 when $p_{i}^{(k)} \in W_{i} i=1 \cdots 5$ for all $k \geq 1$ and Proposition 6.3, discusses equations (38)-42) when at some time $k$ and for some $i, p_{i}^{(k)} \notin W_{i}$.

Proposition 6.2 Assume $\nu=1$ and suppose $\mathbf{p}^{(0)}$ is chosen so that $\left(d_{1}^{(0)}, d_{3}^{(0)}\right)$ lies in $\mathcal{A} \cap\left\{\left(d_{1}, d_{3}\right) \mid d_{3} \geq d_{1}\right\}$. Further suppose that $p_{i}^{(k)} \in W_{i}$ for all $k \geq 0$ and the hypotheses of Lemma 6.1 are satisfied. Then the orbit $\mathbf{d}^{(k)}=\left(d_{1}^{(k)}, d_{3}^{(k)}\right)$ moves along a straight line through $\mathbf{d}^{(0)}$ parallel to $l_{0}$, and converges to a point $\mathbf{d}^{*}=\left(d_{1}^{*}, d_{3}^{*}\right)$ on $l_{d}$. We have $\beta_{1} d_{1}^{*}+\beta_{2} d_{2}^{*}+\beta_{3} d_{3}^{*}=\bar{x}^{*}$ with $d_{i}^{*}>0$.

Proof: Since $p_{i}^{(k)} \in W_{i}, k \geq 0$, we can compute the dot product $<-b_{3}, b_{1}>\cdot<\Delta d_{1}^{(k)}, \Delta d_{3}^{(k)}>=0$ for all $k$, by equation 50 where $\Delta d_{i}^{(k)}=d_{i}^{(k+1)}-d_{i}^{(k+1)} i=1,2,3$. Therefore iterates proceed in a direction parallel to $<b_{1}, b_{3}>$ , i.e. parallel to the line $l_{0}$. Since $p_{i}^{(k)} \in W_{i}$, we can write down the following equation for $\bar{x}^{(k+1)}$, the mean route cost at time $k+1$,

where $x s^{*}=c_{2}+c_{3}+c_{5}$ and $x s(k)=\left(\frac{w}{\bar{x}(k)}\right)^{\frac{1}{2}}$. As in Section 5.1 we can see that $T$ is a uniform contraction when $\mathbf{d}^{(k)} \in \mathcal{A}$ so that $\bar{x}^{(k)} \rightarrow \bar{x}^{*}$, where $x s^{*}=\left(\frac{w}{\bar{x}^{*}}\right)^{\frac{1}{2}}$. When $\mathbf{d}^{(k)}$ is above the line $l_{d}, d_{1}^{(k)}$ and $d_{3}^{(k)}$ decrease and approach the line from above. Conversely when $\mathbf{d}^{(k)}$ is below the line, the $d_{1}^{(k)}$, and $d_{2}^{(k)}$ both increase so the approach is from below.

Remarks: Note that $d_{1}^{(k)}<d_{3}^{(k)}$ for all $k \geq 1$ in this situation so we can legitimately treat the $\beta_{j}^{(k)} j=1,2,3$ as constant.
If ( $d_{1}^{(0)}, d_{3}^{(0)}$ ) is below the line $l_{1}$, the orbit will reach the line $d_{1}=d_{3}$ before it reaches $l_{d}$ and hence $\gamma(k)$ will diverge to $\infty$.

The fate of orbits beginning at points in the region $\mathcal{A} \cap\left\{\left(d_{1}, d_{3}\right) \mid d_{3} \geq d_{1}\right\}$ where for some $k p_{i}^{(k)} \notin W_{i}$, is the same as that of orbits that begin above the line $l_{0}$ because in both cases, the orbits approach the $d_{3}$ axis. The next proposition discusses the latter situation. Here some of the link prices will converge to zero, an indication the traffic on those links have reached their capacity.

Proposition 6.3 If $\mathbf{p}^{(0)}$ is chosen as in the previous proposition but $\left(d_{1}^{(0)}, d_{3}^{(0)}\right)$ is above the line $l_{0}$, then $\mathbf{d}^{(k)}$ approaches the $d_{3}$ axis. Moreover:

1. if for some $k, p_{1}^{(k)} \notin W_{1}$, and $p_{3}^{(l)} \in W_{3} l \geq 0$, then $\mathbf{p}^{(k)}$ converges to $\mathbf{p}^{*}=\left(0, p_{2}^{*}, p_{2}^{*}, 0, p_{5}^{*}\right)$, with $\beta_{1} p_{2}^{*}+\beta_{2} p_{2}^{*}+$ $\beta_{3} p_{5}^{*}=\bar{x}^{*}$.
2. if for some $k p_{3}^{(k)} \notin W_{3}$, and $p_{1}^{(l)} \in W_{1}, l \geq 0$, then $\mathbf{p}^{(k)}$ converges to $\mathbf{p}^{*}=\left(p_{1}^{*}, 0,0, p_{1}^{*}, p_{5}^{*}\right)$ where $\beta_{1} p_{1}^{*}+$ $\beta_{2} p_{1}^{*}+\beta_{3}\left(2 p_{1}^{*}+p_{5}^{*}\right)=\bar{x}^{*}$.
3. if for some $k p_{i}^{(k)} \notin W_{i} i=1,3$, then $\mathbf{p}^{(k)}$ converges to $\mathbf{p}^{*}=\left(0,0,0,0, p_{5}^{*}\right)$ where $\beta_{3} p_{5}^{*}=\bar{x}^{*}$.

Proof: The proof that the orbit $\mathbf{d}^{(k)}, \quad k \geq 0$ proceeds along a straight line parallel to $l_{0}$ is also valid for this case. Therefore the orbit must approach the $d_{3}$ axis. We can also assume that $h$ is small enough so that any point above the line $l_{0}$ has a $d_{3}$ value large enough so that either $p_{1} \in W_{1}$ or $p_{3} \in W_{3}$ or $p_{5}^{(k)} \in W_{5}$. Since $d_{1}^{(k)}=p_{1}^{(k)}+p_{3}^{(k)}$, there is some $k$, where either $p_{1}^{(k-1)} \notin W_{1}$ and/or $p_{3}^{(k-1)} \notin W_{3}$.
(i) If $p_{1}^{(k-1)} \notin W_{1}$ we must have $p_{1}^{(k)}=p_{4}^{(k)}=0$. From 38)-42, one can therefore see that $p_{1}^{(l)}=0 l \geq k$ as long as $x s(l) \leq x s^{*}, \quad l \geq k$. During this time we can restrict our attention to the equations for $p_{2}\left(=p_{3}\right)$ and $p_{5}$. Here we assume that $p_{2}^{(k)} \in W_{2}$. The mean route cost at time $k, \bar{x}^{(k)}=\beta_{1} p_{2}^{(k)}+\beta_{2} p_{2}^{(k)}+\beta_{3} p_{5}^{(k)}$, continues to decrease and converges to $\bar{x}^{*}$. We have $\bar{x}^{(l)} \geq \bar{x}^{*}$ so $x s(l) \leq x s^{*}$ for all $l \geq k$. Meanwhile, $p_{2}^{(k)}, p_{5}^{(k)}$ converge to values $p_{2}^{*}, p_{5}^{*}$ for which $\bar{x}=\bar{x}^{*}$ while $p_{1}^{*}=p_{4}^{*}=0$. Note that $p_{2}^{(l+1)}-p_{5}^{(l+1)}=p_{2}^{(l)}-p_{5}^{(l)}+h\left(\beta_{3}^{\left(h_{s}\right)}-\beta_{2}^{\left(h_{s}\right)}\right)\left(x s^{*}-x s(k)\right)$. Therefore if $p_{5}^{(k)}>p_{2}^{(k)}$, the inequality remains true for $l \geq k$ and $d_{3}^{(l)} \geq d_{1}^{(l)}$.
(ii) If $p_{3}^{(k-1)} \notin W_{3}$, we will also assume in analogy with (i) that $p_{1}^{(k)} \in W_{1}$. Since $p_{2}^{(k)}=p_{3}^{(k)}=0$, and $p_{1}^{(k)}=p_{4}^{(k)}$, a system for $p_{1}$ and $p_{5}$ remains. Arguing as before it can be seen that since $\bar{x}^{(l)} \geq \bar{x}^{*}$, for $l \geq k$, then $p_{1}^{(l)}=0 \quad l \geq k$. The mean route cost at time $k, \bar{x}^{(k)}=\left(1+\beta_{3}\right) p_{1}^{(k)}+\left(\beta_{2}+\beta_{3}\right) p_{5}^{(k)}$, decreases and $p_{1}^{(k)}, p_{5}^{(k)}$ converge to $p_{1}^{*}, p_{5}^{*}$ where $\bar{x}^{*}=\left(1+\beta_{3}\right) p_{1}^{*}+\left(\beta_{2}+\beta_{3}\right) p_{5}^{*}$. The remaining limiting $p_{i}$ values are $p_{2}^{*}=p_{3}^{*}=0$. In this case we also have $d_{3}^{(l)} \geq d_{1}^{(l)}$, for $l \geq k$.
(iii) If both $p_{3}^{(k-1)} \notin W_{3}$ and $p_{1}^{(k-1)} \notin W_{1}$ hold, then we can repeat the reasoning in (i) and (ii) and conclude that the system reduces to the evolution of just $p_{5}$. In this case $p_{5}^{(k)}$ converges to $p_{5}^{*}$ where $\beta_{3} p_{5}^{*}=\bar{x}^{*}$. The remaining limiting values are $p_{i}^{*}=0 i=1 \cdots 4$. As in the previous cases, $d_{3}^{(l)}>d_{1}^{(l)}$ for $l \geq k$.

Proposition 6.2 shows that there are infintely many equilibrium points with $\mathbf{d}^{*}>0$ for the system (38)-42) with each point depending on the initial condition $\mathbf{d}^{0}$. However the equilibrium value $x s^{*}$ is unique. In the $\mathbf{d}$-plane, linearization about any such point shows that each has a neutrally stable direction (eigenvalue 1) along the direction of $l_{d}$, and an asymptotically stable direction parallel to $l_{0}$ and so these points are neutrally stable. Thus it is not surprising that they do not persist when a parameter, in particular the entropy $h_{s}$, is changed. The equilibrium points in the p plane discussed in Proposition 5.3 are more difficult to analyze because the right hand side of the system fails to be differentiable when any $p_{i} \notin W_{i}$. Nevertheless linearization of the reduced system discussed in (i) and (ii) in the proof of Proposition 6.3 shows the equilibrium points there are neutrally stable and the equilibrium point in (iii) is asymptotically stable. A complete proof would have to show that the stability demonstrated in the reduced system is also valid in the entire p plane. The fact that, in each of these cases, the plane for the reduced system is invariant under $(38)-(42)$ leads us to conjecture that this extension can be made.

In the next section we will discuss the effect of perturbing the route allocation away from the distribution defined by the critical entropy. Under such a perturbation the neutrally stable points will disappear but the asymptotically stable point in Proposition 6.3 (iii) with a single positive price for link 5 will persist.

### 6.2 Diamond Route Distribution with increased $h_{s}$

In our discussion of the behavior of $(38)-42$ for perturbed entropy values, it is useful to introduce a parameter $\nu$ that decreases (increases) the weight on links 2 and 3 as the perturbed entropy increases (decreases). Since we will continue the assumptions on the capacity values displayed in equation $45, \beta_{1}^{(h s)}=\beta_{2}^{(h s)}$ will still hold. Therefore, it is assumed that the entropy is the value $h_{s}$ for which the route allocation distribution is,

\begin{equation*}
\hat{\beta}^{(h s)}=\left\langle\frac{\nu c_{3}}{c_{2}+c_{3}+c_{5}}, \frac{\nu c_{2}}{c_{2}+c_{3}+c_{5}}, \frac{c_{5}+(1-\nu)\left(c_{2}+c_{3}\right)}{c_{2}+c_{3}+c_{5}}\right\rangle, \tag{53}
\end{equation*}
$$

where $\nu<1$. The entropy of the distribution with $\beta_{1}^{(h s)}=\beta_{2}^{(h s)}=\beta$, is $H=2 \beta \log (2)+h_{\beta}$ where $h_{\beta}=-2 \beta \log (2 \beta)-$ $(1-2 \beta) \log (1-2 \beta)$. It is not hard to show that if $\beta>1 / 4$, decreasing $\beta$ increases $H$ and vice versa. Since we confine our analysis to the region $d_{1} \geq d_{3}$ (see the discussion at the beginning of Section 6), we must consider a distribution where $\beta_{1}=\beta_{2} \geq \beta_{3}$. This implies that $\beta \geq 1 / 3$.

The case $\nu<1$ corresponds to an entropy value $h_{s}$ larger than the critical entropy where $\nu=1$. Here in contrast to Section 6.1, the values of $x s$ for which $\Delta p_{i}^{(k)}=0$ in $38-42$ are not all equal and so any orbit for which $p_{i}^{(k)} \in W_{i}, k \geq 0$ as in Proposition 6.2 will not become a stationary point once $\mathbf{d}^{(k)}$ reaches the line $l_{d}$. The equilibrium value $\bar{x}^{*}$ satisfies:

x s^{*}=\left(w / \bar{x}^{*}\right)^{1 / 2}, \text { where } x s^{*}=\left(c_{2}+c_{3}+c_{5}\right)\left(1-\frac{(1-\theta) \beta_{3} b_{3}}{\beta_{1} b_{1}+\beta_{2} b_{2}+\beta_{3} b_{3}}\right) \text { and } \\
\theta=\left(c_{2}+c_{3}+3 c_{5}\right) /\left(c_{2}+c_{3}+3 c_{5}+2(1-\nu)\left(c_{2}+c_{3}\right)\right)
\end{gathered}
$$

The neutrally stable points discussed in that proposition no longer exist. The same situation also holds for the neutrally stable points discussed in parts 1 and 2 of Proposition 6.3. However, as the next proposition shows, for each $\nu<1$, there is a unique equilibrium bandwidth rate and a corresponding unique equilibrium to which orbits of (38)-(42) converge.

In what follows we let $\mathcal{B}^{\prime}$ be the region in the $d_{1}, d_{3}$ plane bounded above by the line $l_{0}$, below by the line $l_{1}$ and on the left by $d_{3}$ axis. The lines $l_{0}$ and $l_{1}$ are described just as they are in Section 6.1. We then define $\mathcal{B}=\mathcal{B}^{\prime} \cap\left\{\left(d_{1}, d_{3}\right) \mid d_{1} \geq d_{3}\right\}$.
Proposition 6.4 Let $h_{s}$ be the entropy defined by the distribution in 53) and suppose the initial values of $\left\{p_{i}^{(0)} i=\right.$ $1 \cdots 5\}$ satisfy the hypotheses in Lemma 6.1. Then $\mathbf{p}^{(k)}=\left(p_{1}^{(k)}, p_{2}^{(k)}, p_{3}^{(k)}, p_{4}^{(k)}, p_{5}^{(k)}\right) \rightarrow\left(0,0,0,0, p_{5}^{*}\right)$
Proof: Since $p_{i}^{(0)} \in W_{i} i=1, \cdots 5$, the initial dynamics of the route cost vector $\mathbf{d}^{(k)}$ is governed by the equations in 48)-49. First suppose, $\mathbf{d}^{(0)} \in \mathcal{B}$. The mean route cost, $\bar{x}^{(k)}=\beta_{1} d_{1}^{(k)}+\beta_{2} d_{2}^{(k)}+\beta_{3} d_{3}^{(k)}$ becomes stationary (i.e. $\Delta \bar{x}^{(k)}=0$ ) when $x s^{(k)}=x s^{*}$. We can repeat the arguments in the derivation of 32 from 31 to this situation to show that the mapping $T$, defined by

\bar{x}^{(k+1)}=T \bar{x}^{(k)}=\bar{x}^{(k)}-h \bar{b}\left\{x s^{*}-x s(k)\right\} \tag{54}
\end{equation*}
$$

where $\bar{b}=\beta_{1} b_{1}+\beta_{2} b_{2}+\beta_{3} b_{3}$, is a global contraction in $\mathcal{B}$ with a fixed point at $\bar{x}^{*}$. Consequently orbits in the $\mathbf{d}$ plane starting in $\mathcal{B}$ will converge to the line $l_{d}$. Once the orbit approaches the line, it remains there and moves toward the $d_{3}$ axis i.e. $d_{1}$ decreases while $d_{3}$ increases. This is because,

\end{equation*}

where $x s_{1}^{*}=C_{1} / b_{1}=c_{2}+c_{3}+c_{5}$ and $x s_{3}^{*}=\left(c_{2}+c_{3}+c_{5}\right) \theta$ are values for which $\Delta d_{i}^{(k)}=0$, for $i=1,3$. If $\mathbf{d}^{(0)}$ lies above the line $l_{0}$, then $\bar{x}^{(k)}$ decreases since $x s(k)<x s^{*}$. It is clear therefore that regardless of where the orbit starts, $d_{1}$ will eventually become small enough so that $p_{1}^{(k-1)} \notin W_{1}$ or $p_{3}^{(k-1)} \notin W_{3}$ for some $k$ for the first time.

We examine the case when $p_{3}^{(k-1)} \notin W_{3}$ first. It follows that $p_{3}^{(k)}=0$. We will show that $p_{3}^{(k+1)}=0$ and that the subset $\left\{\mathbf{p} \mid p_{3}=0\right\}$ is invariant under the iteration of 68)-42. By Lemma 6.1 $p_{2}^{(k)}=0$, and $p_{1}^{(k)}=p_{4}^{(k)}$, so we will focus on $p_{1}$ and $p_{5}$. If $p_{i}^{(k)} \in W_{i} i=1,5$, then an equation for $\bar{x}^{(k+1)}$ can be obtained. The value let us call it $x s p_{1,5}^{*}$,for which $\Delta \bar{x}^{(k+1)}=0$ is $x s p_{1,5}^{*}=u * x s p_{1}^{*}+(1-u) * x s p_{5}^{*}$ where $u=\frac{\left(1+\beta_{3}\right)\left(\beta_{1}+\beta_{3}\right)}{\left(1+\beta_{3}\right)\left(\beta_{2}+\beta_{3}\right)+\beta_{3}^{2}}$. Here, $x s p_{1}^{*}=\left(c_{3}+c_{5}\right) /\left(\beta_{1}+\beta_{3}\right)$ and $x s p_{5}^{*}=c_{5} / \beta_{3}$ are $x s$ values for which $\Delta p_{i}^{(k)}=0, \quad i=1, \cdots, 5$. The inequality $x s p_{5}^{*}<x s p_{1,5}^{*}<x s p_{1}^{*}<x s p_{3}^{*}$ holds. It can also be shown that the mapping $\bar{x}^{(k+1)}=T \bar{x}^{(k)}$ is a contraction in the $p_{1}, p_{5}$ plane with a fixed point $\bar{x}_{1,5}^{*}$ corresponding to $x s p_{1,5}^{*}$. Now $p_{3}^{(k-1)} \notin W_{3}$, implies that $x s(k-1) \leq x s p_{3}^{*}=\left(c_{2}+c_{3}+c_{5}\right) / \nu$ and if $x s(k-1)>x s p_{1,5}^{*}$, then $x s$ will decrease and $x s(k)<x s(k-1)$. If $x s(k-1)<x s p_{1,5}^{*}$ then $x s(k)>x s(k-1)$ but since $h$ is small $x s(k)<x s p_{3}^{*}$. Moreover, the distance between $x s(k)$ and $x s p_{1,5}^{*}$ decreases because of the contraction property in the iteration of $\bar{x}^{(k)}$. Thus $p_{3}^{(k+1)}=0$. Even though, subsequent iteration of $p_{1}$ and $p_{5}$ leads to increasing $x s$ when $x s(k)<x s p_{1,5}^{*}$ the corresponding value of $x s$ will approach but cannot exceed $x s p_{1,5}^{*}$. Thus $p_{3}$ remains 0 . Eventually $\left(p_{1}^{(k)}, p_{5}^{(k)}\right)$ converges to the line $x s p_{1,5}^{*}=\beta_{1} p_{1}+\beta_{3} p_{5}$ and remains on the line as $p_{1}^{(k)} \rightarrow 0$, and $p_{5}^{(k)} \rightarrow p_{5}^{*}$, where $x s^{*}=x s p_{5}^{*}$.

If $p_{1}^{(k-1)} \notin W_{1}$ and $p_{3}^{(k-1)} \notin W_{3}$, then since $x s p_{1}^{*}>x s p_{5}^{*}, x s(k)>x s p_{1}^{*}$ implies that $\bar{x}^{(k)}=\beta_{3} p_{5}^{(k)}$ will increase and thus $x s$ decreases and eventually, $x s(l)<x s p_{1}^{*}$ for some $l \geq k$. If $p_{1}^{l)}=0$, it remains 0 and the orbit remains on the $p_{5}$ axis and converges to $p_{5}^{*}$. If $p_{1}^{(l)} \in W_{1}$ for some $l$ then we are back in case discussed in the previous paragraph. In all these cases the orbits eventually converge to the point $\left(0,0,0,0, p_{5}^{*}\right)$ where $\bar{x}^{*}=\beta_{3} p_{5}^{*}$ with corresponding $x s^{*}=c_{5} / \beta_{3}$.

Finally we turn to the case where the equations for $\mathbf{d}$ lose validity because for some $k, p_{1}^{(k-1)} \notin W_{1}$ but $p_{i}^{(k-1)} \in W_{i} i=3,5$. We are supposing that up to this point, $p_{i}^{(l)} \in W_{i} l=0,1 \cdots k-2, \quad i=1,3,5$. From the Remark following Lemma 6.1, we have $p_{1}^{(k-1)}=p_{3}^{(k-1)}+p_{5}^{(k-1)}$. But $p_{3}^{(k-1)}>h\left\{c_{3}-\beta_{1} x s(k-1)\right\}$ and $p_{5}^{(k-1)}>h\left\{c_{5}-\beta_{3} x s(k-1)\right\}$ so it must be that $p_{1}^{(k-1)}>h\left\{c_{1}-\left(\beta_{1}+\beta_{3}\right) x s(k-1)\right\}$. Thus $p_{1}^{(k-1)} \in W_{1}$ a contradiction. Consequently this case cannot occur.

Remark: Since orbits that begin below the line $l_{1}$ blow up we will not discuss these here.

### 6.3 Diamond Route Distribution with decreased $h_{S}$

Using the notation introduced in Section 6.2 we consider $\nu>1$. This has the effect of increasing the weight on links 2 and 3 with a compensating decrease of weight on link 5 . The discussion in Section 6.2 shows that the corresponding entropy $h_{s}$ is decreased. In contrast with the previous case, the algorithm fails to converge and in fact the root $\gamma(k)$ of (17) diverges as $k \rightarrow \infty$. This section details a proof of this fact. For a particular sub-case (see Case 1a) we assume that $2 c_{2}>c_{5}$.

We assume initial values of $\mathbf{p}$, such that $p_{i}^{(0)} \in W_{i} i=1, \cdots, 5$. The subsequent dynamics at least intially can therefore be described by equations 48 - 49 Let the $x s$ values for which $\Delta d_{j}^{(k)}=0 j=1,2,3$ be denoted by $x s_{j}^{*}$. The relation (55) is now,

\begin{equation*}
x s_{1}^{*}<x s^{*}<x s_{3}^{*} \tag{56}
\end{equation*}
$$

Let $\tau_{1}$ be the line in the $\mathbf{d}$ plane given by $\bar{x}=\bar{x}_{1}^{*}$, where $\bar{x}_{1}^{*}$ is the mean cost corresponding to $x s_{1}^{*}$. The line $\tau_{3}$ is defined analogously. The line $\tau_{d}: \bar{x}=\bar{x}^{*}$ lies between $\tau_{1}$ and $\tau_{3}$ so we will define $\mathcal{C}$ to be the region bounded by these lines, the $d_{3}$ axis, and the line $\left\{\left(d_{1}, d_{3}\right) \mid d_{3}=d_{1}\right\}$. If $d^{(0)}$ is an initial point whose corresponding $x s$ value is $x s(0)<x s_{1}^{*}$, then $d_{1}$ and $d_{3}$ will decrease. On the other hand if the corresponding $x s$ value satisfies $x s(0)>x s_{3}^{*}$, then $d_{1}$, and $d_{3}$ will increase (see Figure 7). Orbits either enter the region $\mathcal{C}$ or they intersect or approach the $d_{1}$ or $d_{3}$ axes. We describe the fate of orbits that enter $\mathcal{C}$. The behavior of $\bar{x}^{(k)}$ is governed by 54). The contraction property of $T$ implies that $\mathbf{d}^{(k)}$ approaches the line $\tau_{d}$ and once the orbit reaches the line it moves along it. By 56 see that $d_{1}$ increases and $d_{3}$ decreases so it is clear that $\mathbf{d}^{(k)}$ approaches the line $d_{1}=d_{3}$. Thus $\gamma^{k}$ must diverge.

Suppose now that an orbit's initial position is located above the line $l_{0}$ (see equation (51) and Figure 7). In this situation, at least initially $x s(k) \leq x s_{1}^{*}<x s_{3}^{*}$, therefore $d_{1}$ and $d_{3}$ are decreasing and orbits approach the $d_{3}$ axis. We have $d_{3}^{(0)} \geq \delta$ where $(0, \delta)$ is the intersection of $l_{0}$ with the $d_{3}$ axis. Thus the equation will cease to be valid for some $k$ for the first time. Since $d_{1}^{k-1}=p_{1}^{(k-1)}+p_{3}^{(k-1)}$, we can suppose either $p_{1}^{(k-1)} \notin W_{1}$ or $p_{3}^{(k-1)} \notin W_{3}$. One can verify after some algebra, an inequality that will be used in the arguments that appear below. Recall that $x s p_{i}^{*}$ is the value of $x s$ for which $\Delta p_{i}^{(k)}=p_{i}^{(k+1)}-p_{i}^{(k)}=0$, when $p_{i}^{(k)} \in W_{i}$. For $\nu>1, x s p_{3}^{*}=x s p_{2}^{*}<x s p_{1}^{*}<x s p_{5}^{*}$.

Case 1: First assume that $p_{1}^{(k-1)} \notin W_{1}$ and thus $p_{1}^{(k)}=0$.
Case 1a If $p_{2}^{(k)}=p_{3}^{(k)} \in W_{2}$ and $p_{5}^{(k)} \in W_{5}$, an equation for $\bar{x}^{(k+1)}$ can be obtained in terms of $p_{2}^{(k+1)}$ and $p_{5}^{(k+1)}$ of the form $\bar{x}^{(k+1)}=T \bar{x}^{(k)}$ analogous to 32 . $T$ is a contraction with a fixed point $\bar{x}_{2,5}^{*}$ such that $x s_{2,5}^{*}=\left(\frac{w}{\bar{x}_{2,5}^{*}}\right)^{1 / 2}$, and $x s_{2,5}^{*}=(1-\mathfrak{f}) x s p_{2}+\mathfrak{f} x s p_{5}$ with $\mathfrak{f}=\frac{\beta_{3}^{2}}{\left(\beta_{3}^{2}+\left(1-\beta_{3}\right) \beta_{2}\right)}$. Now suppose $x s_{2,5}^{*}<x s p_{1}^{*}$. Then $\bar{x}^{(k)}=\beta_{1} p_{3}^{(k)}+\beta_{2} p_{2}^{(k)}+\beta_{3} p_{5}^{(k)}$ will move closer to the value of $\bar{x}$ corresponding to $x s_{2,5}^{*}$. Thus $x s(k+1)<x s p_{1}$ and therefore $p_{1}^{(k+1)}=0$. We could repeat this argument so that by induction this implies then that $p_{1}^{(l)}=0 \quad l \geq k$. Now $d_{3}^{(l)} \geq d_{1}^{(l)}$ and $p_{1}^{(l)}=0=p_{4}^{(l)}$, therefore $p^{(l)} \geq p_{2}^{(l)}$

In the $p_{2}, p_{5}$ plane, $x s(k) \rightarrow x s_{2,5}^{*}$ and since $x s p_{2}^{*}<x s_{2,5}^{*}<x s p_{1}^{*}<x s p_{5}^{*}$, we must have $p_{5}$ decreasing and $p_{2}$ increasing. Thus $\left(p_{2}^{(k)}, p_{5}^{(k)}\right)$ approaches the line $p_{2}=p_{5}$ as $k \rightarrow \infty$. This means that we approach the line $d_{1}=d_{2}=d_{3}$. The following sufficient condition for $x s_{2,5}^{*}<x s p_{1}$ is derived in the Appendix and is satisfied when $\kappa=\frac{c_{2}}{c_{5}}>1 / 2$ and $\nu>1$.

$$
\begin{equation*}
\left\{\frac{1}{\kappa+1+(1-\nu) \kappa}-\frac{f}{1+2(1-\nu) \kappa}\right\}>0 \tag{57}
\end{equation*}
$$

The preceeding reasoning assumed $p_{2}^{(k)} \in W_{2}$. The convergence of $\left(p_{2}^{(l)}, p_{5}^{(l)}\right)$ to the line $\bar{x}=x s_{2,5}^{*}$ and the fact that $x s_{2,5}^{*}>x s p_{2}$ shows that $p_{2}^{(l)} \in W_{2}$ for $l \geq k$.

Case 1b: Suppose $p_{3}^{(k)} \notin W_{3}$. Then $x s(k) \leq x s p_{3}^{*}$ and since $x s p_{3}^{*}<x s p_{1}^{*}<x s p_{5}^{*}$, both $d_{1}^{(k)}$ and $d_{3}^{(k)}$ decrease. Therefore even though $p_{3}^{(k+1)}$ is $0, x s(k)$ increases. $x s$ continues to increase until $x s(l) \geq x s p_{3}^{*}$, for some $l \geq k$. If $x s(l)=x s p_{3}^{*}$ then note that $p_{5}^{(l)}$ decreases, and hence $\bar{x}^{(l)}$ decreases. Therefore $x s$ will continue to increase and $p_{3}$ eventually becomes positive and we are back in the previous case where $p_{3}^{(k)}=p_{2}^{(k)} \in W_{2}$. If we have $p_{5}^{(k)} \notin W_{5}$, then $p_{1}^{(k)}=0$ implies that $d_{1}^{(k+1)}=p_{3}^{(k+1)} \geq d_{3}^{(k+1)}=p_{5}^{(k+1)}=0$. So we have crossed the line $d_{1}=d_{3}$ causing $\gamma$ to diverge. Case 2: Finally let us consider the case when for the first time, $p_{3}^{(k-1)} \notin W_{3}$. Then $x s(k-1) \leq x s p_{3}^{*}<x s p_{1}^{*}<x s p_{5}^{*}$ so $d_{1}$ and $d_{3}$ decrease, causing $x s(k)$ to increase. This increase continues until $x s(l) \geq x s p_{3}$, for some $l \geq k$.
Case 2a: If $p_{1}^{(k)} \in W_{1}$, then $x s$ continues to increase and eventually, $p_{3}^{(l)} \in W_{3}$ for some $l \geq k$ and is increasing. One can check that $x s p_{3}^{*}=x s_{1}^{*}<x s p_{1}^{*}<x s p_{5}^{*}$. If $x s(l) \leq x s p_{1}$, then $\left(d_{1}^{(l)}, d_{3}^{(l)}\right) \in \mathcal{C}$ and we can apply the results of the discussion of orbits in that region to this case. If $x s(l)>x s p_{1}$ and $p_{5}^{(k)} \in W_{5}$ then, equations 48)-44 can be used
to show that $\left(d_{1}^{(l)}, d_{3}^{(l)}\right)$ is either in or will eventually enter $\mathcal{C}$. If $p_{5}^{(k)} \notin W_{5}$ then $d_{1}^{(k+1)}=d_{3}^{(k+1)}$, i.e. we are at the boundary of the feasible region so $\gamma^{(k+1)}=\infty$.

Case 2b Note that $x s p_{3}^{*}<x s_{2,5}^{*}<x s p_{1}^{*}$. If $p_{1}^{(k)} \notin W_{1}$ then $x s$ increases until for some $l \geq k, p_{3}^{(l)}>0$. As in Case 1a, the dynamics of $d_{1}^{(l)}, d_{3}^{(l)}$ are determined by $p_{3}^{(l)}=p_{2}^{(l)}$ and $p_{5}^{(l)}$ as long as $x s(l)<x s p_{1}^{*}$ with $l>k$. We can repeat the arguments of Case 1a to show that in fact $x s(k) \rightarrow x s_{2,5}^{*}$.

The route distribution entropy $h_{s}$ is a measure of the degree of path diversity of an allocation scheme that uses that distribution. The tradeoff between path diversity and utility is not well understood in general but our approach allows us to frame the issue in relation to a reference entropy that defines an intrinsic allocation defined by the link capacities and topology of a given network. Using the critical entropy value as a reference, the effect of decreasing or increasing path diversity beyond this allocation can be assessed. This is illustrated in our examples by plotting the utility as a function of $h_{s}$. In each case, this was done by computing the average utility over a finite time interval for
each $h_{s}$ for a range of values that contained the critical entropy value. Figure 8 shows the computation for TwoLinks and Figure 9 shows the corresponding computation for Diamond. For values of $h_{s}$ less than the critical value, a time interval was chosen so that orbits were still within the feasible region. Increasing the entropy from $h_{s}=0$, the value for a single path allocation scheme, the iterations did not converge until a critical entropy value was reached.

Inspection of the curves shows that a network using an allocation with larger entropy can increase utility by decreasing the entropy (that is, increasing the fraction on less expensive links) up until the critical value is reached. The differing topologies of TwoLinks and Diamond affect what happens when the allocation entropy is less than the critical value. In TwoLinks the utility cannot be increased by decreasing the entropy. In Diamond, the utility is increased until the value $h_{s}=\log 2$. Note in contrast to [9] the utility does not reach a maximum at the critical entropy value. We could not stably iterate equations (38) - 42 for values $h_{s}<\log 2$. We find that the iterations fail to converge for any $h_{s}<h_{D}(c)$. A possible reason for this comes from a visualization of the route allocation distributions for 3 routes (Figure 10). As discussed in Section 4, each $\beta=\left(\beta_{1}, \beta_{2}, \beta_{3}\right)$, such that $\beta_{i} \geq 0 i=1,2,3$, $\beta_{1}+\beta_{2}+\beta_{3}=1$, can be associated with a point in the equilateral triangle with altitude height 1 . The transformation from the simplex in 3 -space to this triangle is smooth and invertible. The region defined by the constraints of the optimization problem i.e. inequalities 11 - 13 is convex and bounded by the level curve for $h_{s}$. Level curves for various values of $h_{s}$ are mapped to the curves in the triangle. When $h_{s}=\log 2$, the curve is tangent to the boundary of the triangle and therefore the level curve is tangent to the boundary of the simplex. The points of tangency are singular points for the entropy function (i.e. points where the derivative of $h_{s}$ as a function of $\beta$ fail to exist). Once $h_{s}<\log 2$, the curve becomes disconnected. It is interesting to note that the source of the trouble comes from the implicit equation. Indeed there are two solutions of the implicit equation for each $h_{s}$ and when $h_{s}<\log 2$, the values of $\left.\gamma_{( } k\right)$ oscillate between these values introducing sustained oscillations into the system that resemble the route flapping phenomenon discussed in [12] and other work. For such $h_{s}$ note that we are effectively operating with only two of the three links, so that the Diamond topology is equivalent at this stage to the Twolinks topology.

## 8 CONCLUSION

In this paper, we presented a convex network optimization problem for simultaneously controlling congestion and route allocation. The set of possible route allocations that can be used by a source $s$ is constrained by placing a lower bound on the route distribution entropy $h_{s}$. As a first step towards understanding the issues involved in any protocol based on this model we derived a dual iteration scheme and analyzed the dynamics for two simple topologies. Sufficient conditions insuring that the equilibria of the iteration scheme are solutions of the optimization problem are given. We also discuss the limits of the algorithm. Specifically in our examples we identify parameter values $h_{s}$ where the iterates eventually leave the region of feasibility. For such parameter values some other approach-using subgradient methods may prove useful.

Another key issue here is the trade-off between network utility and $h_{s}$, a parameter that measures path diversity. After making mild assumptions about the capacity of the links in each example we found a critical value of the entropy. The average utility can always be increased if the system has an allocation with route distribution entropy $h_{s}$ that is larger than the critical value. Figure 8 shows how the average utility for the TwoLinks topology plateaus so that its maximum value is achieved at or near the value at the critical entropy $h_{T}(c)$ similar to the results of the simulation in [9. However Figure 9 shows that the average utility for the Diamond topology continues to increase for $h_{s}<h_{D}(c)$. A natural lower bound of $\log 2$ is reached, corresponding to the point where one of the 3 routes is eliminated and the topology is effectively equivalent to TwoLinks. What we can therefore say in this case is that the utility value at $h_{D}(c)$ is the largest practicably achievable one given a protocol based on dual iteration.

In summary, we see that one cannot increase the utility by choosing a path distribution with entropy less than the reference entropy without producing infeasible solutions. For each of the examples, the link capacities and the topology introduce inherent limits to how closely the route allocation can approach the single path specification scheme.

## 9 APPENDIX

### 9.1 Constant $\beta^{(k)}$ in TwoLinks

In this section we will show that
Theorem 9.1 Let $\frac{c_{1}}{c_{2}}=\lambda$ and $\frac{\beta_{1}^{(h s)}}{\beta_{2}^{h s}}=\lambda+\mu$ with $\lambda>1$ and $\lambda+\mu \geq 0$. Then

$$
\begin{equation*}
\beta_{i}^{(k)} \equiv \beta_{i}^{(h s)} i=1,2, k \geq 0 \tag{59}
\end{equation*}
$$

where $\mathrm{H}\left(\beta^{(h s)}\right)=-\left(\beta_{1}^{(h s)} \log \beta_{1}^{(h s)}+\beta_{2}^{(h s)} \log \beta_{2}^{(h s)}\right)=h s$.

Proof: For simplicity we will drop the $h s$ notation from $\beta_{i}^{(h s)} i=1,2$. Given an entropy value $h s<\log 2$ there are exactly two associated probability distributions, either $\{\beta, 1-\beta\}$ or $\{1-\beta, \beta\}$. If we define the ratio $\rho=\frac{\beta_{1}}{\beta_{2}}$, then the distributions can be expressed as either $\left\{\frac{\rho}{1+\rho}, \frac{1}{1+\rho}\right\}$ or $\left\{\frac{1}{1+\rho}, \frac{\rho}{1+\rho}\right\}$. If $p_{1}^{(k)}<p_{2}^{(k)}$ then the choice of a positive root of 17 implies that $\beta_{1}^{(k)}=\frac{\rho}{1+\rho}$ where $\rho<1$. If on the other hand, $p_{1}^{(k)}>p_{2}^{(k)}$ then $\beta_{1}^{(k)}=\frac{1}{1+\rho}$.

Note that the condition $h s<\log 2$, rules out the possibility that $p_{1}^{(k)}=p_{2}^{(k)}$ for any finite $k$ since the solution of (17) would then be $\infty$. These facts lead to the observation that $\beta_{i}^{(k)}, i=1,2$ remains constant in $k$ if and only if $p_{2}^{(k)}-p_{1}^{(k)}$ does not change sign. In fact a change in sign leads to a jump discontinuity in the value of $\beta_{i}, i=1,2$.

### 9.2 Diamond route distributions and their entropy

There are 3 routes in the diamond topology. Using planar geometry one can show that every distribution in the simplex of distributions on 3 routes $S=\left\{\hat{\beta}=\left(\beta_{1}, \beta_{2}, \beta_{3}\right) \mid \quad \beta_{i} \geq 0 \quad i=1,2,3 \beta_{1}+\beta_{2}+\beta_{3}=1\right\}$, can be represented by a point in an equiliateral triangle with an atlitude of height 1. This result is known as Viviani's theorem. If we position the leftmost vertex of the base of the triangle at the origin (as shown in Figure 10, then the distribution $\left(\beta_{1}, \beta_{2}, \beta_{3}\right) \in \mathrm{S}$ corresponds to coordinates $(x, y)$ in the triangle through $\Psi: \mathcal{R}^{2} \rightarrow \mathrm{~S}$ given by,

$$
\begin{equation*}
\beta_{1}=y, \beta_{2}=\frac{\sqrt{3} x-y}{2}, \beta_{3}=1-\left(\frac{y+\sqrt{(3) x}}{2}\right) \tag{60}
\end{equation*}
$$

The entropy function $\mathrm{H}\left(\beta_{1}, \beta_{2}, \beta_{3}\right)$, defines a function of $x, y$ through 60) and $h(x, y)=\mathrm{H}(\Psi(x, y))$. The distribution with $\beta_{1}=\beta_{2}=\beta_{3}=1 / 3$, is the image of $(1 / \sqrt{ }(3), 1 / 3)$. A simple computation shows that the latter is a non-singular critical point of $h$. Hence nearby level curves are nearly ellipses and other level curves for smaller values of $h_{s}$ that do not touch another critical point must have the same topological type and so they are simple closed curves [10]. Since $\Psi$ is affine and H is convex, $h=H \circ \Psi$ is convex and therefore quasi-convex. The region enclosed by a level of $h$ is therefore convex. At $\log 2$, the level curve has several critical points that are the images of the intersection of the black curve in Figure 10 with the sides of the triangle. The topological type of the level curve therefore changes.

### 9.3 Suffcent condition that $x_{2,5}^{*}<x s p_{1}^{*}$

We present a proof of the inequality (58) that appeared in Section 6.3.
Lemma 9.2 Let $x s p_{1}^{*}$ be the value of $x s$ for which $\Delta p_{1}^{(k)}=0$ in equation 38). Further let, $x s_{2,5}^{*}$ be the value of $x s$ for which $\Delta \bar{x}^{(k)}=0$ restricted to the $\left(p_{2}, p_{5}\right)$ plane. Then $x s_{2,5}^{*}<x s p_{1}^{*}$ if and only if inequality 58) is satisfied .

## Proof:

We have,

x s p_{1} & =\frac{c_{3}+c_{5}}{c_{3}+c_{5}+(1-\nu)\left(c_{2}+c_{3}\right)}, x s p_{2}=x s p_{3}=\frac{c_{2}+c_{3}+c_{5}}{\nu}  \tag{61}\\
x s_{2,5}^{*} & =(1-\mathfrak{f}) x s p_{2}+\mathfrak{f} x s p_{5}  \tag{62}\\
\mathfrak{f} & =\frac{\beta_{3}^{2}}{\beta_{3}^{2}+\left(1-\beta_{3}\right) \beta_{2}}  \tag{63}\\
& =\frac{\left(c_{5}+2(1-\nu) c_{2}\right)^{2}}{\left[2\left(\nu c_{2}\right)^{2}+\left(c_{5}+2(1-\nu) c_{2}\right)^{2}\right]} \tag{64}
\end{align*}
$$

Writing $x s_{2,5}^{*}-x s p 1=(x s p 2-x s p 1)-\left(x s p 2-x s_{2,5}^{*}\right)$, after some algebra it can be seen that

$$
\begin{equation*}
x s_{2,5}^{*}-x s p_{1}=\left(\frac{1-\nu}{\nu}\right)\left[\frac{1}{c_{3}+c_{5}+(1-\nu) c_{3}}-\frac{\mathfrak{f}}{c_{5}+(1-\nu)\left(c_{2}+c_{3}\right)}\right]\left(c_{2}+c_{3}+c_{5}\right) \tag{65}
\end{equation*}
$$

The expression in the square brackets of equation (65) is the left hand side of inequality (58). Setting $\kappa=\frac{c_{2}}{c_{5}}=\frac{c_{3}}{c_{5}}$ it can be seen that choosing $\kappa>1 / 2$ is sufficient when $\dagger$ is rewritten in terms of $\kappa$ and the inequality is verified by calculation.
