As in the past, the mornings will be devoted to general sessions with the afternoons (and a few evenings) given over to multidisciplinary workshops and breakout meetings. There has been occasional confusion and misinformation regarding the process of running for office in the IAI. Although the process has not changed, the following is presented to minimize any confusion that might exist:

Anyone desiring to run for an IAI office must appear before the Nominating Committee on the first Monday of the conference. As stated in Article VI, Section 1, of the IAI's constitution, that committee is composed of all past presidents in attendance at the conference who wish to serve, the chair of the Board of Directors, and one associate member.

Incumbent officers, to include vice presidents and board members, seeking the same office or, in the case of the vice presidents, the successive office, **do not** have to come before the Nominating Committee. *Non-incumbents* desiring to run for any office, including the Board of Directors, **must** appear in person before the committee. In addition, nominations for office may be made from the floor during the Annual Business Meeting, but each candidate *must* speak briefly on his or her own behalf after being nominated from the floor. should be noted that the Secretary-Treasurer, Legal Counsel and Editor are appointed, not elected, positions, so they do not fall within the above guidelines.

The IAI Image Quality tests conducted at NIST have been completed and a compression ratio of 15:1 has appeared to be acceptable for IAFIS applications. Complete test documentation has been forwarded to all IAI officers and board members, and is available from any of these individuals. In addition, the complete test will be published in a future *Journal*. Interestingly, the FBI has adopted the 15:1 compression ratio as the basis for continuing the development of the IAFIS system.

I look forward to seeing you in Phoenix for what promises to be a most productive and educational experience.
