Conformity assessment: demonstration that specified requirements are fulfilled



Conformity assessment body (CAB): body that performs conformity assessment services

The Parties – Who Does What?

- First Party** Conformity assessment body (CAB) is person or organization that provides the object (seller or manufacturer)
- Second Party** CAB is a purchaser or user
- Third Party** CAB is an independent entity that has no interest in transactions between the first and second parties (...but they do have a financial interest in the conformity assessment)

Attestation: Issue of a statement that fulfilment of specified requirements has been demonstrated



ISO/IEC 17050-1: Conformity assessment— Supplier's declaration of conformity

- Specifies requirements applicable when the individual or organization responsible for fulfilment of specified requirements (supplier) provides a declaration that a product (including service), process, management system, person or body is in conformity with specified requirements.
- Declaration (hardcopy, electronic media, or any other suitable medium):
 - Is uniquely identified
 - Contains sufficient information to enable the recipient of the declaration of conformity to identify the issuer of the declaration, the object of the declaration, the specified requirements with which conformity is declared, and the person signing for and on behalf of the issuer of the declaration of conformity
 - Can make reference to the results of assessments by one or more first, second or third parties
- Issuer require to have procedures to ensure the continued conformity of the object with the stated requirements of the declaration of conformity, and to re-evaluate validity in the event of changes.

Closing thoughts: What does a self-attestation really do?

- SDoC is by far the most common conformity assessment practice used for products being placed in the market globally
 - Specified requirements can be in regulation, procurement documents, or voluntary program descriptions
 - Can also be requirements regarding the conformity assessment determinations that support the SDoC and/or the bodies that perform them
- Represents a claim made in the market
 - Attestations made against specific criteria must be supported by appropriate evidence
 - When attestation is publicly available, other interested parties can verify or challenge the attestation
