Online resources such as “What the Font”, “Font Squirrel”, and “What Font Is” are helpful tools in identifying fonts (typefaces) but are not definitive and may not withstand scrutiny in a court of law. Forensic Document Examiners (FDEs) and other non-FDE experts have presented on the topic of font identification and the importance of date of introduction of fonts. ^{1,2,3} As technologies have changed from typewriters to modern computers and printing techniques, FDEs have relied on input from verifiable sources such as manufacturers in determining document creation, development, and authenticity. Yet, a relationship gap exists between FDEs and font developers. A reliable and continued database resource establishing access to font identification and date of introduction is needed by FDEs in order to further standards on alterations⁴ and authentication⁵ of documents.
