# **Objective**

NIST is investigating the design, capabilities, and performance of the installed active fire-protection systems in WTC 1, 2, and 7 and their role in fire control, emergency response, and fate of occupants and responders.

#### Scope

Three systems are being investigated: the fire sprinkler system, including the fire standpipes and pre-connected hoses; fire alarm system; and the smoke management systems.



### **Areas of Focus**

- What were the performance limitations of the WTC 1 and 2 sprinkler systems after rupture of the water supply riser?
- What was the capacity of the sprinkler system in building 7 to retard fire spread?
- What, if any, are the default alarm signals or messages from a damaged WTC 1 and 2 system?
- Was the manual smoke purging system used in the towers?



## **Organization of Project 4**

- NIST investigators leading three groups of fire protection system contract experts.
- The engineering groups are organized by fire protection system specialty.
- Each group is examining the one type of fire protection system in all three WTC buildings.

# Sprinklers, Standpipes and Pre-connected Hoses - Tasks

- Document the design and installation
- Document the design and capacity of the water supply including provisions for redundancy
- Identify differences in the designs between WTC 1, 2, and 7
- Document the normal operation and effect of the fully functional systems for fire control
- Assess the probable performance of the systems on September 11, 2001



#### **Fire Alarms - Tasks**

- Document the design and installation of the systems
- Document the normal expected operation and effect of the fully functional systems, including provisions for redundancy
- Document modifications made to fire alarm systems in WTC 1 and 2 after the 1993 bombing
- Assess the probable performance of the systems on September 11, 2001



#### **Smoke Management - Tasks**

- Document the design and installation of the systems
- Describe the normal operation in fire emergencies
- Assess the probable performance of the systems on September 11, 2001



# Fire History of WTC Buildings 1, 2 and 7

- NIST gathered information on significant fires in the buildings after occupancy and prior to 9-11-01
- The extensive records of fire incidents kept in the WTC 1 offices of the PANYNJ were lost
- Information was collected from FDNY [434 Bureau of Operations Fire Reports (1970-2001) and 87 Bureau of Fire Investigation Records (1977-2001)]
- There were 12 significant fires defined by NIST as those activating multiple sprinklers or equivalent in addition to the well known 1975 fire starting on floor 11 of WTC 1 and 1993 parking garage bombing

### **Fire Alarm Information from Building 7**

- WTC Building 7 fire alarm system was monitored by AFA Protective Systems, Inc. outside of the WTC site
- The fire alarm record was reviewed to find information about the fire conditions in building 7 on 9/11/01
- Although a great amount of information is collected from fire detectors throughout a building and stored by the fire alarm system, typically, and in this case, no specific fire information is sent out of the building
