# **Submitting the Application:**

#### The RFP mentions 15 pages maximum. Is this single- or double-spaced?

The application may be formatted in single space or double space. Applicants should determine the appropriate spacing in relation to the content of their application and the other guidelines described in the Announcement of Federal Funding Opportunity.

The application package doesn't include the places to upload the technical proposal

#### and abstract. How can I get them?

Application documents must be completed and attached by clicking "Add Attachments" found in item 15 of the SF-424, Application for Federal Assistance. This will create a zip file that allows for transmittal of the documents electronically via Grants.gov.

# **Use of Funding:**

#### What are we permitted to use the grant funding for?

Funds may be used for the conduct (i.e. programmatic activities) and operational activities (i.e. grant administration, management, and oversight) directly associated with the award. General information on allowability of costs is available in 2 CFR Part 200 Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, accessible at: http://go.usa.gov/SBYh.

# What should be achieved by this grant?

Applicants must establish (or identify if it already exists) a multistakeholder workforce partnership to include at least a K-12 school, an institution of higher education, and a local employer to support or implement the goals and objectives of the NICE Strategic Plan. Standup of this consortium, as well as the delivery of specific activities, such as training, adhere to the intent of the program.

In the "Statement of Work and Implementation Plan", is "Recruit employers in the community to support internships, apprenticeships, or coop programs in conjunction with education and training providers." the major activity? Or do you expect certain specific training activities to be developed and implemented for the employers?

The importance of one activity doesn't necessarily outweigh the other. Successful applicants will be awarded based on their ability to effectively address local cybersecurity workforce development needs.

#### What is the time frame allowable to use this funding?

Applicants should anticipate completing their goals and objectives within a 15-month project period.

## Applicants:

Will you be awarding based upon geography?

Geography may be taken into account at time of selection since one of the selection factors is "Regional Diversity".

When you refer to eligible applicant as "non-profit including institutions of higher education" are you specifically referring to 501c3 non-profit corporations or just an applicant that is not private or for-profit?

For the purpose of this FFO, a non-profit organization is an entity that is not a government agency (state, local or tribal) or a for-profit.

If a legally formed non-profit is waiting for its exempt status can it still apply?

Yes.

# **Partnerships/Letters of Commitment:**

How many total partnerships must be identified?

A multistakeholder workforce partnership must include at least 1) K-12 school, 2) an institution of higher education and 3) local employer.

Participation from more than one organization of each of these types as well as from training and certification providers, economic development organizations, and other community organizations is encouraged

Do K-12 partners need to focus on all of K-12? Could the partner just focus on segments of K-12 (i.e. only middle school or only high school)?

There is no requirement to include all grade levels.

#### Are we required to have sub-awardees?

No. Members of the multistakeholder partnership are not required to receive funding.
