Introduction

- 1. Radio Equipment Directive (RED) Article 3.3g on access to emergency services was expanded to include **mobile phones**. The requirements for essential requirement RED Article 3.3g (mobile phones/Galileo) have been applicable since March 17, 2022. See <u>Delegated Regulation 2019/320</u>.
- 2. There are no harmonized standard (hENs) references cited in the Official Journal of the European Union (OJEU) to address RED Article 3.3g (mobile phones/Galileo). Therefore, manufacturers placing mobile phones on the market in the EU are **required** to use the services of an RED Notified Body. The European Commission (EC) has published the following EC Guidelines for the notified bodies and manufacturers: EC Guidelines for Compliance with Delegated Regulation 2019/30
 - The aim of these EC Guidelines is to harmonize the approach/technical solutions. Other approaches/solutions are allowed with technical justification.
- 3. RED NBs that evaluate mobile phones for the RED may add RED Article 3.3g (mobile phones/Galileo) to their ISO/IEC 17065 Scope of Accreditation. Beginning in 2023, NIST requires inclusion of the applicable essential requirements (ERs) on the NB Scope of Accreditation. The ERs will be provided to the EC (via NIST NANDO notification). The ERs will be listed in NANDO (for public viewing). NBs will only be able to offer NB services for those ERs that are listed in NANDO.
- 4. This assessment checklist shall be used by the US accreditation bodies to document the competency assessment for RED NBs that are adding RED Article 3.3 g (mobile phones/Galileo) to their ISO/IEC 17065 Scope of accreditation.
- 5. It is acceptable for the assessment to add RED Article 3.3 g (mobile phones/Galileo) to be conducted remotely (if the accreditation body allows this).
