To whom it may concern,

I only have one comment/concern, and that is the introduction of GNSS in this document without alerting the reader that non-US GNSS is not traceable back to UTC USNO. I could not find any reference in the document to GNSS time not being traceable to UTC USNO or under US control. Technical Report ITU-T GSTR-GNSS is referenced and Section 1.3.2 covers GNSS Time; unfortunately, the only example it provides is US GNSS or GPS and then states that "other GNSS systems are comparable". They might be comparable, but they can't be traced back to UTC USNO, which is a problem for cyber security.

A goal of UTC is to have every country participating on the same time standard; unfortunately, that is not the case and the use of the term "UTC" was a problem during the balloting of the SAE eLoran standards. As you know, UTC USNO and UTC NIST are not exactly the same, but they're kept in in very close agreement, typically to within 20 nanoseconds, and both can be considered official sources for time in the United States.

It has been my experience, that very few people are aware that GNSS time might not be traceable back to UTC USNO.

GNSS is a time source, but your reader's need to be aware of the potential dangers associated with using non-US GNSS as a time source.

To align with US Policy, time must be based on USNO UTC and the reader should know that GNSS does not align with US Policy and is not traceable to UTC USNO.
