

**Site License**  
**NIST Standard Reference Database 23**  
**NIST Reference Fluid Thermodynamic and Transport Properties**  
**Database (REFPROP)**

This document is a non-exclusive, non-transferable, non-assignable and limited License agreement between the National Institute of Standards and Technology, U.S. Department of Commerce, (NIST) and \_\_\_\_\_ (“Licensee”).

**DEFINITIONS**

**Site** – defined as one organization consisting of one or more geographic locations.

**Named User** – An individual associated with the Licensee authorized to use REFPROP. One REFPROP license is required for each named user. The number of Named Users determines the site license level in section three of this agreement.

**1. GRANT OF RIGHTS, TERMS AND CONDITIONS**

Upon acceptance of this agreement, NIST (“Licensor”) shall grant Licensee a non-exclusive, non-assignable and non-transferable license for \_\_\_\_\_ (number of) Named Users from \_\_\_\_\_ (name of Institution) the right to use the NIST Standard Reference Database 23 – NIST Reference Fluid Thermodynamic and Transport Properties Database Version 10.

Licensee may use REFPROP Version 10, including the Dynamic Link Library (DLL) (hereinafter referring to the DLL distributed directly by NIST or to any other part of a compiled object generated by incorporating the REFPROP Version 10 source code) and related files containing fluid and mixture coefficients as supplied by NIST as integral parts of programs, limited to internal applications, developed for Institutional use only by the Licensee.

Licensee may use revisions to REFPROP Version 10, as part of the license granted under this agreement, when they are made generally available to users as versions 10.x. Licensee shall not use a later version of REFPROP other than the version that accompanies this agreement unless Licensee has separately acquired the right to use such later version through a separate Site License agreement.

**2. COPYRIGHT AND USE RESTRICTIONS**

Copyright protection of NIST Standard Reference Database 23 has been secured by the U.S. Department of Commerce in the United States and in other countries that are parties to the Universal Copyright Convention, pursuant to Section 290(e) of Title 15 of the United States Code. Licensee is responsible and accepts responsibility for ensuring that Licensee’s Authorized Users comply with all copyright and usage provisions under the agreement. Under no circumstances or conditions shall Licensee sublicense or otherwise transfer the use of the Licensed Service, nor shall Licensee or Licensee’s Authorized User reproduce, distribute, augment, change or modify any material, including the Dynamic Link Library (DLL), source code, or executable files unless permission to do so is expressly granted in writing by NIST. Licensee and its Users may not reproduce or distribute copies of the licensed material for any reason or purpose, unless approved by NIST in writing prior to such use.

- Licensee may integrate REFPROP in internal, intranet applications to all Named Users.
- Licensee may integrate REFPROP on Internet accessible applications providing the application is restricted to only Named Users.
- A NIST Distribution Agreement is required for public Internet access to REFPROP including but not limited to public Internet accessible websites, IOS and Android applications, or machine to machine communications including Application Programming Interfaces.

Named Users specified in the License are NOT permitted to do the following:

- allow any other than Named User to use or access the database
- develop a commercial package from any portion of the database and in turn, distribute package in any mode or medium to additional customers
- alter or modify any portion of the database
- delete or remove, in any form or format, any copyright information or notice

### 3. LICENSE FEES – 25 User Minimum

Licensee shall be given access to the database upon full payment of the appropriate subscription fee and acceptance of this agreement. Licensee understands that payment will be due in advance in order to access the database. Licensee agrees that the license granted herein shall not take effect until NIST has received full payment of the appropriate subscription fee.

**Existing site license customers shall receive a 50% discount off of the calculated payment from the above table.** For example, thirty-two users is  $(\$260 \times 32) + \$800 = \$9,120$ . For site license renewals, thirty-two users is \$4,560. 75 users and above is a flat fee of \$19,670 or \$9835 for existing site license renewals.

### 4. NO WARRANTY

NIST strives to deliver a high-quality database and to verify that the data contained therein have been selected on the basis of sound scientific judgment. However, NIST makes no warranties, express or implied, of any type including no warranty of merchantability or fitness for a particular purpose. NIST shall not be liable for any damage that may result from errors or omissions in the database.

**5. TERMINATION**

Licensee may terminate this agreement for any reason, at any time. This agreement may be terminated by NIST in the event of any breach of the terms of this agreement by the Licensee. NIST shall notify the Licensee in writing of its intention to terminate the agreement for cause and will allow customer thirty (30) days to correct the breach after the date or receipt of written notification.
