<p>QUESTION: Shall the Board of Supervisors of Fairfax County, Virginia, contract a debt, borrow money, and issue bonds of Fairfax County, Virginia, in addition to the parks and park facilities bonds previously authorized, in the maximum aggregate principal amount of \$75,000,000 for the purpose of providing funds, with any other available funds, to finance the cost of providing additional parks and park facilities including the acquisition, construction, development and equipment of additional parks and park facilities, and the purchase of permanent easements for the preservation of open-space land and the development and improvement of existing parks and park facilities by the Fairfax County Park Authority, and including an amount not to exceed \$10,000,000 allocable to Fairfax County as its share of the cost of parks and park facilities to be acquired, constructed, developed, and equipped by the Northern Virginia Regional Park Authority?</p>	<p>QUESTION: Shall the Board of Supervisors of Fairfax County, Virginia, contract a debt, borrow money, and issue bonds of Fairfax County, Virginia, in addition to transportation improvement bonds previously authorized, in the maximum aggregate principal amount of \$165,000,000 for the purpose of providing funds for the cost of providing additional transportation improvements and facilities, to finance the cost of constructing, reconstructing, improving and acquiring transportation improvements, including highways in the primary and secondary systems of State highways, off-street parking, pedestrian improvements, and ancillary related improvements and facilities, and including capital costs of necessary land, transit facilities and equipment in the Washington metropolitan area allocable to Fairfax County pursuant to the provisions of the Washington Metropolitan Area Transit Authority Compact?</p>
