### **STATEMENT OF WORK**

### **Introduction**

The On-Chip Integrated Photonics-Based Metrology project within the Thermodynamic Metrology Group requires the development of next generation photonics-based sensors as will various optoelectronic sub-components, such as on-chip integrated photodetector and light-source. For the development of optoelectronic sensors and on-chip integrated sub-components we plan to build a measurement setup for electrical/optical characterization of optoelectronic devices and sensors. The main block of this system will consist of three digital signal processing (DSP) lock-in amplifiers.

### **Background**

The DSP lock-in amplifiers will be used for electrical/optical measurements of next generation optoelectronic nanodevices and sensors. In particular, three lock-in amplifiers will be used for building the measurement setup for testing and characterization of optoelectronic nanodevices and sensors.

### **Minimum Requirements**

The system shall meet or exceed the technical specifications identified below. **All items must be new.** Used or remanufactured equipment will not be considered for award.

Line Item 0001: DPS Lock-In Amplifier Quantity: One (1)

- 1. Shall be a dual phase unit which can operate in single-ended or differential voltage mode.
- 2. The oscillator shall have a frequency range from 1 mHz (or less) to 250 kHz (or more) with 1 mHz (or less) resolution.

- 11. Shall have noise measurement mode to measure noise in a given bandwidth centered at the reference frequency.
- 12. Shall have a spectral display mode to show the power spectral density of the input signal and noise in the use-selected frequency range.
