1. **IREX Overview** 1

2 The NIST Interoperable Iris Program is being initiated at NIST in support of an expanded marketplace of iris-based

applications based on standardized interoperable iris imagery. The work is primarily conducted in support of the ISO/IEC 3

4 19794-6 standard, now under revision. It secondarily supports the recently completed ANSI/NIST ITL 1-2007 Type 17 5 standard, as derived from the ISO/IEC 19794-6:2005 parent [STD05], and future revision thereof.

6 The IREX is distinct from NIST's prior Iris Challenge Evaluations (ICE). Table 1 gives the context for IREX amongst the various iris activities at NIST.

Table 1 – NIST's iris evaluations

IREX 08	IREX 08 is intended to measure interoperable performance of compressed ISO/IEC 19794-6:2005 rectilinear and polar formatted records, and of a variant proposed for the forthcoming revision of ISO/IEC 19794-6.
ICE 06	Coordinated by Jonathon Phillips at NIST, the Iris Challenge Evaluation 2006 was a comparative assessment of commercial iris verification implementations on a common sequestered test corpus.
ICE 05	Coordinated by Jonathon Phillips at NIST, the ICE 05 activity was a cooperative research and development effort centered on the ICE 05 image corpus collected by University of Notre Dame.

2. Motivation and background 9

2.1. **Toward compact forms** 10

11 NIST's motivation in executing IREX 08 is the establishment of a standardized accurate, interoperable and compact iris 12 image format suitable for large scale identity management applications.

13 While IREX 08 is structured only as an application-independent assessment of the core algorithmic performance of the

14 segmentation and recognition components, NIST is particularly interested in establishing a set of specifications for an iris data element suitable for storage on an ISO/IEC 7816 crypto-token¹, and for efficient transmission across a network. Such

15 16 specifications are

- 17 segmentation parameters (e.g. inner and outer radii multipliers, see section X),
- 18 compression settings (e.g. bits per pixel, see section Y), and _
- 19 geometric representation (e.g. polar or rectilinear, see section Z).

20 Toward similar ends, iris compression studies have been conducted [USNA,CAM07,BATH06,BATH07]. While the studies

21 report promising results, they explored only the single-vendor case in which enrolment and verification data are processed by a lone supplier's segmentation and matching algorithms. The exception here is [BATH07] which showed

22 23 similar compression sensitivities for two different matching algorithms.

24 The ISO/IEC 19794-6 standard was published in 2005 [STD05]. It is almost identical to its precursor, the INCITS 379:2004

25 standard published in the United States [1379]. As application-independent standards, neither document establishes normative requirements on compression. Instead the ISO standard's clause A.1.6 gives the following informative 26

27 guidance "... a compression factor of 6:1 or less is recommended". This is rather conservative compared to the order of

28 magnitude larger compression ratios cited in recent studies.

¹ For example, the U. S. Government's PIV Card, which currently uses fingerprint minutia. As the de facto leading data element for 7816 identity credentials, single-finger minutia templates, encoded as INCITS 378:2004 records, contain 38 minutiae (the MINEX 04 median value [MINEX]) and occupy 260 bytes including header information. ISO/IEC 19794-2:2005 compact card templates are less than half the size yet offer similar accuracy [MOC].

Support for the ISO standard 2.2. 1

- 2 A second key motivation is to support the production of a more robust, interoperable, useful and implementable ISO/IEC
- 3 19794-6 standard. Thus, IREX 08 should be viewed as unofficial augmentation of the ISO development process. This
- 4 contrasts with the default practice of the responsible standards bodies, SC 37 Working Group 3 and M1.3, which is to not
- 5 embed conformance, performance and interoperability tests as part of the standards' development process. For [STD05]
- 6 the result of this structure was that the ultimate viability of the final standard rested on the considerable expertise of the
- 7 editor and the committee, and on any (unpublished) intra-supplier tests.

8 The ISO standard was adopted by at least the Registered Traveler (RT) program in the United States which sought to use

- 9 compact iris imagery on an identity credential. This was achieved by specifying a no-inner-boundary polar format² to
- 10 mitigate possible interoperability problems with the full polar format. Such problems have recently been asserted by 11
- noting that the interoperability of the polar format is critically sensitive to the consistency of the segmentation [N2059,
- 12 N2124], and subject to sampling problems [PROC]. The solution advocated in the German proposal to SC 37 [N2059] is 13 complete removal of the polar format, and the revised text of the standard [N2226] identifies which text is to be removed.
- 14 A UK contribution [N2124] also advocates removal, and suggests the polar format's size can be achieved via cropping and
- 15 compression of the rectilinear format. The UK contribution [CAM07] indicates that compressed sizes of about 2KB are
- achievable. The proposal to remove has been opposed by US [DHS,NIST,LG] with observations that the polar format can 16
- be interoperable (viz. RT), that removal would undermine standards adoption, and that some testing is needed. 17
- 18 While NIST understands the assertions that the interoperability of the polar format is innately fragile, we note
- 19 the polar format was developed and approved by SC 37 and M1, and,
- neither cross-vendor interoperability, nor segmentation consistency, have ever been reported³. 20 _
- 21 This test is therefore intended to assess the interoperability of the various polar formats, and independently measure the 22 dependence of verification error rates on compression.
- 23 NIST supports the current U.S. position to not remove the polar formats from the standard. NIST will support removal of 24 one or more of those formats if
- 25 guantitative interoperability targets are met with compressed rectilinear formats, and
- 26 quantitative interoperability targets are not met when data formatted according to the polar formats in ISO/IEC _ 27 19794-6 are matched.

3. Scope 28

- 29 IREX 08 is intended to support ISO/IEC 19794-6 by requiring participants to produce conformant instances of the
- 30 standard, and by contributing quantitative experimental measurements to SC 37 Working Group 3 for the development 31 of the ISO/IEC 19794-6 revision project.
- 32 Specifically the test aims to
- quantify the performance and interoperability of 33
- 34 rectilinear images,
- 35 no-inner boundary polar images,
- fully segmented polar images, and 36 _
- unsegmented polar images 37
- 38 measure the effect of JPEG and JPEG 2000 compression on accuracy,

² Clause 6.3.2.3 of ISO/IEC 19794-6:2005 allows the pupil center to be used as the inner boundary, i.e. the pupil-iris boundary is not detected and the pupil radius is set to zero.

 $^{^{3}}$ The International Biometric Group's ITIRT study [ITIRT] evaluated sensor interoperability with a common matching subsystem. The three sensors yielded either uncompressed or compressed JPEG rectilinear images.

- 1 quantify the performance and interoperability of iris segmentation algorithms
- 2 time the various operations,
- 3 formulate content and comments toward possible revision of the relevant standards, and
- 4 check that suppliers can produce records conformant to the ISO/IEC 19794-6 standard.
- 5 The primary outputs of the test will be statements of performance including
- 6 measurements of false non-match and false match error rates for various compression levels and operating
 7 thresholds,
- 8 rectilinear to polar conversion times,
- 9 feature extraction times, and
- 10 matching times.
- 11 In so doing, the IREX evaluation requires
- 12 conversion of raw raster images into ISO/IEC 19794-6 rectilinear images, and
- 13 conversion of ISO/IEC 19794-6 rectilinear images into ISO/IEC 19794-6 polar images.
- 14 The following are specifically not within the current scope of this evaluation:
- 15 sensor evaluation (this study will be conducted with offline imagery),
- 16 off-angle imagery (other than that incidentally present in the test corpora),
- 17 conformance to INCITS 379:2004, and
- 18 identification performance.






Figure 3 - Steps for verification of unsegmented polar images

1 6. Aspects of the test

2 6.1. Fundamental concept of the test

- 3 The IREX 08 is an interoperability test and is structured around three core operations:
- 4 In stage 1, functions within the supplier's SDK are called to prepare the four encodings of Table 3, specifically to convert
- 5 In stage 1, archival rectilinear raster images to
- 6 Rectilinear images conformant to ISO/IEC 19794-6:2005,
- 7 Two polar instances conformant to ISO/IEC 19794-6:2005, and
- 8 Unsegmented polar images conformant to the specifications herein.
- 9 In stage 2, functions within a supplier's SDK are called to convert the processed images into an opaque proprietary
 10 template.
- In stage 3, functions within a supplier's SDK are called to compare two proprietary templates and produce a distance
 measure.
- 13 This procedural decomposition is depicted in Figure 1, Figure 2 and Figure 3. The left side of those diagrams shows the 14 enrollment process, and the right side shows the verification phase.

15 **6.2.** Interoperability space

- 16 The targeted interoperability scenario is a one-to-one verification application in which compressed enrollment imagery is
- 17 retrieved for storage to be compared with an uncompressed and unsegmented verification sample. This is reflected in
- 18 Figure 1, Figure 2 and Figure 3 which show the verification sample as always being a rectilinear image.
- 19 NIST will mimic this operation in an offline evaluation by comparing enrollment instances in the various compressed
- formats against unprocessed and uncompressed verification images. This differs, for example, with [CAM07] in which
 both images were compressed before any segmentation and feature extraction.

22 6.3. Offline evaluation using archival imagery

- NIST intends to execute the test in an entirely offline fashion and to use images from the sequestered ICE 06 corpus of LG
 2200 images, and a larger corpus collected using the LG 3000. NIST is likely to extend this data arbitrarily to include other
 sources. IREX 2008 is unlikely to embed a dedicated scenario test or data collection.
- 26 NIST will identify the specific cameras in all published reports.

27 6.4. Uniform software interface

As in many prior NIST tests, we intend to evaluate algorithms by requiring them to be implemented behind a simple "C" API. Note that this is a departure from the ICE protocol.

30 6.5. Audience and options for participation

- 31 Universities and commercial concerns with capabilities in following areas are invited to participate in the IREX 08 test.
- 32 Production of conformant ISO/IEC 19794-6 records
- 33 Segmentation of iris imagery, including production of polar formats
- 34 Verification of standardized image records.
- 35 Prospective participants should read this document then complete the application form, Annex B. Participants must

submit an SDK that provides all of the components identified in one of the rows of Table 4. All components in a row shallbe supplied.

1 The inclusion of these classes is motivated as follows:

Class A exists to allow organizations to demonstrate the capability to produce conformant records (e.g. for a card issuance system)

- Class B exists to allow organizations to demonstrate the capability to find the bounding circle / bounding box in an
 image, i.e. to do primary segmentation.
- 6 Class C exists to allow organizations to demonstrate the capability to generate all variants of the ISO/IEC 19794-6
 7 standard.
- 8 Class D exists to allow organizations to demonstrate capability to match only rectilinear images.
- 9 Class E exists to allow organizations to demonstrate segmentation and matching capability on all images.
 - Q These classes of participation are likely to be revised in subsequent drafts. How?

11 6.6. Segmentation on uncompressed data

12 All polar segmentation steps will be performed on uncompressed data. This mimics the scenario in which the image

processing steps need to instantiate the standard records are conducted at time of enrollment either in the sensor, or on a local computer, before transmission or commitment to an identity credential.

15 6.7. Decompressed data passed to the SDK

16 NIST will not pass JPEG or JPEG 2000 encoded data to the SDK functions. Instead, we will apply compression and then

decompress the data before passing the record to the function. This avoids the need for the SDK to call decompression routines.

19

Q Does the SDK need any information about the compressed imagery? Would, for example, a segmentation algorithm vary its function on, say, the basis of input file size?

20 6.8. Feature extraction on compressed data

Template generation will usually be performed on previously compressed data. This mimics the operational scenario in which compressed imagery is exchanged (on a smartcard, or over a network) and features are extracted by the recipient.

23 Compression ratios from 1:1 (uncompressed) to perhaps 1:200 will be applied.

1 **6.9.** Compression metrics

- JPEG implementations accept a quality parameter that controls the quantization of the DCT coefficients specified in
 ISO/IEC 10918. The quantitative effect of this parameter is not standardized, and may vary between implementations.
- 4 ISO/IEC 15444 JPEG 2000 implementations are parameterized by a target value, such as the number of bits per pixel.
- Some input images are more compressible than others. For example, a motion-blurred image will compress well, as will
 images with large areas of smooth skin content.
- 7 NIST intends to establish operational guidance on the application of compression. NIST intends to quantify compression
- 8 damage in terms of, at least, PSNR as the independent variable. However, compression software does not take this an
- 9 input parameter and thus practical implementation would require iterative schemes to achieve a desired entropy or PSNR
- value. This may be tenable if computational expense is not prohibitive. NIST intends to measure and report compressiontimes.

12 6.10. Provision of sensor information to SDKs

- 13 NIST will provide the manufacturer and model information to the image processing functions provided in the SDK. This
- allows the implementation to tailor its algorithms to known properties of the sensor (e.g. spectral properties of the illuminant)
- 15 illuminant).
- 16 NIST is not currently in possession of detailed sensor specifications, and it is therefore incumbent on participants to
- 17 acquire such information and to use it as they see fit.

18 **6.11.** Repetition of the ICE 06 evaluation

- 19 IREX 2008 may include, as one slice of its scope, a repetition of the ICE 06 trial⁴. This arises because matching of
- rectilinear ICE 06 images, compressed at an initial ratio of 1:1, is logically an approximate repetition of the ICE 06 trial.
 This is approximate because the SDK protocol here differs from that used in ICE.

22 6.12. Verification performance

- 23 The test will embed pure 1:1 template comparisons. It will not enroll a population and thus will not support
- 24 verification systems that run in an identification mode,
- 25 cohort normalization techniques⁵, and
- 26 1:N testing, which is not needed to study the format and compression effects targeted by this study.

27 6.13. Phased testing

Q

In an attempt to support SC37 timelines, NIST will depart from its usual practice (e.g. MINEX II, ELFT I) and conduct this test in just a single phase. This means the results of testing will be published sometime after the implementations are received, without any interim disclosure of results to the supplier, and without any resubmission of SDKs to NIST. We will nevertheless communicate aberrant behavior to suppliers - for example, if generated records are non-conformant to the ISO standard, or if the SDK is not conformant to our API.

Should NIST adopt a two-phase approach? This would support an improvement loop: interim feedback from NIST – supplier development – SDK resubmission.

1 6.14. Open-source code for ISO/IEC 19794-6

As part of NIST's Biometric Data Interchange (BIOMDI) software distribution⁶, NIST has exposed its open-source "C" code project for the reading, writing and validation of ISO/IEC 19794-6 records. The software is freely distributable. It is under formal version control and subscribers to the server are automatically informed of development activities.

5 6.15. Standards-based evaluation

6 The IREX evaluation is an interoperability test. As such, NIST intends to conduct it in conformance to the ISO/IEC FDIS

7 19795-4 — Biometric Performance Testing and Reporting — Part 4: Interoperability Performance Testing standard. This

8 standard establishes requirements for the execution of multi-supplier biometric interoperability tests, primarily those

9 evaluating standardized interchange formats such as ISO/IEC 19794-x.

10 **7.** Data structures

11 **7.1. Overview**

12 Much of IREX 08 will involve the generation or use of the data structures defined in the following two subsections. The

13 first is the ISO/IEC 19794-6:2005 record. The second is the proposed unsegmented polar augmentation of that record. In

both cases, the values in certain fields have been constrained to specific values. For example, the number of images is

15 always 1, and all image data is in uncompressed form.

16 **7.2.** Identifying the records of the standard

The ISO/IEC 19794-6 standard [STD05] required all iris biometric data blocks (BDBs) to be wrapped in CBEFF headers.

18 CBEFF, published as ISO/IEC 19785-1, advances abstract fields and values for encapsulating, signing and encrypting BDBs.

19 For IREX 08, CBEFF headers shall be absent.

20 In ISO/IEC 19794-6:2005, the only means of differentiating rectilinear records from polar records is via the CBEFF fromat

21 type, as shown in Table 5. However, CBEFF encapsulation is now optional in the draft revision [N2226] and there is no

22 normative mechanism for determining the encoding. This presents a bug worthy of WG3 attention.

8 8.3. Software and Documentation

9 8.3.1. SDK Library and Platform Requirements

Participants shall provide NIST with binary code only (i.e. no source code) – supporting files such as header (".h") files

- 21 The cygwin⁷ layer running on a Windows Server 2003 OS.
- 22 RedHat Linux Enterprise 4 or 5 platforms.
- 23 Both will use GNU's gcc compiler, version 3.3.3. These use libc. The link command might be:
- 24 gcc -o irextest irextest.c -L. -lIREX

⁷ According to <u>http://www.cygwin.com/</u> is a Linux-like environment for Windows. It consists of two parts: A DLL (cygwin1.dll) which acts as a Linux API emulation layer providing substantial Linux API functionality; a collection of tools which provide Linux look and feel.

- 1 Participants are required to provide their library in a format that is linkable using GCC with the NIST test driver, which is
- 2 compiled with GCC. All compilation and testing will be performed on x86 platforms. Thus, participants are strongly
- 3 advised to verify library-level compatibility with GCC (on an equivalent platform) prior to submitting their software to
- 4 NIST to avoid linkage problems later on (e.g. symbol name and calling convention mismatches, incorrect binary file
- 5 formats, etc.).
- Dependencies on external dynamic/shared libraries such as compiler-specific development environment libraries are
 discouraged. If absolutely necessary, external libraries must be provided to NIST upon prior approval by the Test Liaison.

8 8.3.3. Installation and Usage

9 The SDK must install easily (i.e. one installation step with no participant interaction required) to be tested, and shall be 10 executable on any number of machines without requiring additional machine-specific license control procedures or 11 activation.

12 The SDK's usage shall be unlimited. The SDK shall neither implement nor enforce any usage controls or limits based on 13 licenses, execution date/time, number of executions, presence of temporary files, etc.

14 It is recommended that the SDK be installable using simple file copy methods, and not require the use of a separate 15 installation program. Contact the Test Liaison for prior approval if an installation program is absolutely necessary.

16 **8.3.4.** Documentation

Participants shall provide complete documentation of the SDK and detail any additional functionality or behavior beyond
 that specified here. The documentation must define all error and warning codes (see 8.4.3).

19 8.3.5. Modes of operation

Individual SDKs provided shall not include multiple "modes" of operation, or algorithm variations. No switches or options
 will be tolerated within one library. For example, the use of two different "coders" by an iris feature extractor must be
 split across two separate SDK libraries, and two separate submissions.

23 8.4. Runtime behavior

24 **8.4.1.** Speed

- 25 The following limits are instituted to constrain NIST's total IREX computational workload.
- 26 The mean template match operation shall not exceed 10 milliseconds.
- 27 The mean template creation operation shall not exceed 1.2 seconds (using a 2GHz Pentium IV).
- 28 The mean iris segmentation operation (e.g. polar) shall not exceed 1.2 seconds (using a 2GHz Pentium IV).
- 29

d Should these times be lowered (for operational relevance) or raised (for improved algorithmic function)?

30 8.4.2. Interactive behavior

The SDK will be tested in non-interactive "batch" mode (i.e. without terminal support). Thus, the submitted library shall not use any interactive functions such as graphical user interface (GUI) calls, or any other calls which require terminal interaction e.g. reads from "standard input".

34 8.4.3. Error codes and status messages

35 The SDK will be tested in non-interactive "batch" mode (i.e. without terminal support). Thus, the submitted library shall

run quietly, i.e. it should not write messages to "standard error" and shall not write to "standard output". Instead, the
 SDK shall conform to the error notification procedures of Annex A.

1 **8.4.4.** External communication

- 2 Processes running on NIST hosts shall not side-effect the runtime environment in any manner, except for memory
- 3 allocation and release. Implementations shall not write any data to external resource (e.g. server, file, connection, or
- 4 other process), nor read from such. If detected, NIST will cease evaluation, inform the provider and document evidence of
- 5 such in published reports.

6 8.4.5. Stateful behavior

- All components in this test shall be stateless. This applies to segmentation, feature extraction and matching. Thus the all
 functions should give identical output, for a given input, independent of the runtime history. NIST will institute
- 9 appropriate tests to detect stateful behavior. If detected, NIST will
- 10 cease evaluation of all implementations from the supplier,
- 11 inform the supplier, and
- 12 publicly report the behavior, with attribution and documentary evidence.

9. NIST conversion of Rectilinear to Polar Coordinates

Q Rather than have suppliers execute the conversion of rectilinear to polar format, should NIST instead require the supplier to return the parameters of the transform with which NIST would then execute it.?

NIST's transformation code would include neither boundary detection nor segmentation code.
