

## **National Initiative for Cybersecurity Education K-12 Working Group Charter**

The National Institute of Standards and Technology (NIST) has been designated as the lead for the National Initiative for Cybersecurity Education (NICE). The mission of NICE is to foster, energize, and promote a robust network and an integrated ecosystem of cybersecurity education, training, and workforce development.

### **Article I: Organization**

**Organization Name:** NICE K-12 Working Group

### **Article II: Purpose**

2.1 To provide a mechanism in which ***public and private sector participants*** can develop concepts, design strategies, and pursue actions that advance cybersecurity education, training, and workforce development.

2.2 Provide a forum for the exchange of ideas among interested practitioners, researchers, developers, and students in the changing field of cybersecurity. In support of this forum, the K-12 sub-group focuses on educational aspects of current, emerging, and at times novel K-12 cybersecurity paradigms, frameworks and standards and addresses those aspects through an open process for multiple stakeholders to provide input to coordinate, revise, accelerate and harmonize national K-12 cybersecurity education initiatives.

2.3 Foster activities for advancing K-12 cybersecurity education and highlight strategies that address the goals of the NICE Strategic Plan.

### **Article III: Organizational Structure**

3.1 **The NICE Public Working Group organizational structure** consists of the Executive Committee- (Co-Chairs from Academia, Industry, and Government), the Leadership Team consisting of the NICE Working Group Co-Chairs, Subgroup Co-Chairs, and Ex-officio Representative.

3.2 **The NICE K-12 Working Group organizational structure consists** of two or more Co-chairs and sub-group members.

3.3 **Terms of Leadership:** Co-chairs will serve 2 year terms with a possibility of renewal for an additional 2 years. Subgroup members will serve 2 year terms with a possibility of renewal for an additional 2 years.

### **Article IV: Operation**

4.1 **Co-Chairs Meetings:** Co-Chairs will take part in the larger working group meetings held monthly or bi-monthly.

4.2 **K-12 Working Group Members:** will convene/participate once or twice per month.

- 5.2.4 In consultation with the NICE K-12 WG Co-Chairs, review, deliberate on, and revise or adopt any recommendations of subgroups prior to forwarding or presenting to the full NICEWG membership.

- 5.3.2 Attend NICE K-12 Project meetings as necessary for providing project status updates, obtaining input, or presenting final results

- 5.3.5 Participate in presentation of recommendations to NICEWG when invited
