***Public-private partnerships that co-invest in developing world-leading advanced manufacturing technologies and capabilities***

- **Has a clearly defined focus**
- **Provides needed state-of-the-art facilities**
- **Enables collaborative, mostly pre-competitive development of promising technologies**
- **Strengthens and leverages regional resources**
- **Carries out workforce development education and training**
- **Increases non-Federal R&D investment**
- **Promotes the creation of a stable and sustainable innovation ecosystem**

# Funding Availability and Award Period

---

- **Period of Performance**
  - 5 year award for up to \$70 million
  - An additional 2-year possible renewal based on:
    - Availability of funds
    - Required approval of spend plans
  
- **Institutes will leverage non-federal sources of support to promote a stable and sustainable business model without the need for long-term NIST NNMI Federal funding**
  - NNMI Institutes can always apply for non-duplicative Federal Funding from other sources

# Startup Phase and Multiyear Funding with Renewal Option

---

## ▪ Startup Phase

- Initial period of the Institute shall be considered the startup phase
- Part of the initial 5 year award, anticipated to take up to 12 months
- Will account for the first increment of funds
- Ongoing Institute Operations begin once successfully completed

## ▪ Multiyear Funding Policy

- Funding is only available for the 1st year and then incrementally thereafter

## ▪ Two Year Renewal

- Awards expected for up to 5 years, with a possibility for 2 additional years at the end of the initial award period on a noncompetitive basis

# Eligibility - Who, Where, Funding?

---

## ▪ Who

- Eligible Applicants & Subrecipients
  - State, local, or tribal Governments;
  - Institutions of Higher Education (IHE);
  - non-profit and for-profit organizations,
  - organized and operated in the U.S. with majority domestic ownership or control
- Ineligible entities
  - Pre-Award - may be included as an unfunded participant
  - Post-Award, may be included on a case-by-case basis

## ▪ Where


- Here in the U.S. unless there is compelling reason

## ▪ Cost Share

- At least 1:1 match of Federal Funding annually

# Two-Step Application Process

---

## *Step 1: Pre-Applications*

- **Submitted through Grants.gov only**
- **Due by April 20, 2016, 11:59 PM ET**
- **One Pre-Application per applicant**
  - Applicants may only lead one proposal; however, they may participate as a subrecipient, contractor, or unfunded collaborator on others
- **Selected applicants will be invited to submit a Full Application on or about May 23, 2016**

## Two-Step Application Process (cont'd)

---

### ***Step 2: Full Applications***

- **ONLY selected Pre-Applicants will be invited by NIST to submit a Full Application** (*Full Applications submitted by applicants who were not selected by NIST within the Pre-Application phase, and Full Applications submitted by applicants who did not submit a Pre-Application, will be returned without review.*)
- **Submitted through Grants.gov only**
- **Due by July 22, 2016, 11:59 PM ET**
- **Changes in applicant, requested budget and reteaming are permitted prior to submission of the Full Application**
  - Change lead entity, revise the requested budget amount, or reteam (subrecipients, contractors or contributors to the Institute)
  - Applicants must provide written notice of its intent in advance of the Full Application due date by mail or email to [jessica.strickler@nist.gov](mailto:jessica.strickler@nist.gov)

*Full Applications must stand on their own and should not rely on information presented within a Pre-Application*

## Cost Sharing?

- **At least 50% of the Institute funding must come from non-Federal cost share annually**
  - In-kind and cash contributions
  - It must be tangible, meaningful, and substantial enough in the aggregate to signal strong and committed industry, regional, and local partnership.
  - Weighted preference will be given to applications that provide greater than 1:1 cost share of funds in the proposed budget.
- **Each type of cost-share has its own merits and uncertainties**
- **Resources**
  - [Cost Share Components and Contributors](#) – suggested template that could be used to document both anticipated and committed cost share
  - [Guidance on Merits and Uncertainties of Cost Share](#) - provides guidance of the various risks associated with different types of cost share. These risks may affect the cost share assessment. Intended to assist applicants for their own analysis of cost share.

## Common Questions (cont'd)

---

### Ineligible Topics and Alignment with Other NNMI Institutes?

- **Any area of advanced manufacturing will be considered so long as it does not duplicate or overlap the technical scope and programs:**
  - Of other federally funded Institutes within the National Network for Manufacturing Innovation (NNMI), or
  - The technical focus area(s) that are identified within any in-progress Institute(s) funding opportunity announcement led by another federal agency

## Common Questions (cont'd)

---

### Ineligible Topics and Alignment with Other NNMI Institutes (cont'd)?

- **Request for Information (RFI's) are underway by DoD and/or DOE to help identify the topics for future NNMI Institutes**
  - These topics identified are not considered “ineligible topics”
  - One or more of these topics may be the subject(s) of a soon to be announced competition
- **Should a new funding opportunity be announced while this competition is in progress, applications within these areas may be considered “ineligible”. Applicants will be notified ASAP so that they have time to re-direct their efforts if they so choose**

## Common Questions (cont'd)

---

### What is meant by the phrase “Benefits that Extend Beyond the Direct Return to Participants”?

- **May fall across a range of categories including, but not limited to:**
  - scientific and technical
  - economic,
  - education and training,
  - national security,
  - Jobs (specifically mentioned in RAMI – Section (d).(4).(E))
  
- **FFO: Pre-Application criterion #1 and associated sub-criteria 1.a and 1.b (Section V, pgs. 35-37 of the FFO) and Full Application criterion 1.b (Section V, pgs. 42-43)**

## Common Questions (cont'd)

---

### Is There an Upper Limit to Our First Year Funding Request?

- **No, however, there is likely to be a practical limit**
  - Based on the experience of the other NNMI Institutes the needed start-up time and money varies depending on the readiness level of the lead organization
  
- **The proposed budget should be appropriate for completing Institute startup and matched to the lead's pre-existing level of readiness**
  - By matching budget to the readiness level for the startup phase, it preserves federal and cost sharing funds for the Institute's ongoing operations.
  - A notional range of Federal funds that may be needed for startup may be \$1 million to \$8 million.

# First full period of operations (could be greater than 12 months)

- **Startup Phase, 1st performance period, may take up to 12 calendar months depending on the applicant's pre-existing level of readiness**
- **Ongoing Institute Operations begin in 2nd performance period, which may be 12 months or more, depending on the duration of Period 1**

## Common Questions (cont'd)

---

### How Should I Include Foreign or Federal (& FFRDC) Participation?

- **Pre-Award.** Foreign organizations (if organized and operated in the U.S.), Federal Labs, and FFRDCs may be included in a team or consortium as an unfunded collaborator
  
- **Post-Award.**
  - On a case-by-case basis majority foreign-owned or foreign-controlled entities organized and operated in the U.S. may be allowed as subrecipients or contractors based on the unique and specific needs of the Institute.
  - FFRDCs may be allowed as subrecipients or contractors, based on the unique and specific needs of the Institute, subject to the provisions of FAR 35.017-1.

## Common Questions (cont'd)

---

### Cooperative Agreement - What is Meant by “Substantial Involvement”?

- **Term applies to Cooperative Agreements and relationship between the Federal sponsor and the award recipient**
  
- **In NNMI, “Substantial Involvement” includes:**
  - NIST collaborating with the Institute leadership:
    - NIST Grants team
    - NIST Advanced Manufacturing Office
    - NIST technical staff
  - Envisioned collaborations and partnerships that develop between the funded Institute and federal agencies, including NIST

## Common Questions (cont'd)

---

### Are Multiple Proposals in the Same Topic Needed before NIST will Determine the Topic is Appropriate for a NNMI Institute?

- No. The NIST open-topic competition uses evaluation criteria that are agnostic to any one specific focus area or topic. Thus for an application to have merit, it must stand on its own against those criteria.

## Common Questions (cont'd)

---

### Am I required to establish a new organization to propose and operate a NNMI Institute?

- **No. The applicant must present their vision of how the Institute should be optimally structured and operate.**
- **It is important for the applicant to demonstrate**  
*“How the Institute and organization will be an independent, neutral, and nonbiased entity able to coordinate and convene a broad range of stakeholders, including small and medium-sized enterprises (SMEs),...”*

# Pre-Application Package

---

- **SF-424 Application Form**
  - Signed by an authorized representative of the institute
- **SF-424A, Budget Information - Non-Construction Programs**
  - A preliminary Rough Order of Magnitude (ROM) budget reflecting the anticipated expenses for an Institute award up to 5 years, considering all potential cost increases, including cost of living adjustments
- **Executive Summary / Abstract of Proposed Effort**
- **An Abbreviated Project Narrative**
  - A typed document of no more than 20 pages

- Evaluation & Selection in May 2016

### Notifications

- On or about 5/23/2016
- Invitation to submit Full Application OR debriefing offered

## Step 2: Full Applications

### Full Applications

- Due by 7/22/2016
- Reteaming in Advance
- Evaluation July-Sept. 2016

### Interviews & Negotiation

- Interviews in early Oct. 2016
- Negotiations likely Sept.-Dec. 2016
- Selection to follow

### Awards-Startup

- Announcement & Notifications in Q1 CY 2017
- Institute Startup in Q1 CY 2017
