Government Requirements

TITLE: Procurement of two Frequency-Stabilized Helium-Neon Lasers

LAB REQUESTING SERVICE: Material Measurement Laboratory, Chemical Sciences Division, Gas Sensing and Metrology Group

I. BACKGROUND INFORMATION

The National Institute of Standards and Technologies Chemical Sciences Division Gas Sensing Metrology Group develops new methodologies and instrumentation for the measurement of gas phase molecular absorption features. These methodologies and instrumentation include novel spectrometers that offer ultra-high sensitivity to trace gases, high fidelity and reproducibility in measured concentrations, and precision gas metrology. In order to obtain high-quality reference data on molecular absorption line centers and line shapes under a variety of pressure, temperature, and collisional partners, NIST requires stabilized optical resonators to perform cavity ring-down spectroscopy. The optical resonators are routinely stabilized to narrow line width Helium-Neon (HeNe) lasers.

II. SCOPE OF WORK

NIST routinely performs cavity ring-down spectroscopy at a variety of wavelengths throughout the visible, near-infrared, and mid-infrared. When the optical cavity, or resonator, is frequency stabilized, measurements can be done with high fidelity over minutes, hours, and even days. In order to implement frequency-stabilized cavity ring-down spectroscopy for several planned and ongoing laboratory investigations, NIST requires fiber-coupled frequency-stabilized HeNe lasers with narrow continuous-wave (CW) line width.

III. SPECIFICATIONS

The Contractor shall provide two (2) frequency-stabilized HeNe lasers that meet the following minimum technical requirements.

System Requirements:

- Laser shall have continuous-wave (CW) output at the 633 nm red HeNe line (i.e., and output wavelength of 633 nm)
- Laser output shall be single mode and of nominally greater than or equal to 1 mW power
- Laser frequency stability shall be less than or equal to 100 kHz at a 10 ms measurement time
- Laser frequency stability shall be less than or equal to 100 kHz at a 1 minute measurement time when located in a temperature stabilized room with room temperature (70 degrees) variations less than or equal to 0.5 °C
- Laser output shall be linearly polarized and stabilized
- Laser output shall be fiber coupled into a polarization-maintaining single-mode fiber-optic cable of at least 2 m in length
- Fiber optic cable shall have FC/APC connectors on both ends
- Fiber optical laser output assembly shall also include a Faraday isolator

- Laser output shall have root-mean-square (rms) intensity fluctuations less than or equal to 0.5% measured from 30 Hz to 10 MHz
- Laser controller and laser head shall be powered using a standard U.S. wall outlet and contractor-supplied cables
- Operation manual and any applicable performance and test data and certification

Warranty:

The Contractor shall provide, at a minimum, a one year warranty for the equipment. The warranty shall cover all parts, labor and travel. The warranty shall commence upon successful completion of delivery and Government acceptance. Government acceptance will be concluded within 7 days of delivery.

IV. PLACE OF PERFORMANCE

Installation of the instrument shall be accomplished by the NIST Technical Point of Contact at NIST, Gaithersburg, Maryland. Normal duty hours are Monday through Friday, 9:00 a.m. to 5:00 p.m. with the exception of Federal holidays.

SOLICITATION INFO

This procurement is being issued pursuant to the authority of FAR Part 13 – Simplified Acquisition Procedures.

Award will be made to the Offeror that provides the lowest priced, technically acceptable quote. Technical acceptability means that the quote meets all of the stated minimum specifications. The Government will evaluate information based on the following evaluation Criteria:

- 1) Technical Capability factor "Meeting the Requirement," and
- 2) Price.

Technical Capability: Evaluation of Technical Capability will be based on the information provided in the quotation.

Price: The Government will evaluate price for reasonableness.

All Offerors shall submit the following:

- 1) A firm fixed price quotation meeting all the requirements.
- 2) A description and/or product literature which clearly demonstrates that all the requirements of the statement of work have been met. Offeror shall include the manufacturer or brand name, make and model of the products, manufacturer sales literature or other product literature which addresses all minimum specifications, and clearly documents that the offered product meets the minimum specifications required.
- 3) Description of commercial warranty;
- 4) Confirmation of the Contractor's concurrence with the following:
 - a. The Government's terms and conditions, identified herein, shall govern the pursuant purchase order.
 - b. In the event of a conflict between the Government's terms and conditions and the Contractor's terms and conditions, the Government's terms and conditions identified herein, shall prevail.
 - c. Upon submission of a quotation, the Contractor accepts all the terms and conditions set forth by the Government.

``Immediate owner`` means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

``Inverted domestic corporation,`` means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

``Manufactured end product`` means any end product in product and service codes (PSCs) 1000-9999, except

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

``Place of manufacture`` means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

``Restricted business operations`` means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate-

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

Sensitive technology

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically-

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

Such disclosure shall include a description of the actions the contractor has taken or proposes to take in order to avoid, neutralize, or mitigate any resulting conflict of interest.

(d) Remedies. The Contracting Officer may terminate this contract for convenience, in whole or in part, if the Contracting Officer deems such termination necessary to avoid, neutralize or mitigate an actual or apparent organizational conflict of interest. If the contractor fails to disclose facts pertaining to the existence of a potential or actual organizational conflict of interest or misrepresents relevant information to the Contracting Officer, the Government may terminate the contract for default, suspend or debar the contractor from Government contracting, or pursue such other remedies as may be permitted by law or this contract.

(e) Subcontracts. The contractor shall include a clause substantially similar to this clause, including paragraphs (f) and (g), in any subcontract or consultant agreement at any tier expected to exceed the simplified acquisition threshold. The terms "contract," "contractor," and "Contracting Officer" shall be appropriately modified to preserve the Government's rights.

(f) Prime Contractor Responsibilities. The contractor shall obtain from its subcontractors or consultants the disclosure required in FAR Part 9.507-1, and shall determine in writing whether the interests disclosed present an actual, or significant potential for, an organizational conflict of interest. The contractor shall identify and avoid, neutralize, or mitigate any subcontractor organizational conflict prior to award of the contract to the satisfaction of the Contracting Officer. If the subcontractor's organizational conflict cannot be avoided, neutralized, or mitigated, the contractor must obtain the written approval of the Contracting Officer prior to entering into the subcontract. If the contractor becomes aware of a subcontractor's potential or actual organizational conflict of interest after contract award, the contractor agrees that the Contractor may be required to eliminate the subcontractor from its team, at the contractor's own risk.

(g) Waiver. The parties recognize that this clause has potential effects which will survive the performance of this contract and that it is impossible to foresee each circumstance to which it might be applied in the future. Accordingly, the contractor may at any time seek a waiver from the Head of the Contracting Activity by submitting such waiver request to the Contracting Officer, including a full written description of the requested waiver and the reasons in support thereof.
