. 1 NIST REQUIREMENTS DOCUMENT

### **NIST Requirements Document**

High-speed, Single Polarization, 1x8 Lithium Niobate Optical Switch

#### **I. BACKGROUND**

The National Institute of Standards and Technology (NIST) Physical Measurements Laboratory (PML), Thermodynamic Metrology Group's mission is to realize, maintain and disseminate temperature, pressure, vacuum and humidity standards, calibrate and develop sensors. In order to meet his mission a high speed optical switch is a critical component of a new photonic sensor interrogation system being built in the lab that would enable real-time probing of multiple sensors to enable spatial and temporal mapping of thermal and pressure gradients.

#### **II. SCOPE:**

The high speed optical switches are components of high speed photonics sensor interrogation system to allow the interrogation of up to 8 photonic sensors with a single laser and detector using a nanosecond (10-100 ns) switch. The operating wavelength range is 1500 nm to 1600 nm.

#### **III. MINIMUM SPECIFICATIONS:**

The Contractor shall provide two (2) 1x8 fast Lithium Niobate Optical (LiNbO3) based bi-directional switches. The LiNbO3 shall meet the following minimum specifications:

1. Operating wavelength range shall be between 1520 through 1570 nm.
2. Insertion loss shall be < 5 dB to desired output port.
3. Switch crosstalk shall be < 18 dB
4. Switching speed shall be < 10-100 nano seconds.
5. Input/output fiber(s) shall be PM (Polarization Maintaining)
6. Optical Connectors shall be FC/UPC (slow axis aligned to the narrow key)

#### **I. DELIVERY**

Delivery shall be FOB DESTINATION and shall occur not later than thirty (30) days ARO.

#### **II. TESTING/ INSPECTION/ ACCEPTANCE**

The Government will test, inspect, and accept the equipment onsite within ten (10) business days of the receipt of the optical switching unit. The tests shall be conducted using an oscilloscope to ensure the switch meets all the switching time, loss and cross-talk specifications in the minimum specifications section above. The Government will accept a switch that passes all tests for meeting the minimum specifications listed above.
