Request for Information Timelines

- **The Request for Information (RFI) was published in the Federal Business Opportunities (FBO) on Thursday, September 29.**
- **One amendment to the RFI, amending the date and time of the workshop to October 14, 9:30am through 12:00pm, was posted in FBO on Friday, September 30.**
- **Questions to the requirements of the RFI were due no later than 12:00pm, October 10. (The questions and answers have been provided with the agenda).**



Request for Information Timelines

- **Interested firms should submit a white paper, not to exceed 5 pages to the Contracting Officer (Shelby Buford, Jr.) by noon EST, October 27. Submissions are to be in both hardcopy (three copies) and in electronic form. (To ensure proper handling of sensitive corporate information, all proprietary information should be appropriately labeled). Email submissions will not be accepted.**
- **One-on-One meetings with selected firms may follow the review of the five page white paper. The purpose of these meetings will be to gain further insight into the state of the market and how firms intend on meeting the new requirements within the necessary time frame.**
- **All firms are reminded that the Government is not under any obligation to take any further action with any party as result of this Market Research Effort.**
