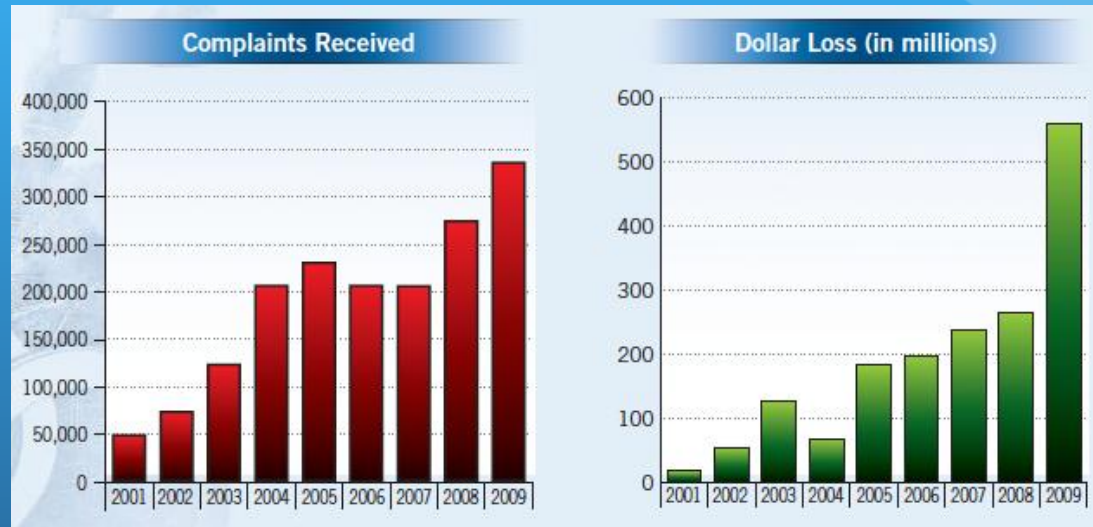

A Snapshot of Cybercrime in America

Complaints
on the rise
668%



- The cost of attack is relatively low for criminals, and the payoff is high.
- Cybercrimes are growing rapidly in terms of scope and sophistication.
- The dollar loss from all cases of crime referred to law enforcement totaled \$559.7 million, a 112% increase from \$264.6 million in 2008.

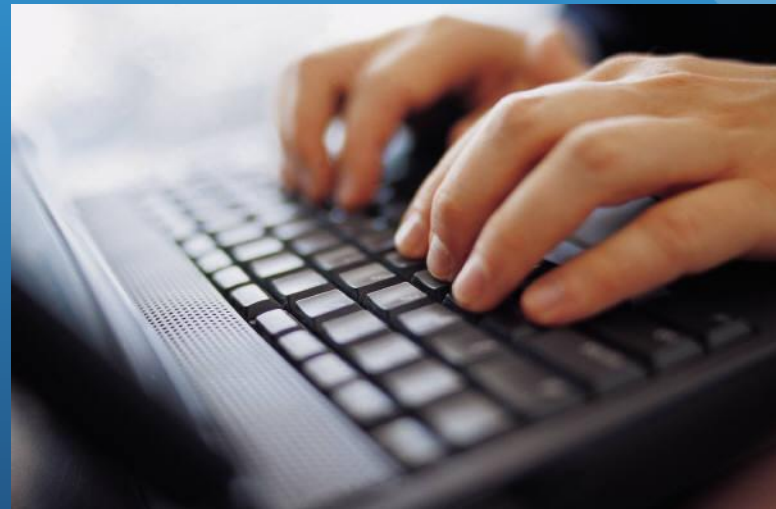

Policy Workgroup

- The Policy Workgroup is focused on city, state and federal cyber security policies. They work to understand the benefits to both business and individuals and to influence adoption of policies for the benefit of the county residents. They also work with local organizations to foster internal cyber security policies that protect businesses.
- Deliverables
 - Research best practices for workplace policy
 - Research effectiveness of state laws

Awareness Workgroup

- The Awareness Workgroup is focused on increased visibility of the National “Stop.Think.Connect.” Message.
- Deliverables
 - Billboards, buses and bathrooms campaign
 - In cooperation with NCSA and private partner
 - Spread the STOP. THINK. CONNECT message
 - Smart phone safety campaign countywide
 - In cooperation with University of Michigan and private partners
 - Distribute posters, top tips

Education Workgroup

- The focus of the Education Workgroup is to foster general and curriculum-based learning for all digital citizens. This includes the general public (individuals and organizations), formal schools (K-12, university, adult continuing ed.) and seniors. They will take responsibility for content on the www.washtenawcybercoalition.org site.
- Deliverables:
 - Create and maintain local website
 - Link the community to area experts with speaker list
 - Bring nationally recognized curriculum into classrooms, senior centers, workplaces

Crime Prevention (Formerly Law Enforcement)

- The Crime Prevention Workgroup is focused on educating small business owners to help prevent them from becoming victims of cyber crime.
- Deliverable
 - Create a training seminar for small businesses
 - Working with the Chamber of Commerce, educate small business owners on how to stay safe online
 - Partner with United Way “211” and FBI for cyber crime reporting

What is Working?

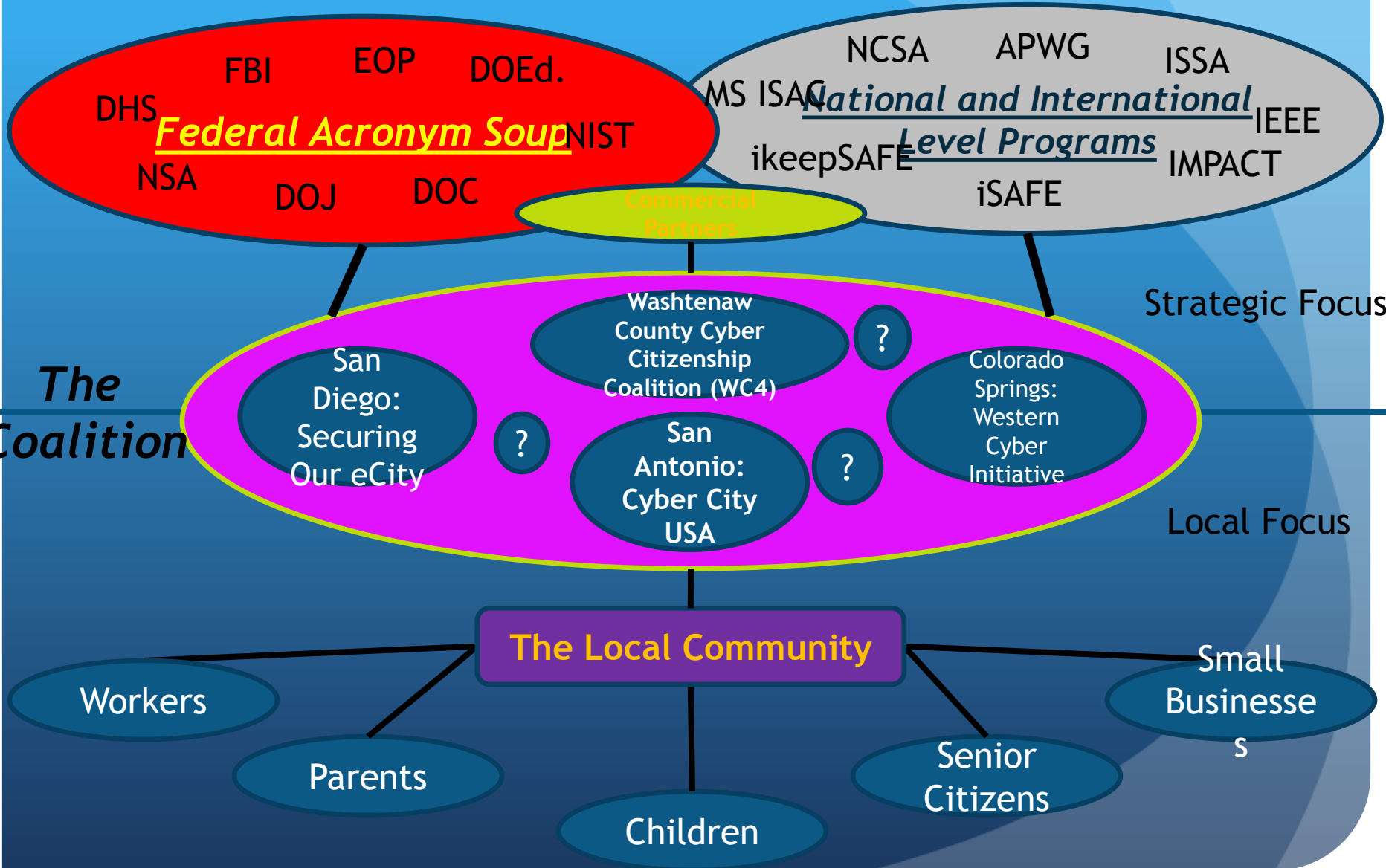
- Broad local participation
