Request for Information, "Federal Register", Volume 86, Number 114, Wednesday, June 16, 2021 from National Institute of Standards and Technology, Docket Number 21068-0123

Regarding: "PROMOTING ACCESS TO VOTING", "Information to barriers to private and independent voting for people with disabilities."

First, in the process, to providing information to support "Ensuring Equal Access for Voters with Disabilities" from Section 7 of Executive Order 14019 I did not have enough time to fully elaborate with a "Comment containing references, studies, research, and other empirical data".

That is the first constraint, that I have encountered in submitting a request for Information regarding the rights of persons to vote.

Next, as is stated on page 32027 of "Federal Register", Volume 86, Number 114 from Wednesday, June 16, 2021, "The following statements are not intended to limit the topics that may be addressed", I recommend and request that this process of "Request for Information" regarding the subject of "Ensuring Equal Access For Voters" be restated, or reissued as a "Request for Comment" so that increased promotion of comment might be possible; More time is available for persons to access the opportunity to comment might be possible; More time is available to promote the "Call to Comment" might be possible; And more time to provide for "Comments containing references, studies, research, and other empirical data" might also be possible to increase the supplement of collective information that has been asserted from individuals and groups to comment with regard to the process and right to have Equal Justice Under Law for the right to vote in the United States of America.

In the understanding that I did not have enough time to provide all of the research and study that I have pertaining to this particular subject I am going to restate each question and provide a short form answer to each of the questions pertaining to, "Promoting Access to Voting", and "Ensuring Equal Access for Voters With Disabilities.

"1. Describe concerns regarding accessing the right to vote privately and independently for people with disabilities."

The following issues are some of the "concerns regarding accessing the right to vote privately and independently for people with disabilities", Transportation to Voting

Locations is a concern regarding accessing the right to vote privately and independently for people with disabilities.

Misinformation and Disinformation is another "concern regarding accessing the right to vote privately and independently for people with disabilities", All people have the right to make an informed choice from truthful information provided.

Voter Suppression and Voter Intimidation are "concerns regarding accessing the right to vote privately and independently for people with disabilities", people should have the "least restrictive environment and process to safely access and assert their choice without obstruction" at Official locations designated for voting.

Intentional removal of access through Federal and State legislative repeals are, "concerns regarding accessing the right to vote privately and independently for people with disabilities." Do the repeals of State and Federal legislations that have enabled voters the "least restrictive environment and process" hinder in implementation, effect, and process of effect the action of the ability for individuals to assert their personal will of liberty and right of freedom?

Accessible access for People with Disabilities according to the Americans With Disability Act to ensure disabled persons right without harassment and intimidation for specific disclosure of their disability when not pertinent to the direct function of the action to vote impair or impend on their individual rights as persons to assert their vote is, "concern regarding accessing the right to vote privately and independently for people with disabilities".

Health requirements that support the well being, health and "Cause No Harm", to Persons with Disabilities is and should be of immediate "concern regarding accessing the right to vote privately and independently for people with disabilities". If a person with a disability has a very restrictive environment, instead of "the least restrictive environment" as stated in the Americans With Disabilities Act regarding the act and function of "Access" for people with impairments visible or not visible that does not allow to attend to health care needs that may be immediate such as waste elimination from the body; accessing food and water to take medications; and other conditions that may not exactly be predictable in the time or circumstance in that is emergent in the process of the act to individually assert their private and personal assertion that has been relegated through the process and function of casting a ballot then that does cause personal harm that could be direct or visceral depending on the impending circumstances 'effective' in occurrence.

"2. Describe effective strategies, techniques, and technologies for addressing the barriers faced by voters with disabilities throughout the voting process."

Provide, the "least restrictive environment" for access to vote.

"3. Describe barriers that people with disabilities encounter in getting useful information about the voting process"

One of the most pertinent barriers that people with disabilities encounter in getting useful information about the voting process is misinformation; disinformation; and information that is out of context and distorted.

Several opportunities should be provided to have forms of civil, public comment and question regarding planned events where the individual right of person is subject to the right and action of voting.

"4. Describe barriers that people with disabilities encounter with ballots and getting useful information about the items on the ballots."

Assurance of personal choice, confidentiality, protection for the selection of personal choice in the least restrictive environment, Voter Intimidation, and Voter Suppression through fraud are the most pertinent barriers that hinder people from justly casting their ballots of individual choice and having the right to vote.

"5. Provide recommendations for improving voter access for people with disabilities."

I am restating what I integrated earlier in this document, "I recommend and request that this process of "Request for Information" regarding the subject of "Ensuring Equal Access For Voters" be restated, or reissued as a "Request for Comment" so that increased promotion of comment might be possible; More time is available for persons to access the opportunity to comment might be possible; More time is available to promote the "Call to Comment" might be possible; And more time to provide for "Comments containing references, studies, research, and other empirical data" might also be possible to increase the supplement of collective information that has been asserted from individuals and groups to comment with regard to the process and right to have Equal Justice Under Law for the right to vote in the United States of America.

I also recommend that the "least restrictive environments and processes" be implemented immediately to ensure just and fair "Promotion of Access to Voting".

"6. Identify what has had the most impact enabling people with disabilities to vote privately and independently."

The "least restrictive environment and process" has had the most impact enabling people with disabilities to vote privately and independently.

"7. Identify gaps that remain in making voting accessible to people with disabilities."

Provision, of the least restrictive environment and process is a barrier and multi conditional service provision gap to making voting accessible to people with disabilities.

Cyberterrorism, transportation, enough time to process and comment on processes in the process and function of voting in designated state of act as it is to function as such are all very pertinent pieces that are in the process of having the ability to access and cast an individual vote justly.

"9. Describe barriers that people with disabilities encounter in getting useful information about their eligibility to vote."

The public function of interface and availability of interface between government and it's people for the Purpose of Promotion Access to Voting is, the primary barrier for people getting useful information about their eligibility to vote.

"10. Describe barriers that people with disabilities encounter with registering to vote."

Any form of restrictive environment or process that does not allow a just, "least restrictive environment or process."

"11. Describe barriers that people with disabilities encounter using technology for the registration or voting process, whether online, in person, or via email."

The primary concern is access to the equipment, and technology to perform that function. The secondary but but pertinent concern is the act of Cyberterrorism.

"12. Describe the availability of accessible voting equipment."

Please directly refer to each, Secretary of State for that information.

"13. Describe barriers that people with disabilities encounter with voting by mail."

Several, many people have reported issues with slow delivery of mail from the US Post and have vocalized distrust, of the method, and practice of fail delivery from the US Post recently.

"14. Describe security considerations relevant to existing and potential technologies used by people with disabilities in the voting process."

Cyberterrorism and Fraud.

"15. Describe barriers that people with disabilities face at polling locations."

Forms, methods, and processes of Voter Intimidation and Suppression.

"16. Describe the accessibility of polling places."

Please contact each, Secretary of State for more information and reports regarding incidents.

"17. Identify areas where poll worker training can address barriers experienced by people with disabilities."

I have been a poll worker so my experience is relevant and pertinent. Providing the "least restrictive environment and process" and just, regulated process as instructed and trained to implement the act of public voting can definitely address barriers.

"18. Identify areas where clearer or better policies can address barriers experienced by people with disabilities."

Having more time, platform, and public interface to elaborate on said request.

"19. Describe any barriers that people with disabilities face to voting that disproportionately impact communities of color, persons who live in rural areas; and persons otherwise adversely affected by persistent poverty or inequality."

Restrictive, environments or processes "disproportionately impact communities of color, persons who live in rural areas; and persons otherwise adversely affected by persistent poverty or inequality."

"20. Of concerns and barriers noted, identify the most serious and impactful barriers faced by voters with disabilities throughout the voting process."

Unjust restrictive environments or processes are, "the most serious and impactful barriers faced by voters with disabilities throughout the voting process."

And please remove all from the over 600,000 people that passed away from COVID-19 from the voting rolls immediately.
