3 A *Discussion Draft of the Preliminary Cybersecurity Framework* for improving critical
4 infrastructure cybersecurity is now available for review. This draft is provided by the National
5 Institute of Standards and Technology (NIST) in advance of the Fourth Cybersecurity
6 Framework workshop on Sept.11-13, 2013, at the University of Texas at Dallas. Participants are
7 asked to read the Note to Reviewers and review this draft in advance of the workshop.

8

9 **Note to Reviewers**

10 If the Cybersecurity Framework is to be effective in helping to reduce cybersecurity risk to the
11 Nation’s Critical Infrastructure, it must be able to assist organizations in addressing a variety of
12 challenges. The National Institute of Standards and Technology (NIST) requests that reviewers
13 consider the following questions:

14 How can the Preliminary Framework:

- 15 • adequately define outcomes that strengthen cybersecurity and support business
16 objectives?
- 17 • enable cost-effective implementation?
- 18 • appropriately integrate cybersecurity risk into business risk?
- 19 • provide the tools for senior executives and boards of directors to understand risks and
20 mitigations at the appropriate level of detail?
- 21 • provide sufficient guidance and resources to aid businesses of all sizes while maintaining
22 flexibility?

24 Will the Discussion Draft, as presented:

- 25 • be inclusive of, and not disruptive to, effective cybersecurity practices in use today?
- 26 • enable organizations to incorporate threat information?

28 Is the Discussion Draft:

- 29 • presented at the right level of specificity?
- 30 • sufficiently addressing unique privacy and civil liberties needs for critical
31 infrastructure?

68 1.0 Framework Introduction

69 The national and economic security of the United States depends on the reliable functioning of
70 critical infrastructure. To strengthen the resilience of this infrastructure, the President issued
71 Executive Order 13636, “Improving Critical Infrastructure Cybersecurity” on February 12,
72 2013.¹ This directive calls for the development of a Cybersecurity Framework (“Framework”)
73 that provides a “prioritized, flexible, repeatable, performance-based, and cost-effective
74 approach” for assisting organizations responsible for critical infrastructure services to manage
75 cybersecurity risk.²

76 The Framework, developed in collaboration with industry, provides guidance to an organization
77 on managing cybersecurity risk, in a manner similar to financial, safety, and operational risk.³
78 The Framework is not a one-size-fits-all approach for all critical infrastructure organizations.
79 Because each organization’s risk is unique, along with their implementation of information
80 technology (IT) and operational technology (OT), the implementation of the Framework will
81 vary.

82 The focus of the Framework is to support the improvement of cybersecurity for the Nation’s
83 Critical Infrastructure using industry-known standards and best practices.⁴ The Framework
84 provides a common language and mechanism for organizations to: 1) describe current
85 cybersecurity posture; 2) describe their target state for cybersecurity; 3) identify and prioritize
86 opportunities for improvement within the context of risk management; 4) assess progress toward
87 the target state; 5) foster communications among internal and external stakeholders.

88 The Framework complements, and does not replace, an organization’s existing business or
89 cybersecurity risk management process and cybersecurity program. Rather, the organization can
90 use its current processes and leverage the framework to identify opportunities to improve an
91 organization’s cybersecurity risk management. Alternatively, an organization without an existing
92 cybersecurity program can use the Framework as a reference when establishing one.

93 1.1 Overview of the Framework

94 The Framework is composed of three parts: the Framework Core, the Framework
95 Implementation Tiers, and the Framework Profile. These components are detailed below.

- 96 • The *Framework Core* is a compilation of cybersecurity activities and references that are
97 common across critical infrastructure sectors. The Core presents standards and best
98 practices in a manner that allows for communication and risk management across the
99 organization from the senior executive level to the implementation/operations level. The

100 Framework Core consists of five Functions—Identify, Protect, Detect, Respond, Recover
101 —which can provide a high-level, strategic view of an organization’s management of
102 cybersecurity risk. The Framework then identifies underlying key Categories and
103 Subcategories for each of these Functions, and matches them with Informative
104 References such as existing standards, guidelines, and practices for each Subcategory.
105 For instance, for the “Protect” Function, categories include: Data Security; Access
106 Control; Awareness and Training; and Protective Technology. At the next level down,
107 ISO/IEC 27001 Control A.10.8.3 is an informative reference which supports the “Data
108 during transportation/transmission is protected to achieve confidentiality, integrity, and
109 availability goals” Subcategory of the “Data Security” Category in the “Protect”
110 Function.

- 111 • *Framework Implementation Tiers* (“Tiers”) demonstrate the implementation of the
112 Framework Core Functions and Categories and indicate how cybersecurity risk is
113 managed. These Tiers range from Partial (Tier 0) to Adaptive (Tier 3), with each Tier
114 building on the previous Tier.
- 115 • A *Framework Profile* (“Profile”) conveys how an organization manages cybersecurity
116 risk in each of the Framework Core Functions and Categories by identifying the
117 Subcategories that are implemented or planned for implementation. Profiles are also used
118 to identify the appropriate goals for an organization or for a critical infrastructure sector
119 and to assess progress against meeting those goals.

120 **1.2 Risk Management and the Cybersecurity Framework**

121 While not a risk management process itself, the Framework enables the integration of
122 cybersecurity risk management into the organization’s overall risk management process.⁵ The
123 Framework fosters:

- 124 • Cybersecurity risk management approaches that take into account the interaction of
125 multiple risks;
- 126 • Cybersecurity risk management approaches that address both traditional information
127 technology and operational technology (industrial control systems);
- 128 • Cybersecurity risk management practices that encompass the entire organization,
129 exposing dependencies that often exist within large, mature, and/or diverse entities, and
130 with the interaction between the entities and their partners, vendors, suppliers, and others;
- 131 • Cybersecurity risk management practices that are internalized by the organization to
132 ensure that decision making is conducted by a risk-informed process of continuous
133 improvement; and
- 134 • Cybersecurity standards that can be used to support risk management activities.

135 Within the Nation’s Critical Infrastructure, organizations vary widely in their business models,
136 risk tolerance, approaches to risk management, and effects on security, national economic
137 security, and national public health or safety. Profiles are the result of organizations, large or

138 small, implementing a cybersecurity risk management process that aligns with their business
139 mission and objectives.

140 **1.3 Document Overview**

141 The remainder of this document contains the following sections and appendices:

- 142 • Section 2 describes the Framework components: the Framework Core, the Tiers, and the
143 Profiles.
- 144 • Section 3 presents examples of how the Framework can be used.
- 145 • Section 4 discusses areas for improvement in cybersecurity standards, practices, etc.
146 identified as a result of the Framework efforts to date.
- 147 • Appendix A presents the Framework Core in a tabular format: the Functions, Categories,
148 Subcategories, and Informative References.
- 149 • Appendix B contains a methodology to protect privacy and civil liberties.
- 150 • Appendix C describes the Framework development methodology.
- 151 • Appendix D contains a glossary of selected terms.
- 152 • Appendix E lists acronyms used in this document.

154 **2.0 Framework Basics**

155 The Framework provides a common language for expressing, understanding, and managing
 156 cybersecurity risk, both internally and externally. The Framework helps identify and prioritize
 157 actions for reducing cybersecurity risk and is a tool for aligning policy, business, and
 158 technological approaches to managing that risk. Different types of entities — including
 159 individuals, organizations, and associations — can use the Framework to create one or more
 160 Profiles. These Profiles draw from the Functions, Categories, Subcategories, and Tiers.

161 **2.1 Framework Core**

162 The *Framework Core* provides references to cybersecurity activities and Informative References.
 163 The Framework Core is not a checklist of activities to perform; it presents key cybersecurity
 164 outcomes that are aligned with activities known to manage cybersecurity risk. These activities
 165 are mapped to a subset of commonly used standards and guidelines. The Framework Core
 166 comprises four types of elements—Functions, Categories, Subcategories, and Informative
 167 References—depicted in **Figure 1**:

170 The Framework Core elements work together as follows:

- 171 • **Functions** provide the highest level of structure, for organizing cybersecurity activities
172 into Categories and Subcategories. These Functions are: Identify, Protect, Detect,
173 Respond, and Recover.
- 174 • **Categories** are the subdivisions of a Function into groups of cybersecurity activities,
175 more closely tied to programmatic needs. Examples of Categories include “Asset
176 Management,” “Access Control,” and “Detection Processes.”
- 177 • **Subcategories** further subdivide a Category into high-level tactical activities to support
178 technical implementation. Examples of subcategories include “Inventory and track
179 physical devices and systems within the organization,” “Protect network integrity by
180 segregating networks/implementing enclaves (where appropriate),” and “Assess the
181 impact of detected cybersecurity events to inform response and recovery activity.”
- 182 • **Informative References** are specific sections of standards and practices common among
183 critical infrastructure sectors and illustrate a method to accomplish the activities within
184 each Subcategory. The Subcategories are derived from the Informative References. The
185 Informative References presented in the Framework Core are not exhaustive, and
186 organizations are free to implement other standards, guidelines, and practices.⁶

187 See **Appendix A** for the complete Framework Core listing. In addition, **Appendix B** provides an
188 initial methodology to address privacy and civil liberties considerations around the deployment
189 of cybersecurity activities.

190 The five Framework Core Functions defined below apply to both traditional information
191 technology and operational technology.

- 192 • **Identify** – Develop the institutional understanding of which organizational systems,
193 assets, data, and capabilities need to be protected, determine priority in light of
194 organizational mission, and establish processes to achieve risk management goals.
- 195 • **Protect** – Develop and implement the appropriate safeguards, prioritized through the
196 organization’s risk management process, to ensure delivery of critical infrastructure
197 services.
- 198 • **Detect** – Develop and implement the appropriate activities to identify the occurrence of a
199 cybersecurity event.⁷
- 200 • **Respond** – Develop and implement the appropriate activities, prioritized through the
201 organization’s risk management process (including effective planning), to take action
202 regarding a detected cybersecurity event.

- **Recover** – Develop and implement the appropriate activities, prioritized through the organization’s risk management process, to restore the appropriate capabilities that were impaired through a cybersecurity event.

2.2 Framework Implementation Tiers

The Framework Implementation Tiers (“Tiers”) reflect how an organization implements the Framework Core functions and categories and manages its risk. Section 2.3 provides additional information on how the Tiers apply to the Framework Core. The Tiers are progressive, ranging from Partial (Tier 0) to Adaptive (Tier 3), with each Tier building on the previous Tier. A Tier represents the stage of the implementation of the Framework Profile and the organization’s cybersecurity risk management process. The Tier characteristics are defined at the organizational level. These characteristics are applied to the Framework Core to determine how a category is implemented. The Tier definitions follow:

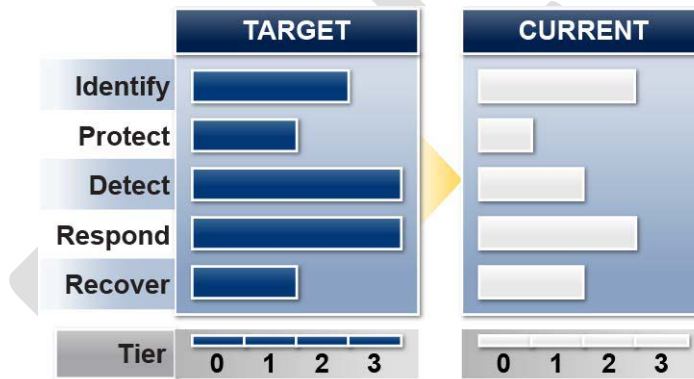
- **Tier 0: Partial** – The organization has not yet implemented a formal, threat-aware risk management process to determine a prioritized list of cybersecurity activities. The organization may implement some portions of the Framework on an irregular, case-by-case basis due to varied experience or information gained from outside sources. An organization at Tier 0 might not have the processes in place to share cybersecurity information internally between its organizational layers and might not have the processes in place to participate in coordination or collaboration with other entities.
- **Tier 1: Risk-Informed** – The organization uses a formal, threat-aware risk management process to develop a Profile of the Framework. In addition, risk-informed, management-approved processes and procedures are defined and implemented and staff has adequate resources to perform their cybersecurity duties. The organization knows its role in the larger ecosystem, but has not formalized its capabilities to interact and share information externally.
- **Tier 2: Repeatable** – The organization updates its Profile based on regular application of its risk management process to respond to a changing cybersecurity landscape. Risk-informed policies, processes, and procedures are defined, implemented as intended, and validated. The organization will also have consistent methods in place to provide updates when a risk change occurs. Personnel have adequate knowledge and skills to perform their defined roles and responsibilities. The organization understands its dependencies and partners and can consume information from these partners to help prevent and improve its reaction to events.
- **Tier 3: Adaptive** – The organization updates its Profile based on predictive indicators derived from previous and anticipated cybersecurity activities. These updates to the Profile enable the organization to actively adapt to a changing cybersecurity landscape and emerging/evolving threats. Risk-informed policies, processes, and procedures are part of the organizational culture and evolve from previous activities (and from information shared by other sources) to predict and address potential cybersecurity events. The organization manages risk and actively shares information with partners to ensure that accurate, current information is being distributed and consumed to improve cybersecurity before an event occurs.

245 Organizations should determine the desired Tiers at the Category level, ensuring that the selected
246 levels meet the organizational goals, reduce cybersecurity risk to critical infrastructure, and are
247 feasible to implement. External guidance will be helpful, such as information that could be
248 obtained from the Department of Homeland Security (DHS), an Information Sharing and
249 Analysis Center (ISAC), or other sources. The Framework implementer selects the appropriate
250 Categories and target Tiers through the use of the Profile.

251 **2.3 Framework Profile**

252 A Framework Profile (“Profile”) enables organizations to establish a roadmap for reducing
253 cybersecurity risk that is well-aligned with organization and sector goals, considers
254 legal/regulatory requirements, and reflects risk management priorities. A Framework Profile can
255 be used to describe both the current state and the desired target state of specific cybersecurity
256 activities, thus revealing gaps that should be addressed to meet cybersecurity risk management
257 objectives. **Figure 2** shows the two types of Profiles: Target and Current. The Target Profile
258 indicates the cybersecurity goal state, and the Current Profile indicates the current state.

267 The Profile is the selection of the Functions, Categories, and Subcategories that are aligned with
268 the business requirements, risk tolerance, and resources of the organization. The Target Profile
269 should support business/mission requirements and aid in the communication of risk within and
270 between organizations. Identifying the gaps between the Current Profile and the Target Profile
271 allows the creation of a roadmap that organizations should implement to reduce cybersecurity
272 risk.

273 The Framework provides a mechanism for organizations, sectors, and other entities to create
274 their own Target Profiles. It does not provide Target Profile templates, nor does it identify Tier

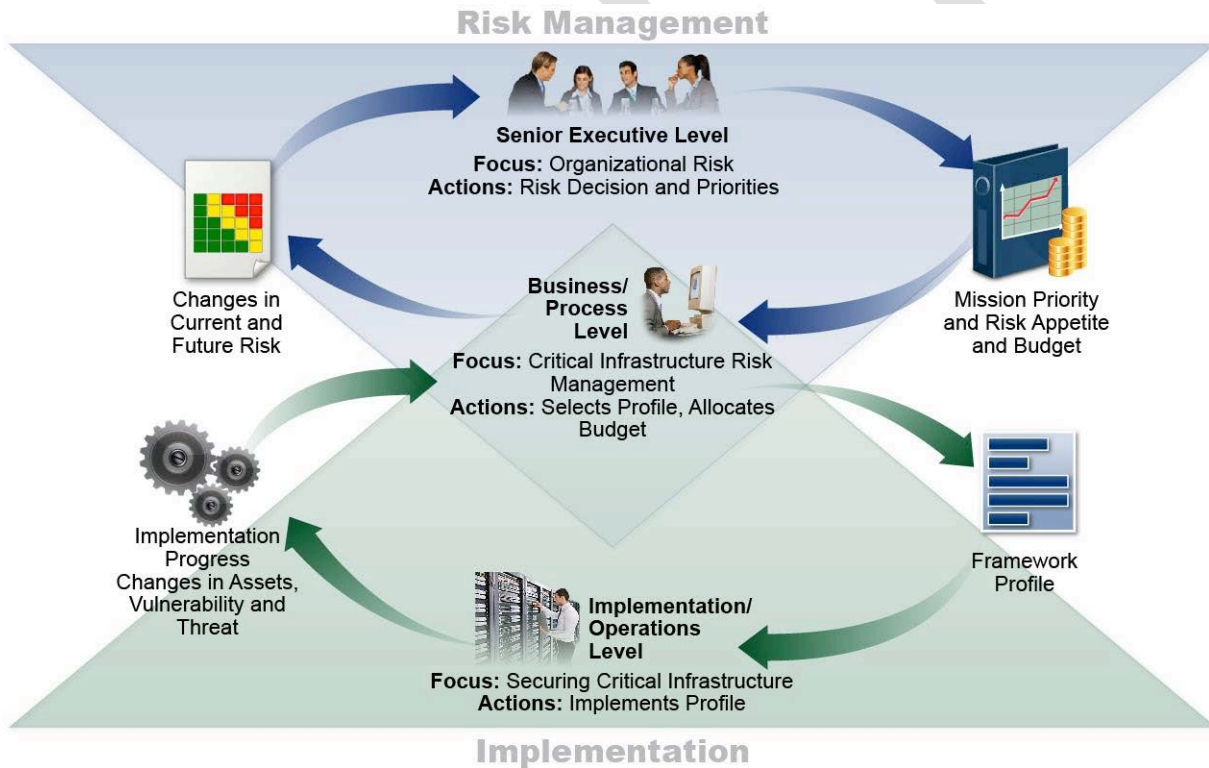
275 requirements that an organization should meet. In the future, organizations should identify
276 existing Target Profiles that could be customized for their purposes and needs.

277 **2.4 Putting It Together**

278 **Figure 4** describes the notional flow of information and decisions within an organization: at the
279 senior executive level, at the business/process level, and at the implementation/operations level.
280 This figure depicts the overall Framework usage and where Profiles fit in.

281 Starting at the top of the figure and proceeding clockwise, the senior executive level
282 communicates the mission priorities, available resources, and overall risk tolerance to the
283 business/process level. The business/process level uses the information as inputs into their risk
284 management process, and then collaborates with the implementation/operations level to create a
285 Profile. Implementation of the Profile is communicated by the implementation/operations level
286 to the business/process level, where an impact assessment is made. The outcomes of that impact
287 assessment are reported to the senior executive level to inform the organization’s overall risk
288 management process.

292 **3.0 How to Use the Framework**

293 The Framework structure is designed to support existing aspects of business operations, and can
294 be used as the basis for creating a new cybersecurity program for an organization that does not
295 already have one. The following examples provide several options for using the Framework.

296 **3.1 Establishing or Improving a Cybersecurity Program**

297 An organization should use the Framework as the basis for establishing a new cybersecurity
298 program or improving an existing cybersecurity program. First, the organization uses its risk
299 management process to create a Target Profile that reflects the desired Tiers for each selected
300 Category, and then assesses its cybersecurity posture as a Current Profile. The organization uses
301 the Target Profile to assess progress, making adjustments to it as needed to reflect ongoing
302 changes in risk. Used in this way, the Profiles are a helpful organizational tool for improving
303 cybersecurity within an organization.

304 The following is an example illustrating how an organization may use the Framework to create
305 or improve a cybersecurity program. Organizations should communicate effectively with
306 pertinent organizational levels when meaningful information becomes available.

307 **Step 1: Make Organization Wide Decisions.** The senior executive level clearly communicates
308 high-level understanding of business/mission drivers, regulatory requirements, and overall risk
309 posture to those developing the organization's Framework Profile, to ensure the appropriate
310 selection of Categories and Tiers. They provide business objectives and risk tolerance guidance
311 to the business/process level to inform effective decision making that supports the organization's
312 priorities.

313 **Step 2: Establish a Target Profile.** With an understanding of the priorities and constraints
314 within their organization, the business/process level creates a Target Profile that considers both
315 internal and external factors. When selecting the Profile for their areas of responsibility, the
316 business/process level considers the level of cybersecurity needed to achieve the objectives
317 determined in Step 1. Risk and priority information, provided by the senior executive level,
318 allows the business/process level to invest resources in a manner that increases cybersecurity and
319 supports the broader strategic direction.

320 **Step 3: Establish a Current Profile.** The business/process level assesses the current
321 cybersecurity state of the organization by establishing a Current Profile, based on the Categories
322 included in the Target Profile.

323 **Step 4: Compare Target and Current Profiles.** Once the Target and Current Profiles have
324 been established, the business/process level compares the Target Profile to the Current Profile.
325 The differences between the Tiers of the Profiles indicate areas for improvement or areas of
326 where resources could be reallocated to address other parts of the Profile. The utilization of
327 Current Profiles and Target Profiles help the business/process level to make informed decisions
328 about cybersecurity activities and streamline improvement.

329 **Step 5: Implement Target Profile.** The implementation/operations level is responsible for the
330 implementation and ongoing monitoring of the cybersecurity activities identified as outcomes of
331 Step 4. For further guidance, the Framework identifies Informative References regarding the
332 practices described in the Categories and Subcategories.

333 **3.2 Communicating Cybersecurity Requirements with Stakeholders**

334 The Framework provides a common language to communicate requirements among
335 interdependent partners responsible for the delivery of critical infrastructure. Examples include:

- 336 • An organization may utilize a Target Profile to express requirements to an external
337 service provider (e.g., a cloud provider) to which it is exporting data.

- 338 • An organization may express its cybersecurity state through a Current Profile to report
339 results or for comparison with acquisition requirements.
- 340 • A critical infrastructure owner/operator, having identified an external partner on whom
341 that infrastructure depends, may use a Target Profile to convey Categories, Subcategories
342 and Tiers that will ensure the appropriate level of resilience.
- 343 • A critical infrastructure sector may establish a baseline Target Profile.

344 **3.3 Identifying Gaps**

345 The Framework can be used to identify gaps where additional Informative References would
346 help organizations implement technologies or better address emerging threats. An organization
347 implementing a given Subcategory might discover that there are few Informative References, if
348 any, for a related activity. To address that need, the organization might collaborate with
349 technology leaders and/or standards bodies to draft, develop, and coordinate standards, guidance,
350 and practices to address the needs of potential adopters.

351 **4.0 Areas for Improvement for the Cybersecurity Framework**

352 Executive Order 13636 states that the Cybersecurity Framework will “identify areas for
353 improvement that should be addressed through future collaboration with particular sectors and
354 standards-developing organizations.” Based on stakeholder input, several high-priority Areas for
355 Improvement have been identified. Collaboration and cooperation must increase for these areas
356 to further understanding and/or the development of new or revised standards. The initial Areas
357 for Improvement are as follows:

- 358 • Authentication
- 359 • Automated Indicator Sharing
- 360 • Conformity Assessment
- 361 • Data Analytics
- 362 • International Aspects, Impacts, and Alignment
- 363 • Privacy
- 364 • Supply Chains and Interdependencies

365 This is not intended to be an exhaustive list, but these are highlighted as important areas that
366 should be addressed in future versions of the Framework.

367 These Areas for Improvement require continued focus; they are important but evolving areas that
368 have yet to be developed or require further research and understanding. While tools,
369 methodologies, and standards exist for some of the areas, they need to become more mature,
370 available, and widely adopted. To address the Areas for Improvement the community must
371 identify primary challenges, solicit input from stakeholders to address those identified
372 challenges, and collaboratively develop and execute action plans for addressing the challenges.

373 **4.1 Authentication**

374 Authentication challenges continue to exist across the critical infrastructure. As a result,
375 inadequate authentication solutions are a commonly exploited vector of attack by adversaries.
376 Multi-Factor Authentication (MFA) can assist in closing these attack vectors by requiring
377 individuals to augment passwords (“something you know”) with “something you have,” such as
378 a token, or “something you are,” such as a biometric.

379 While new solutions continue to emerge, there is only a partial framework of standards to
380 promote security and interoperability. In addition, usability has remained a significant challenge
381 for many control systems, as many of the solutions that are available today in the marketplace
382 are for standard computing platforms. Moreover, many solutions are geared only toward
383 identification of individuals; there are fewer standards-based approaches for automated device
384 authentication.

385 The inadequacy of passwords to fulfill authentication needs was a key driver behind the 2011
386 issuance of the National Strategy for Trusted Identities in Cyberspace (NSTIC), which calls upon
387 the private sector to collaborate on development of an Identity Ecosystem that raises the level of
388 trust associated with the identities of individuals, organizations, networks, services, and devices
389 online. While NSTIC is heavily focused on consumer use cases, the standards and policies that
390 emerge from the privately-led Identity Ecosystem Steering Group (IDESG) established to

391 support the NSTIC can inform advances in authentication for critical infrastructure going
392 forward.

393 **4.2 Automated Indicator Sharing**

394 The automated sharing of indicator information is an important tool to provide organizations
395 with timely, actionable information that they can use to detect and respond to cybersecurity
396 events as they are occurring. Current sharing communities use a combination of standard and
397 proprietary mechanisms to exchange indicators. These mechanisms have differing strengths and
398 weaknesses. Standard approaches must be developed that incorporate successful practices to
399 enable sharing within and among sectors. This shared subset of indicators needs to allow for
400 extraction of indicator data as part of the analysis of cybersecurity incidents, sharing of data that
401 does not expose the organization to further risks, and automated action by receiving
402 organizations. When indicators are received by an organization, security automation technologies
403 should be able to detect historic attacks, identify compromised systems, and support the
404 detection of future attacks.

405 **4.3 Conformity Assessment**

406 Industry has a long history of developing conformity assessment programs to meet society's
407 needs. An organization can use conformity assessment activities to assess the implementation of
408 requirements related to managing cybersecurity risk. The output of conformity assessment
409 activities can enhance an organization's understanding of its implementation of a Framework
410 profile. The decisions on the type, independence, and technical rigor of conformity assessment
411 should be risk-based. The need for confidence in conformity assessment activities must be
412 balanced with cost to the private and public sectors, including direct program costs, time-to-
413 market delays, diverse global requirements, additional legal obligations, and the cost of non-
414 conformity in the market. Successful conformity assessment provides the needed level of
415 confidence, is efficient, and has a sustainable and scalable business case. Critical infrastructure's
416 evolving implementation of Framework profiles should drive the identification of private sector
417 conformity assessment activities that address the confidence and information needs of
418 stakeholders.

419 **4.4 Data Analytics**

420 Big data and the associated analytic tools coupled with the emergence of cloud, mobile, and
421 social computing offer opportunities to process and analyze structured and unstructured
422 cybersecurity-relevant data on an unprecedented scale and specificity. Issues such as situational
423 awareness of complex networks and large-scale infrastructures can be addressed. Additionally,
424 the analysis of complex behaviors in these large scale-systems can also address issues of
425 provenance, attribution, and discernment of attack patterns in a forward-looking basis.

426 For the extraordinary potential of analytics to be realized, several challenges must be
427 overcome—for example, the lack of taxonomies of big data; mathematical and measurement
428 foundations; analytic tools; measurement of integrity of tools; and correlation and causation.
429 Additionally, there are privacy implications in the use of these analytic tools, such as data
430 aggregation and PII that must be addressed for legal and public confidence reasons.

431 **4.5 International Aspects, Impacts, and Alignment**

432 Globalization and advances in technology have benefited governments, economies, and society
433 as a whole, spawning unparalleled increases in innovation, competitiveness, and economic
434 growth. However, the functioning of the critical infrastructure has become dependent on these
435 enabling technologies, spurring governments around the globe to view cybersecurity increasingly
436 as a national priority. Many governments are proposing and enacting strategies, policies, laws,
437 and regulations covering a wide range of issues and placing varying degrees of requirements on
438 organizations. As many organizations, and most sectors, operate globally or rely on the
439 interconnectedness of the global digital infrastructure, many of the requirements are affecting, or
440 may affect, how organizations operate and conduct business. Diverse and unique requirements
441 can impede interoperability, produce duplication, harm cybersecurity, and hinder innovation,
442 significantly reducing the availability and use of innovative technologies to critical
443 infrastructures in all industries. This ultimately hampers the ability of critical infrastructure
444 organizations to operate globally and effectively manage new and evolving risk. The Framework
445 has been designed to allow for the use of international standards that can scale internationally.

446 **4.6 Privacy**

447 The Fair Information Practice Principles (FIPPs) are a longstanding framework for evaluating
448 and mitigating privacy impacts around the collection, use, disclosure, and retention of personally
449 identifiable information (PII). They are the basis for a number of laws and regulations, as well as
450 various sets of privacy principles and frameworks. Although the FIPPs provide a process for how
451 PII should be treated, they do not provide standardized guidance on implementation methods or
452 best practices. This lack of standardization makes it difficult to assess the effectiveness of
453 organizational implementation methods. Furthermore, organizational policies are often designed
454 to address business risks that arise out of privacy violations, such as reputation or liability risks,
455 rather than focusing on minimizing the risk of harm to individuals. Although research is being
456 conducted in the public and private sectors to improve current privacy practices, many gaps
457 remain. There are few identifiable standards or best practices to mitigate the impact of
458 cybersecurity activities on individuals' privacy and civil liberties.

459 **4.7 Supply Chains and Interdependencies**

460 Although many organizations have robust internal risk management processes, there remain
461 challenges related to collaboration, information sharing, and trust mechanisms throughout the
462 supply chain. As a result, the weakest links are susceptible to penetration and disruption,
463 affecting the overall supply chain. Supply chain risk management, particularly in terms of
464 product and service integrity, is an emerging discipline characterized by diverse perspectives,
465 disparate bodies of knowledge, and fragmented standards and best practices.

466 Similar to global supply chains, all critical infrastructures have sector and subsector
467 interdependencies. Disruptions in one sector may have a cascading and adverse impact on the
468 operations of another. Impacts on one sector can also provide advanced warning of potential
469 risks to another. While some dependencies are readily apparent, others are not and many
470 organizations continue to struggle to identify their risks and prioritize their actions due to these
471 operational interdependencies.

473 **Appendix A: Framework Core**

474 This appendix presents the Framework Core: a listing of Functions, Categories, Subcategories, and Informative References that
 475 describe specific cybersecurity activities that are common across all critical infrastructure sectors. The Framework Core presented in
 476 this appendix is not exhaustive; it is extensible, allowing organizations, sectors, and other entities to add Categories, Subcategories,
 477 and Informative References that are relevant to them and enable them to more effectively manage their cybersecurity risk. Activities
 478 can be selected from the Framework Core during the Profile creation process and additional Categories, Subcategories, and
 479 Informative References may be added to the Profile. An organization’s risk management processes, legal/regulatory requirements,
 480 business/mission objectives, and organizational constraints guide the selection of these activities during Profile creation.

501 **Appendix B: Methodology to Protect Privacy and Civil Liberties**

502 This appendix presents a methodology to address privacy and civil liberties considerations
 503 around the deployment of cybersecurity activities. It is organized by Function and Category to
 504 correspond with the Framework Core. Every Category may not be represented as not all
 505 Categories give rise to privacy and civil liberties risks.

Organizations should assess whether or under which circumstances such policies and procedures: i) provide notice to and enable consent by affected individuals regarding collection, use, dissemination, and maintenance of PII, as well as mechanisms for appropriate access, correction, and redress regarding use of PII; ii) articulate the purpose or purposes for which the PII is intended to be used; iii) provide that collection of PII be directly relevant and necessary to accomplish the specified purpose(s) and that PII is only retained for as long as is necessary to fulfill the specified purpose(s); iv) provide that use of PII be solely for the specified purpose(s) and that sharing of PII should be for a purpose compatible with the purpose for which the PII was collected; and v) to the extent practicable, ensure that PII is accurate, relevant, timely, and complete.

508 **Appendix C: Framework Development Methodology**

509 This Framework was developed in response to Executive Order 13636: *Improving Critical*
510 *Infrastructure Cybersecurity*.⁸

511 Initially, NIST issued a Request for Information (RFI) in February 2013 to gather relevant input
512 from industry and other stakeholders, and asking stakeholders to participate in the Cybersecurity
513 Framework development process.⁹ The process was designed to identify existing cybersecurity
514 standards, guidelines, frameworks, and best practices that are applicable to increase the security
515 of critical infrastructure sectors and other interested entities. NIST shared publicly the 245
516 responses to the RFI.¹⁰ NIST conducted analysis of these comments, and shared initial findings
517 on May 15, 2013.¹¹

518 On April 3, 2013 NIST hosted an initial workshop to identify existing resources and gaps, and
519 prioritize issues to be addressed as part of the framework.¹²

520 At a second workshop hosted by Carnegie Mellon University, NIST worked with stakeholders to
521 discuss the foundations of the Framework and the initial analysis.¹³ The feedback from the
522 second workshop led to the development of the draft outline of the preliminary Framework
523 presented on July 1, 2013.¹⁴

524 At a third workshop in July¹⁵ the draft outline was presented for validation and stakeholders
525 contributed input to the Framework Core, which was also shared publicly on July 1st.¹⁶

526 Through the processes, with NIST as a convener and coordinator, the following goals were
527 developed for the Framework:

- 528 • Be an adaptable, flexible, and scalable tool for voluntary use;
- 529 • Assist in assessing, measuring, evaluating, and improving an organization's readiness to
530 deal with cybersecurity risk;
- 531 • Be actionable across an organization;
- 532 • Be prioritized, flexible, repeatable, performance-based, and cost-effective;
- 533 • Rely on standards, methodologies, and processes which align with policy, business, and
534 technological approaches to cybersecurity;
- 535 • Complement rather than conflict with current regulatory authorities;
- 536 • Promote, rather than constrain, technological innovation in this dynamic arena;
- 537 • Focus on outcomes;
- 538 • Raise awareness and appreciation for the challenges of cybersecurity but also the means
539 for understanding and managing the related risks;

547 **Appendix D: Glossary**

548
549 This appendix defines selected terms used in the publication.

550 **Category:** The subdivision of a Function into groups of cybersecurity activities, more closely
551 tied to programmatic needs. Examples of Categories include “Asset Management,” “Access
552 Control,” and “Detection Processes.”

553 **Critical Infrastructure:** Systems and assets, whether physical or virtual, so vital to the United
554 States that the incapacity or destruction of such systems and assets would have a debilitating
555 impact on cybersecurity, national economic security, national public health or safety, or any
556 combination of those matters.

557 **Cybersecurity Event:** A cybersecurity change that may impact organizational operations
558 (including mission, capabilities, or reputation).

559 **Detect (function):** Develop and implement the appropriate activities to identify the occurrence
560 of a cybersecurity event.

561 **Framework:** A voluntary structure to reduce cybersecurity risk that relies on private sector input
562 and existing standards, guidelines, and practices. Also known as the “Cybersecurity
563 Framework.”

564 **Framework Core:** A compilation of cybersecurity activities and references. The Framework
565 Core comprises four types of elements: Functions, Categories, Subcategories, and Informative
566 References.

567 **Framework Implementation Tier:** The degree of progress achieved toward implementation of
568 predictive cybersecurity risk management principles for each Profile-selected Function,
569 Category, and Subcategory.

570 **Framework Profile:** A logical construct that defines which Framework Categories are relevant
571 for a particular organization, sector, or other entity. A Profile also defines the expected
572 Framework Implementation Tier for each Subcategory.

573 **Function:** One of the main components of the Framework. Functions provide the highest level
574 of structure, for organizing cybersecurity activities into Categories and Subcategories. The five
575 functions are: Identify, Protect, Detect, Respond, and Recover.

576 **Identify (function):** Develop the institutional understanding of which organizational systems,
577 assets, data, and capabilities need to be protected, determine priority in light of organizational
578 mission, and establish processes to achieve risk management goals.

579 **Informative Reference:** A specific section of existing standards and practices that are common
580 among all critical infrastructure sectors and illustrate a method to accomplish the activities
581 within each Subcategory. An example of an Informative Reference is ISO/IEC 27001 Control
582 A.10 - Cryptographic technology, which supports the *Protect Data in Transit* Subcategory of the
583 *Data Security* Category in the *Protect* function.

584 **Protect (function):** Develop and implement the appropriate safeguards, prioritized through the
585 organization’s risk management process, to ensure delivery of critical infrastructure services.

586 **Recover (function):** Develop and implement the appropriate activities, prioritized through the
587 organization’s risk management process, to restore the appropriate capabilities that were
588 impaired through a cybersecurity event.

589 **Respond (function):** Develop and implement the appropriate activities, prioritized through the
590 organization’s risk management process (including effective planning), to take action regarding a
591 detected cybersecurity event.

592 **Risk:** The level of impact on organizational operations (including mission, functions, image, or
593 reputation), organizational assets, individuals, other organizations, or the Nation resulting from
594 the operation of an information system given the potential impact of a threat and the likelihood
595 of that threat occurring.

596 **Risk Management:** The process of managing risks to organizational operations (including
597 mission, functions, image, or reputation), organizational assets, individuals, other organizations,
598 or the Nation resulting from the operation or use of an information system, and includes: (1) the
599 conduct of a risk assessment; (2) the implementation of a risk mitigation strategy; (3)
600 employment of techniques and procedures for the continuous monitoring of the security state of
601 the information system; and (4) documenting the overall risk management program.

602 **Subcategory:** The subdivision of a Category into more detailed cybersecurity activities to allow
603 technical implementation. Examples of subcategories include “Inventory and track physical
604 devices and systems within the organization,” “Protect network integrity by segregating
605 networks/implementing enclaves (where appropriate),” and “Assess the impact of detected
606 cybersecurity events to inform response & recovery activity.”
