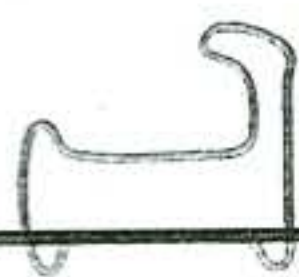

TO VOTE FOR INDIVIDUAL CANDIDATES:

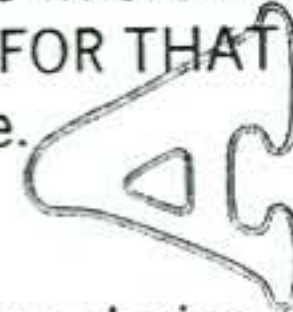
Turn to Pages 3 through 12 and vote for each candidate of your choice.

Turn to Page 14 through 15 to vote on Board of Education Levies.



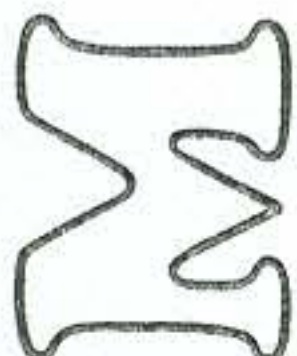
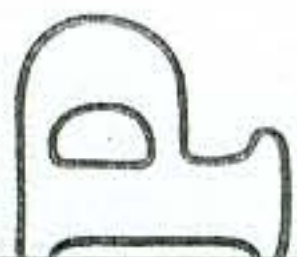
