ELECTION NIGHT REPORTING

2010 FILE SPECIFICATIONS

PURPOSE

To establish mandatory election results file specification that are effective for the 2010 elections. To make election night reporting more efficient and uniform by creating standards followed by all counties and voting system vendors. To create file specifications that contain common codes identifying who the results are from, each contest and ballot item, as well as information regarding the reporting status and a summary of each contest. To create a standard yet versatile file that can be used to meet numerous reporting requirements and report election results on a variety of levels, including state totals, county totals, and precinct level results. The description fields can also be written in a variety of languages.

TERMS & DEFINITIONS

Pertaining to a Specific Contest

- <u>Votes Cast</u>: The summation of votes cast for ballot items that are not write-ins where the sum of votes cast plus write-ins is less than or equal to the number to vote for in a specific contest.
- <u>Write-In Votes</u>: The summation of write-in votes where the sum of write-ins plus votes cast is less than or equal to the number to vote for in a specific contest.
- <u>Total Votes</u>: The sum of votes cast plus write-in votes as defined above.
- <u>Over Votes</u>: When the sum of votes cast plus write-ins is greater than the number to vote for in a specific contest, it is counted as one over vote for the contest.
- <u>Under Votes</u>: If total votes is less than or equal to the number to vote for, then subtract the total votes from the number to vote for. If the system counts blank votes (as defined below) then under votes are recorded only when there is a vote for more than one contest and at least one vote is cast but less than the required number to vote for.
- <u>Blank Votes (optional)</u>: If there is no vote selection at all for a contest, then it is counted as one blank vote.

Pertaining to the Overall Election

• <u>Election Turnout</u> will be calculated by counting page one of the ballot or by adding a shadow race that appears on the first page of every ballot style

RULES

- <u>Codes</u>: Many of the fields require the use of defined codes. All of the codes referred to in the specifications are located on the Division's web site (<u>http://soe.dos.state.fl.us/</u>) under the <u>Contest Codes</u> link. On the Contest Code page is a <u>Miscellaneous Codes</u> link to which has all of the codes listed.
 - <u>Contest Codes:</u> The contest code is a six digit number that contains district/circuit/group information for the contest. The Division has defined all of the state level contests and many of the county level contests, as derived from the Notice of General Election. On the Contest Code page is a link to <u>How to Define Local Contest Codes</u>.
 - <u>Candidate Numbers</u>: The candidate number starts at 10 and increments at 10 following ballot order, see '*Election/Contest Identifiers (Field 5)*' under the <u>Miscellaneous Codes</u> link.
 - <u>Contest Information</u>: The contest identifiers that are less than 10 and greater than 999 indicate specific information regarding the contest, such as contest description, precincts reporting, over votes, under votes and total votes cast. Since statutory reporting requirements for extraneous election information can change, it is ideal for the user to be able to select which items to include in the report. (See '*Election/Contest Identifiers (Field 5)*' under the <u>Miscellaneous Codes</u> link)

RULES (CONTINUED)

- <u>Universal Primary Contests</u> (UPC) if defined as multiple contests, the results will be reported together as a summation of votes for one contest using the appropriate contest code.
- <u>Presidential Preference Primary</u> will be reported as a county total on election night. Congressional District breakdowns will be reported on the county canvass certificate.

FILE CONVENTIONS

- <u>Filename</u>: The file naming convention for a file written in English is as follows: "ElecResults"ResultFileType_CountyAbbr_DatetimeStamp.txt using local military time in the date stamp (i.e. Alachua's file is ElecResults10_ALA_20080129191504.txt or ElecResults20_ALA_20080129191504.txt). If not English then add "_LanguageCode" after the date stamp: ElecResults20_ALA_20080129191504_SPA.txt
- <u>**Transfer Method:**</u> File can be transferred to the Division by FTP or uploaded via the web.
- **File Format:** The fields will be tab delimited with a carriage return, line feed at the end of each record. Character fields will <u>not</u> have quotes around them.

FILE RESULT TYPES

The specifications cover two different types of election results that must be produced per statute.

- <u>Election Night Summary Results</u>: This results file contains the summary election results that the counties must submit to the Division of Election on election night per Florida Statute 102.141(4).
- **Post Election Precinct Results:** This results file contains the precinct election results that the counties must submit to the Division of Election within 45 days of the election per Florida Statute 98.0981.

FILE LAYOUT

- <u>**Record Types:**</u> The results file is made up of various types of records.
 - o Identification Record (IDR) who created the file
 - Election Identification Record (EIR) what election is it
 - Election Results Type Record (ERR) what type of election results is being reported
 - \circ Election Turnout Record (ETR) overall turnout for the election
 - Election Precinct Reporting Record (EPR) overall precinct information
 - Election Reporting Status Record (ERS) overall reporting status for absentee and early voting
 - o Contest Information Record (CIR) what contest is it
 - Contest Precinct Reporting Record (CPR) contest precinct reporting information
 - o Contest Results Record (CRR) the various contest ballot items (candidate name, yes, no)
 - **Contest Other Votes Record (COR)** votes that cannot be applied to a contest ballot item such as over votes, under votes and blank votes
 - Contest Total Votes Cast Record (CTV) contest total votes cast
 - Precinct Information Record (PIR) what precinct is it
- **<u>Record Fields</u>**: All records have eight fields. For the Election Night Summary Results, the combination of field one and field five make each record unique. For the Post Election Precinct Results, the combination of field one, four and five make each record unique. Many of the fields contain defined codes that must be used. The specific data in each field is dependent on the record type.
 - Field 1 is a 6 digit numeric field but leading zeroes are required; it contains the election information code or the contest code
 - \circ Field 2 always contains the county code
 - Field 3 the language code, election type code, election results code, or precinct label
 - Field 4 election date, reporting level/precinct id or indicate if contest has write-ins
 - Field 5 county id number, results file type code, or election/contest identifier
 - **Field 6** turnout, number precincts reporting, memory devices reporting, number to vote for, precinct ID, or votes
 - Field 7 voter registration, total number of precincts, total number of memory devices, total number of choices or total votes
 - Field 8 always contains the "description" for the record
